
A BILL FOR AN ACT

RELATED TO RECYCLING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to amend the
2 definition of "electronic device" to clarify the scope of
3 covered devices under the Electronic Device Recycling and
4 Recovery Act.

5 SECTION 2. Section 339D-1, Hawaii Revised Statutes, is
6 amended by amending the definition of "electronic device" to
7 read as follows:

8 ""Electronic device":

9 (1) Means:

10 (A) A computer, computer printer, computer monitor,
11 or portable computer with a screen size greater
12 than four inches measured diagonally; and

13 (B) Any device that is capable of receiving
14 broadcast, cable, or satellite signals and
15 displaying television or video programing,
16 including any direct view or projection

17 television with a viewable screen of nine inches



1 or larger with display technology based on
2 cathode ray tube, plasma, liquid crystal, digital
3 light processing, liquid crystal on silicon,
4 silicon crystal reflective display, light
5 emitting diode, or similar technology; and

6 (2) Shall not include:

7 (A) An electronic device that is a part of a motor
8 vehicle or any component part of a motor vehicle
9 assembled by or for a motor vehicle manufacturer
10 or franchised dealer, including replacement parts
11 for use in a motor vehicle;

12 (B) An electronic device that is functionally or
13 physically required as a part of a larger piece
14 of equipment designed and intended for use in an
15 industrial, commercial, or medical setting,
16 including diagnostic, monitoring, or control
17 equipment;

18 (C) An electronic device that is contained within a
19 clothes washer, clothes dryer, refrigerator,
20 refrigerator and freezer, microwave oven,



- 1 conventional oven or range, dishwasher, room air
- 2 conditioner, dehumidifier, or air purifier;
- 3 (D) A telephone of any type including a mobile
- 4 telephone; [~~or~~]
- 5 (E) A global positioning system[~~+~~]; or
- 6 (F) Floor-standing printers or printers with optional
- 7 floor stands."

8 SECTION 3. Statutory material to be repealed is bracketed
9 and stricken. New statutory material is underscored.

10 SECTION 4. This Act shall take effect on July 1, 3000.
