# HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF AGRICULTURE TO ESTABLISH A  
SUSTAINABLE FOOD SYSTEMS WORKING GROUP.

1           WHEREAS, a sustainable food system is a food system in  
2 which producers, retailers, community members, non-governmental  
3 organizations, and government agencies partner to create a  
4 vibrant and resilient local food economy that enhances and  
5 sustains the environmental, economic, and social health of the  
6 community; and  
7

8           WHEREAS, the development of a more sustainable food system  
9 for Hawaii represents an opportunity to create a new food  
10 economy that integrates the objectives of "green" job creation,  
11 sustainable economic development, land stewardship, food  
12 security, environmental protection, and climate change  
13 resiliency with community health and well-being; and  
14

15           WHEREAS, the State needs a coordinated, comprehensive, and  
16 unified approach to building a sustainable food system; now,  
17 therefore,  
18

19           BE IT RESOLVED by the House of Representatives of the  
20 Thirty-second Legislature of the State of Hawaii, Regular  
21 Session of 2024, the Senate concurring, that the Department of  
22 Agriculture is requested to establish a Sustainable Food Systems  
23 Working Group; and

25           BE IT FURTHER RESOLVED that the Sustainable Food Systems  
26 Working Group is requested to consist of the following members;

- 28           (1) The Deputy to the Chairperson of the Board of  
29           Agriculture, who is also requested to serve as  
30           chairperson of the Sustainable Food Systems Working  
31           Group;

40 Food Systems Working Group are requested to serve without  
41 compensation but may be reimbursed for necessary expenses,



1 including travel expenses, incurred in carrying out their  
2 duties; and

4 BE IT FURTHER RESOLVED that the Sustainable Food Systems  
5 Working Group is requested to submit the interagency food  
6 systems plan and its recommendations for the implementation of  
7 the plan, including any proposed legislation, to the Legislature  
8 no later than twenty days prior to the convening of the Regular  
9 Session of 2025; and

11 BE IT FURTHER RESOLVED that the Department of Agriculture  
12 is requested to provide any necessary administrative and staff  
13 support to the Sustainable Food Systems Working Group, including  
14 the preparation of the interagency food systems plan; and

16 BE IT FURTHER RESOLVED that certified copies of this  
17 Concurrent Resolution be transmitted to the Chairperson of the  
18 Board of Agriculture; Director of Health; Director of Business,  
19 Economic Development, and Tourism; Acting Director of the Office  
20 of Planning and Sustainable Development; Coordinator of the  
21 Hawaii Climate Change Mitigation and Adaptation Commission;  
22 Interim Dean and Director of the College of Tropical Agriculture  
23 and Human Resources of the University of Hawaii at Manoa; Chair  
24 of the Department of Urban and Regional Planning of the  
25 University of Hawaii at Manoa; Executive Director of the Hawaii  
26 Appleseed Center for Law & Economic Justice; President and Chief  
27 Executive Officer of the Hawaii Foodbank; Program Manager of the  
28 Farm to School Hui; Chief Executive Officer of Hawaii
