HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF HUMAN SERVICES TO ESTABLISH A WORKING GROUP TO ADDRESS ISSUES RELATING TO REIMBURSEMENTS AND PAYMENTS TO HOME- AND COMMUNITY-BASED SERVICES PROVIDERS.

WHEREAS, home- and community-based services providers carry 1 out essential and necessary services to the State's elderly and 2 vulnerable populations; and 3 4 5 WHEREAS, a 2022 study conducted by the actuarial firm Milliman of reimbursement rates for home- and community-based 6 services found that, for all provider types, current median 7 direct care wages paid by the service providers fell below the 8 United States Bureau of Labor Statistics twenty-fifth percentile 9 for those occupations; and 10 11 WHEREAS, adequate reimbursements and payments are crucial 12 to sustain and improve the quality of care provided by home- and 13 community-based residential care home facilities; and 14 15 WHEREAS, there is a pressing need to identify and implement 16 17 measures to enhance reimbursement rates for all home- and community-based services providers; now, therefore, 18 19 20 BE IT RESOLVED by the House of Representatives of the Thirty-second Legislature of the State of Hawaii, Regular 21 Session of 2024, the Senate concurring, that the Department of 22 23 Human Services is requested to establish a working group to address issues relating to reimbursements and payments to home-24 and community-based services providers; and 25 26 27 BE IT FURTHER RESOLVED that the working group is requested to consist of the following members: 28 29
