1 BE IT RESOLVED by the House of Representatives of the

17 Committee; Higher Education & Technology Committee; and Water &

20 BE IT FURTHER RESOLVED that LUKE A. EVSLIN shall no longer
21 be a member of the Education Committee and Higher Education &
22 Technology Committee, but shall be added as the Chair of the
23 Housing Committee and a member of the Judiciary & Hawaiian
24 Affairs Committee, and shall remain as a member of the
25 Transportation Committee; and

27 BE IT FURTHER RESOLVED that TRISH LA CHICA shall be added
28 as the Vice Chair of the Education Committee and shall remain as
29 a member of the Economic Development Committee, Higher Education
30 & Technology Committee, and Tourism Committee; and
