# HOUSE RESOLUTION

REQUESTING THE HAWAII OFFICE OF VETERANS' SERVICES TO PRIORITIZE  
POLICIES AND SERVICES EXPANDING FINANCIAL AND OTHER FORMS  
OF BENEFITS FOR HAWAII NATIONAL GUARD VETERANS, RETIREES,  
AND VETERAN-OWNED SMALL BUSINESSES.

1           WHEREAS, the Hawaii National Guard, which consists of the  
2 Hawaii Army National Guard and Hawaii Air National Guard,  
3 provides fully-manned, operationally-ready, and well-equipped  
4 units in support of federal and state missions; and  
5

6           WHEREAS, the Hawaii National Guard serves as an integral  
7 component of the Total Force by maintaining units that can  
8 promptly respond to any national contingency ranging from war  
9 and peacekeeping missions to nation-building operations; and  
10

11           WHEREAS, soldiers and airmen of the Hawaii National Guard  
12 support the local communities in response to natural disasters,  
13 human-caused crises, and the unique needs of the State; and  
14

15           WHEREAS, throughout the decades of service, the Hawaii  
16 National Guard has been vital to the safety and protection of  
17 the people of Hawaii, from floods, hurricanes, and lava  
18 eruptions; and  
19

20           WHEREAS, the terrorist attacks of September 11, 2001,  
21 caused a massive mobilization and deployment of United States  
22 forces, sending more than one thousand Hawaii National Guard  
23 veterans and retirees to dangerous, volatile, and unstable areas  
24 of the world, such as Iraq and Afghanistan; and

26           WHEREAS, although Hawaii National Guard veterans and  
27 retirees recognized their duty and proudly served their nation,  
28 the call-up undeniably disrupted their personal and professional  
29 lives; and

1 WHEREAS, Hawaii National Guard veterans and retirees  
2 suffered a significant loss of income while still having to meet  
3 rents and mortgages, car payments, child care costs, tuition  
4 fees, and a host of other expenses; and  
5

6 WHEREAS, the Hawaii National Guard Enlisted Association  
7 advocates for changes to policy impacting enlisted men and women  
8 of the Hawaii National Guard, veterans, retirees, and their  
9 families; and  
10

11 WHEREAS, as a beneficiary of their courageous and dedicated  
12 service, the State bears a sacred responsibility to veterans,  
13 particularly Hawaii National Guard veterans and retirees who  
14 proudly and faithfully served the United States, the State of  
15 Hawaii, and communities; and  
16

17 WHEREAS, Hawaii National Guard veterans and retirees should  
18 be provided as much support as possible, and the impact on their  
19 lives should be minimized to the greatest extent feasible; and  
20

21 WHEREAS, one way the State can express its appreciation to  
22 Hawaii National Guard veterans and retirees is by providing them  
23 with enhanced benefits; now, therefore,

25 BE IT RESOLVED by the House of Representatives of the  
26 Thirty-second Legislature of the State of Hawaii, Regular  
27 Session of 2024, that the Hawaii Office of Veterans' Services is  
28 requested to prioritize policies and services expanding  
29 financial and other forms of benefits for Hawaii National Guard  
30 veterans, retirees, and veteran-owned small businesses; and

32 BE IT FURTHER RESOLVED that certified copies of this  
33 Resolution be transmitted to the Director of the Hawaii Office  
34 of Veterans' Services, members of the Advisory Board on  
35 Veterans' Services, and Adjutant General for the Hawaii  
36 Department of Defense.
