A BILL FOR AN ACT

RELATING TO BROADBAND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

PART I

2 SECTION 1. The legislature finds that equitable access to 3 high-speed broadband internet is a pressing challenge for the 4 State. The legislature further finds that there is a 5 significant amount of federal funds available to support state 6 broadband initiatives and that some of these programs require 7 matching funds from the State or other non-federal partners. 8 The legislature also finds that the composition of the working 9 group established pursuant to Act 231, Session Laws of Hawaii 10 2022, should be amended to facilitate its purpose in determining 11 the appropriate governance structure to implement, operate, and 12 maintain broadband infrastructure development in the State.

13 The purpose of this Act is to:

14 (1) Transfer the Hawaii broadband and digital equity
15 office from the department of business, economic
16 development, and tourism to the office of the
17 lieutenant governor on a temporary, four-year basis;

1	(2) Provide the matching funds required to receive federal

7	SECTION 2. Section 206S-1, Hawaii Revised Statutes, is								
8	amended by repealing the definition of "department".								
9	[" "Department" means the department of business, economic								
10	development, and tourism."]								
11	SECTION 3. Section 206S-2, Hawaii Revised Statutes, is								
12	amended by amending subsection (a) to read as follows:								
13	"(a) There is established the Hawaii broadband and digital								
14	equity office within the [department of business, economic								
15	development, and tourism.] office of the lieutenant governor."								
16	SECTION 4. Section 206S-4, Hawaii Revised Statutes, is								
17	amended by amending subsection (a) to read as follows:								
18	"(a) The office shall:								
19	(1) Seek input and the widest possible cooperation from								
20	public and private agencies and individuals to achieve								
21	the purposes of this chapter;

10	SECTION 5. All rights, powers, functions, and duties of								
11	the Hawaii broadband and digital equity office shall be								
12	maintained when the office is transferred from the department of								
13	business, economic development, and tourism to the office of the								
14	lieutenant governor.								
15	All officers and employees whose functions are transferred								
16	by this part shall be transferred with their functions and shall								
17	continue to perform their regular duties upon their transfer,								
18	subject to the state personnel laws and this part.								
19	No o	fficer or employee of the State having tenure shall							
20	suffer any	y loss of salary, seniority, prior service credit,							
21	vacation,	sick leave, or other employee benefit or privilege as

1 a consequence of this part, and such officer or employee may be 2 transferred or appointed to a civil service position without the 3 necessity of examination; provided that the officer or employee 4 possesses the minimum qualifications for the position to which 5 transferred or appointed; and provided that subsequent changes 6 in status may be made pursuant to applicable civil service and 7 compensation laws.

8 An officer or employee of the State who does not have 9 tenure and who may be transferred or appointed to a civil 10 service position as a consequence of this part shall become a 11 civil service employee without the loss of salary, seniority, 12 prior service credit, vacation, sick leave, or other employee 13 benefits or privileges and without the necessity of examination; 14 provided that such officer or employee possesses the minimum 15 qualifications for the position to which transferred or 16 appointed.

17 If an office or position held by an officer or employee
18 having tenure is abolished, the officer or employee shall not
19 thereby be separated from public employment, but shall remain in
20 the employment of the State with the same pay and classification
21 and shall be transferred to some other office or position for

which the officer or employee is eligible under the personnel
 laws of the State as determined by the head of the department or
 the governor.

SECTION 6. All rules, policies, procedures, guidelines, 4 5 and other material adopted or developed by the department of 6 business, economic development, and tourism to implement 7 provisions of the Hawaii Revised Statutes that are reenacted or 8 made applicable to the office of the lieutenant governor by this 9 part shall remain in full force and effect until amended or 10 repealed by the office of the lieutenant governor pursuant to 11 chapter 91, Hawaii Revised Statutes. In the interim, every 12 reference to the department of business, economic development, 13 and tourism or the director of business, economic development, 14 and tourism in those rules, policies, procedures, guidelines, 15 and other material is amended to refer to the office of the 16 lieutenant governor or the lieutenant governor, as appropriate. 17 SECTION 7. All deeds, leases, contracts, loans, 18 agreements, permits, or other documents executed or entered into 19 by or on behalf of the department of business, economic 20 development, and tourism pursuant to the provisions of the 21 Hawaii Revised Statutes, which are reenacted or made applicable

1 to the office of the lieutenant governor by this part, shall
2 remain in full force and effect. Upon the effective date of
3 this part, every reference to the department of business,
4 economic development, and tourism or the director of business,
5 economic development, and tourism therein shall be construed as
6 a reference to the office of the lieutenant governor or the
7 lieutenant governor, as appropriate.

8 SECTION 8. All appropriations, records, equipment, 9 machines, files, supplies, contracts, books, papers, documents, 10 maps, and other personal property heretofore made, used, acquired, or held by the department of business, economic 11 12 development, and tourism relating to the functions of the Hawaii 13 broadband and digital equity office shall be transferred to the 14 office of the lieutenant governor with the functions to which 15 they relate.

SECTION 9. There is appropriated out of the general
revenues of the State of Hawaii the sum of \$ or so
much thereof as may be necessary for fiscal year 2023-2024 to
provide required matching funds for the implementation of the
federal Broadband Equity, Access, and Deployment Program.

Appropriates from the funds received by the State of Hawaii from the Infrastructure Investment and Jobs Act for the Broadband Equity, Access, and Deployment Program. Requires the Office of the Lieutenant Governor to convene and lead the working group established pursuant to Act 231, SLH 2022. Effective 1/1/2050. (SD3)
