A BILL FOR AN ACT

RELATING TO GOVERNMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The purpose of this Act is to require public SECTION 1. 2 access to travel reports submitted by state employees, officers, 3 and other representatives of the State traveling on official 4 state business. 5 SECTION 2. Chapter 40, Hawaii Revised Statutes, is amended 6 by adding a new section to be appropriately designated and to 7 read as follows: 8 "§40- Travel reports; official state business; public 9 access. (a) Any travel report submitted by a state employee, 10 officer, or other representative of any state department or 11 agency, including the judiciary and university of Hawaii, in 12 connection with out-of-state or intra-state travel for purposes 13 of official state business, shall be made available for public 14 review on the comptroller's website; provided that any personally identifiable information shall be kept private and 15 redacted from the published report; provided further that out-16

only. The reasons for exceeding the general fund expenditure

- 3 (1) The appropriation made in this Act is necessary to
 4 serve the public interest; and
- 5 (2) The appropriation made in this Act meets the needs6 addressed by this Act.

7 SECTION 4. There is appropriated out of the general 8 revenues of the State of Hawaii the sum of \$ or so 9 much thereof as may be necessary for fiscal year 2024-2025 to 10 provide digital and searchable public access to the travel 11 reports of state employees, officers, and other representatives 12 of the State for travel related to official state business.

13 The sum appropriated shall be expended by the department of 14 accounting and general services for the purposes of this Act.

15 SECTION 5. New statutory material is underscored.

16 SECTION 6. This Act shall take effect on July 1, 2112;17 provided that section 4 shall take effect on July 1, 2024.

Report Title: Department of Accounting and General Services; Comptroller; Travel Reports; Public Access; Expenditure Ceiling; Appropriation

Description:

Requires any travel report submitted by a state employee, officer, or other representative of any state department or agency, including the Judiciary and University of Hawaii, in connection with out-of-state or intra-state travel for purposes of official state business, to be made available for public review on the Comptroller's website. Requires any personally identifiable information to be redacted from the published report. Limits the information to be disclosed for travel reports relating to law enforcement operations. Allows law enforcement agencies to delay the reporting of its travel report for law enforcement operation purposes. Declares that the general fund expenditure ceiling is exceeded. Makes an appropriation. Takes effect 7/1/2112. (SD1)
