A BILL FOR AN ACT

RELATING TO EMERGENCIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature has received complaints that
2 the residents living in the Pacific Palisades area are unable to
3 hear the emergency siren located at Pearl City high school, and
4 the emergency siren at Palisades elementary school has been
5 inoperative for several years. The legislature finds that a new
6 emergency siren is needed in the area so that residents can be
7 alerted to all civil defense emergencies in a timely manner in
8 order to take any necessary safety measures.

9 The purpose of this Act is to appropriate funds for the
10 installation of a new outdoor emergency siren in the Pacific
11 Palisades area.

12 SECTION 2. There is appropriated out of the general
13 revenues of the State of Hawaii the sum of \$200,000 or so much
14 thereof as may be necessary for fiscal year 2024-2025 for the
15 installation of a new outdoor emergency siren in the Pacific
16 Palisades area of Oahu in connection with the statewide outdoor
17 siren warning system.



1 The sum appropriated shall be expended by the department of
2 defense for the purposes of this Act.

3 SECTION 3. In accordance with section 9 of article VII of
4 the Hawaii State Constitution and sections 37-91 and 37-93,
5 Hawaii Revised Statutes, the legislature has determined that the
6 appropriations contained in H.B. No. , will cause the state
7 general fund expenditure ceiling for fiscal year 2024-2025 to be
8 exceeded by \$ or per cent. In addition, the
9 appropriation contained in this Act will cause the general fund
10 expenditure ceiling for fiscal year 2024-2025 to be further
11 exceeded by \$200,000 or per cent. The combined total
12 amount of general fund appropriations contained in only these
13 two Acts will cause the state general fund expenditure ceiling
14 for fiscal year 2024-2025 to be exceeded by
15 \$ or per cent. The reasons for exceeding the
16 general fund expenditure ceiling are that:

- 17 (1) The appropriation made in this Act is necessary to
18 serve the public interest; and
19 (2) The appropriation made in this Act meets the needs
20 addressed by this Act.

21 SECTION 4. This Act shall take effect on July 1, 2024.
