# A BILL FOR AN ACT

RELATING TO THE HAWAIIAN HOMES COMMISSION ACT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that there are
- 2 approximately twenty four thousand native Hawaiian beneficiaries
- 3 on the department of Hawaiian home lands waitlist.
- 4 legislature further finds that the department of Hawaiian home
- 5 lands does not possess sufficient land to house everyone on the
- 6 waitlist. The legislature also finds that the largest demand
- 7 for lots is on Oahu, but the department's land holdings on Oahu
- 8 are limited.
- 9 Therefore, the purpose of this Act is to shorten the
- 10 waitlist by allowing the department of Hawaiian home lands to
- 11 provide a beneficiary with a cash award to purchase a
- 12 residential lot outside of department of Hawaiian home lands
- 13 trust lands or to pay the beneficiary's existing mortgage note
- 14 or rent in lieu of awarding the beneficiary a lease.
- 15 The Hawaiian Homes Commission Act, 1920, as SECTION 2.
- 16 amended, is amended by adding a new section to be appropriately
- 17 designated and to read as follows:

1	"S Cash award to beneficiaries. The department
2	of Hawaiian home lands may expend funds to provide a cash award
3	of \$ to a beneficiary on the waitlist for the purchase
4	of a residential lot in fee simple located outside of the
5	department's trust lands, or to pay the beneficiary's existing
6	mortgage note or rent. The department shall remove from the
7	waitlist any beneficiary that accepts a cash award."
8	SECTION 3. The provisions of the amendments made by this
9	Act to the Hawaiian Homes Commission Act, 1920, as amended, are
10	declared to be severable, and if any section, sentence, clause,
11	or phrase, or the application thereof to any person or
12	circumstances is held ineffective because there is a requirement
13	of having the consent of the United States to take effect, then
14	that portion only shall take effect upon the granting of consent
15	by the United States and effectiveness of the remainder of these
16	amendments or the application thereof shall not be affected.
17	SECTION 4. New statutory material is underscored.
18	SECTION 5. This Act shall take effect upon its approval.

### Report Title:

HHCA; DHHL; Cash Award; Waitlist; Mortgage; Rent; Residential Lots

Amends the Hawaiian Homes Commission Act to authorize the Department of Hawaiian Home Lands to provide cash awards to beneficiaries on the waitlist in lieu of a lease. Requires the Department of Hawaiian Home Lands to remove those beneficiaries from the waitlist.
