SECTION 1. Section 291C-41, Hawaii Revised Statutes, is

 vehicle shall be driven upon the right half of the roadway,

 (3) Upon a roadway divided into three marked lanes for traffic under the rules applicable thereon; or
 (4) Upon a roadway designated and signposted one-way traffic.

5 Upon all roadways any vehicle proceeding at less than (b) 6 the normal speed of traffic at the time and place and under the 7 conditions then existing shall be driven in the right-hand lane 8 then available for traffic, or as close as practicable to the 9 right-hand curb or edge of the roadway, except when overtaking 10 and passing another vehicle proceeding in the same direction or 11 when preparing for a left turn at an intersection or into a 12 private road or driveway.

13 (c) Upon any roadway having four or more lanes for moving 14 traffic and providing for two-way movement of traffic, no 15 vehicle shall be driven to the left of the center line of the 16 roadway, except when authorized by official traffic-control 17 devices designating certain lanes to the left side of the center 18 of the roadway for use by traffic not otherwise permitted to use 19 [such] the lanes, or except as permitted under subsection 20 (a) (2).
