## A BILL FOR AN ACT

RELATING TO NUISANCE PREVENTION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The purpose of this Act is to clarify the legal
2	authority of the department of health to prevent nuisances that
3	threaten public health or environmental health, both of which
4	affect the health of a community and the people of Hawaii as a
5	whole. The department of health is charged with protecting both
6	public and environmental health. This recognizes that the
7	health of a community requires the prevention of both of
8	diseases as well as threats to the environment. With climate
9	change and the increasing pressures on resources and
10	communities, there needs to be clarity that the department of
11	health has the legal authority and obligation to act when there
12	are nuisances that threaten public or environmental health and
13	not just when there is a threat of disease or impacts to an
14	individual or party.
15	SECTION 2. Chapter 322, Hawaii Revised Statutes, is
16	amended by amending the title of part I to read as follows:
17	"PART I. [ABATEMENT] PREVENTION OF NUISANCES"

Ţ	SECTION 3. Section 322-1, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"§322-1 [Removal, prevention.] Prevention. The department
4	of health and its agents shall examine into all nuisances, such
5	as foul or noxious odors, gases or vapors, water in which
6	mosquito larvae exist, sources of filth, and all causes of
7	sickness or disease, on shore, and in any vessel, which may be
8	known to them or brought to their attention, which in their
9	opinion are dangerous or injurious to public or environmental
10	health, and into any and all conditions created or existing
11	[which] that cause or tend to cause sickness or disease or to be
12	dangerous or injurious to public or environmental health, and
13	shall cause the same to be [abated, destroyed, removed, or
14	prevented.] prevented, which may include abatement, destruction,
15	or removal of the nuisance.
16	For purposes of this part, a nuisance shall include:
17	(1) Toxic materials that are used in or by-products of the
18	manufacture or conversion of methamphetamine, and
19	clandestine drug labs that manufacture
20	methamphetamine; and
21	(2) Odors and filth resulting from a person feeding feral
22	birds."

A BILL FOR AN ACT RELATING TO NUISANCE

PREVENTION.

PURPOSE:

To clarify that the jurisdiction of the Department of Health (DOH) includes the prevention of nuisances that threaten both public health or environmental health.

MEANS:

Amend section 322-1, Hawaii Revised Statutes

(HRS).

JUSTIFICATION:

The current section that establishes DOH's scope over nuisances that threaten health is too broad.

The proposed amendment specifies oversight of nuisances that threaten public health or environmental health, which is in line with DOH's mission to protect public health, pursuant to section 321-1, HRS, and environmental health, pursuant to section 321-1.1, HRS. This clarification is important because newly emerging threats resulting from climate change such as wildfires, flooding, and vector-borne diseases have the potential to adversely impact human health.

Impact on the public: The proposed amendment recognizes the connection between environmental health and public health on the overall wellness of the community and mandates DOH remove or prevent nuisance threats thereto.

Impact on the department and other agencies: This bill will likely require greater coordination with environmental and human health stakeholders.
