A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that Hawaii residents
2	deserve universal access and equity to quality health care at an
3	affordable cost. The Hawaii Prepaid Healthcare Act of 1974, the
4	State Health Insurance Program Act of 1989, and the current
5	successful med-QUEST program administered by the department of
6	human services, are true examples of the State's remarkable
7	tradition of health system reform innovation. However, the
8	State presently falls short of access to health care insurance
9	with approximately eighty thousand uninsured and many more
10	underinsured residents.
11	The legislature also finds that with increasing health care
12	insurance costs; excessive regulatory, administrative, and
13	delivery system complexities; growing unaffordability for
14	families, businesses, and government; unacceptable variation in
15	outcomes despite numerous examples of high-quality care; and
16	growing stresses on recruiting and retaining sufficient health
17	care professionals, a renewed commitment towards guaranteeing

- 1 universal coverage, streamlined administrative costs, and health
 2 system modernization are necessary.
 3 Presently, the state health planning and development agency
- 4 administers the statewide health planning and cost containment
- 5 activities. While the state health planning and development
- 6 agency has an effective certificate of need program, it is not
- 7 sufficient to contain health care costs. Furthermore, existing
- 8 law requires health plans funded by the Hawaii employer-union
- 9 health benefits trust fund and the state medicaid agency to
- 10 provide administrative data, including health and dental
- 11 insurance data, to the state health planning and development
- 12 agency. This data, along with the acquisition of medicare data
- 13 sets specific to Hawaii, is necessary to facilitate greater
- 14 transparency and understanding of health care costs, health care
- 15 system quality, population health conditions, and health care
- 16 disparities.
- 17 Therefore, the purpose of this Act is to establish a task
- 18 force known as the hui ho'omana, which means "group to transform
- 19 and empower", to make recommendations to achieve universal
- 20 allies and equity to quality health care at an affordable cost
- 21 for state residents.

1 SECTION 2. (a) There is established the hui ho'omana within the state health planning and development agency for 2 administrative purposes only, to make recommendations to achieve 3 universal access and equity to quality health care at an 4 affordable cost for state residents. 5 6 The hui ho'omana shall consist of up to twenty-five voting members and ten nonvoting ex officio members. The voting 7 members shall include: 8 9 The administrator of the state health planning and (1)10 development agency or the administrator designee; 11 The director of health or the director's designee; (2) 12 The director of human services or the director's (3) 13 designee; 14 The insurance commissioner or the commissioner's (4)15 designee; 16 The chief executive officer of the Hawaii health (5) 17 systems corporation or the chief executive officer's 18 designee; 19 The administrator of the Hawaii employer-union health (6)

benefits trust fund or the administrator's designee;

3	(8)	One representative from the city and county of
4		Honolulu who shall be selected by the mayor of the

9		selected by the mayor of the county of Maui; and
10	(11)	One representative of the county of Hawaii who shall
11		be selected by the mayor of the county of Hawaii.
12	The	administrator of the state health planning and
13	developme	nt agency shall invite the following individuals or
14	their des	ignees to participate on the hui hoʻomana as voting
15	members:	
16	(1)	The president of the National Association of Social
17		Workers, Hawaii Chapter;
18	(2)	The president and chief executive officer of the
19		Hawaii Medical Service Association;
20	(3)	The regional president of Kaiser Permanente Southern
21		California and Hawaii region;

1	(4)	The president and chief executive officer of the
2		Healthcare Association of Hawaii;
3	(5)	The chief executive officer of the Hawaii Primary Care
4		Association;
5	(6)	The executive director of the Hawaii Medical
6		Association;
7	(7)	The executive director of the Hawaii - American Nurses
8		Association;
9	(8)	The president and chief executive officer of The
10		Queen's Health System;
11	(9)	The president and chief executive officer of Hawaii
12		Pacific Health;
13	(10)	The president of the Accountable Healthcare Alliance
14		of Rural Oahu;
15	(11)	The chief executive officer of Papa Ola Lōkahi;
16	(12)	The chief executive officer of AlohaCare';
17	(13)	The state director of AARP Hawaii; and
18	(14)	The president of the Hawaii Pharmacists Association.
19	The	nonvoting ex-officio members shall include:
20	(1)	The chief of staff from the office of the governor or
21		the chief's designee:

1	(2)	The chair of the senate standing committee on health
2		and human services or the chair's designee;
3	(3)	The chair of the house of representatives standing
4		committee on health and homelessness or the chair's
5		designee;
6	(4)	Two members selected and invited by the administrator
7		of the state health planning and development agency
8		from the statewide health coordinating council who
9		shall be confirmed by the senate;
10	(5)	The director of corrections and rehabilitation or the
11		director's designee;
12	(6)	One member from the department of health with
13		expertise in rural health who shall be selected by the
14		director of health;
15	(7)	The director of the executive office on aging or the
16		director's designee;
17	(8)	The attorney general or the attorney general's
18		designee;
19	(9)	The superintendent of education or the
20		superintendent's designee; and

- (10) The director of commerce and consumer affairs or the
 director's designee.
- 3 The first meeting of the hui ho'omana shall be held no later
- 4 than thirty days after the enactment of this Act, at which the
- 5 members shall elect a chair, vice chair, and any other necessary
- 6 officers from among the members.
- 7 A majority of the hui ho'omana voting members present at any
- 8 given meeting shall constitute a quorum to conduct business.
- 9 The hui ho'omana shall meet not less than quarterly and may
- 10 meet more often than quarterly. The state health planning and
- 11 development agency shall provide administrative and clerical
- 12 support required by the hui ho'omana.
- 13 (c) The hui ho'omana shall;
- 14 (1) Identify and prioritize necessary actions for a

 15 comprehensive plan to provide universal access to
- 17 state residents;
- 18 (2) Determine a responsible party, timelines, and deadline
- for each necessary action identified in the
- 20 comprehensive plan; and

- Identify resources required and funding options, which
 may include financing from private, state, and federal
 entities.
- 4 (d) Members of the hui ho'omana shall serve without
 5 compensation but may be reimbursed for reasonable expenses
 6 necessary for the performance of their duties, including travel
 7 expenses.
- 9 and recommendations, including any proposed legislation, to the legislature no later than twenty days prior to the convening of the regular session of 2025, and a final report of its findings and recommendations, including any proposed legislation, to the legislature before its dissolution.
- 14 (f) The hui ho'omana shall be dissolved on July 1, 2025.
- 15 SECTION 3. If any part of this Act is found to be in
- 16 conflict with federal requirements that are a prescribed
- 17 condition for the allocation of federal funds to the State, the
- 18 conflicting part of this Act is inoperative solely to the extent
- 19 of the conflict and with respect to the agencies directly
- 20 affected, and this finding does not affect the operation of the
- 21 remainder of the Act in its application to the agencies

- 1 concerned. The rules under this Act shall meet federal
- 2 requirements that are a necessary condition to the receipt of
- 3 federal funds by the State.
- 4 SECTION 4. This Act shall take effect on December 31,
- **5** 2050.

Description:

Establishes the Hui Ho'omana task force within the State Health Planning and Development Agency to develop a comprehensive plan to provide universal access to equitable and affordable high-quality health care for state residents, including defining action plan items, setting timeline and deadline for each action item, and identifying resources required and funding options. Requires reports to the Legislature. Dissolves the task force on 7/1/2025. Takes effect 12/31/2050. (SD1)
