SENATE CONCURRENT RESOLUTION

URGING A TRANSITION TO A PLANT-BASED LIFESTYLE.

WHEREAS, a plant-based lifestyle that incorporates plant-1 based nutrition and plant-based construction materials offers a 2 multitude of beneficial impacts to human health, animal welfare, 3 4 and the environment; and 5 WHEREAS, a plant-based lifestyle also champions Aloha 'Āina 6 by fostering a respectful and nurturing relationship with the 7 land, encouraging practices that protect and enhance the natural 8 environment, thereby ensuring the well-being of future 9 10 generations; and 11 WHEREAS, in particular, a plant-based lifestyle aligns with 12 13 traditional Hawaiian dietary practices, enriching biodiversity 14 through the cultivation of endemic and canoe plants, supporting the restoration of the Ahupua'a system, aiding in the prevention 15 and mitigation of natural disasters, advancing food security, 16 and advocating for the use of sustainable building materials, 17 thereby fostering a holistic approach to environmental 18 19 stewardship, cultural preservation, and community well-being; 20 and 21 22 WHEREAS, plant-based nutrition consists primarily of fruits, vegetables, whole grains, legumes, beans, nuts, and 23 24 seeds, while minimizing or eliminating animal products, such as meat, poultry, fish, eggs, and dairy products; and 25 26 27 WHEREAS, many health care associations advocate for a 28 plant-based diet including the Physicians Committee for Responsible Medicine, American Heart Association, and MD 29 Anderson Cancer Center at the University of Texas; and 30 31 WHEREAS, a study conducted by the University of Oxford 32 found that a plant-based diet can dramatically reduce greenhouse 33

gas emissions and other harmful effects caused by the meat and 1 dairy industry; and 2 3 WHEREAS, other academic and international institutions like 4 Stanford University; University of California, Berkely; and the 5 United Nations Food and Agriculture Organization have all 6 reported that phasing out animal agriculture can have an 7 8 enormous positive impact on reducing the effects of climate change; now, therefore, 9 10 11 BE IT RESOLVED by the Senate of the Thirty-second 12 Legislature of the State of Hawaii, Regular Session of 2024, the House of Representatives concurring, that this body urges a 13 14 transition to a plant-based lifestyle; and 15 16 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Governor, 17 Comptroller, Director of Health, Superintendent of Education, 18 Chair of the Board of Education, Director of the Department of 19 Agriculture, Director of the Office of Planning and Sustainable 20 21 Development, and mayors of each of the counties. 22 OFFERED BY: With Stables 23 24
