SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO CONVENE A WORKING GROUP TO MAKE RECOMMENDATIONS ON SOLUTIONS TO REDUCE WILDFIRE RISK AND THE FEASIBILITY OF ESTABLISHING A VEGETATION MANAGEMENT PROGRAM AS IT RELATES TO LANDOWNERS AND PUBLIC UTILITIES.

1	WHEREAS, on August 8, 2023, catastrophic wildfires swept
2	through various communities on Maui; and
3 4 5	WHEREAS, the wildfires impacted human life and the community, housing, education, economy, and health of Maui
6 7	residents; and
8 9 10	WHEREAS, the presence of grasses, trees, and other vegetation adjacent to or under electric utility lines poses a significant risk to fire safety; and
11 12 13 14 15 16	WHEREAS, the House of Representatives, in response to the August 2023 Maui wildfires, established six interim working groups charged with evaluating specific topics related to the wildfire and making recommendations for specific legislative action; and
17 18 19 20 21	WHEREAS, the Wildfire Prevention Working Group, one of the six aforementioned working groups, found that people are the primary drivers of wildfires in Hawaii, as ninety-nine percent of wildfires are caused by human ignitions; and
22 23 24 25 26 27 28 29	WHEREAS, the Wildfire Prevention Working Group also found that guinea grass, fountain grass, molasses grass, and buffelgrass can form continuous fuel beds, ignite easily, attain extremely high fine fuel loads, and are capable of growing back more vigorously in the post-fire environment than the majority of native vegetation; and

WHEREAS, utility companies in the State have miles of 1 utility lines installed throughout the State on government and 2 private land including within the public rights of way and 3 mountainous areas of the State; and 4 5 WHEREAS, a significant portion of the aforementioned public 6 and private lands are covered in unmanaged grasses, trees, and 7 other vegetation that may pose a wildfire risk; now, therefore, 8 9 10 BE IT RESOLVED by the Senate of the Thirty-second Legislature of the State of Hawaii, Regular Session of 2024, the 11 House of Representatives concurring, that the Department of Land 12 and Natural Resources is requested to convene a working group to 13 make recommendations on solutions to reduce wildfire risk and 14 the feasibility of establishing a vegetation management program 15 as it relates to landowners and public utilities; and 16 17 18 BE IT FURTHER RESOLVED that the working group is requested 19 to study the need for policy, regulation, and guidance pertaining to the management of and responsibility for 20 vegetation on public and private lands for wildfire mitigation 21 purposes; and 22 23 BE IT FURTHER RESOLVED that the working group is requested 24 25 to study, evaluate, and make recommendations regarding regulations that define property owner obligations to perform 26 vegetation management on public and private property for 27 wildfire mitigation purposes; and 28 29 BE IT FURTHER RESOLVED that the working group is requested 30 to consist of the following members: 31 32 Chairperson of the Board of Land and Natural Resources (1)33 or the Chairperson's designee who is requested to 34 35 serve as the chairperson of the working group; 36 (2) A representative from the Senate, to be appointed by 37 the President of the Senate; 38 39 40 (3) A representative of the House of Representatives, to be appointed by the Speaker of the House of 41 42 Representatives;

5 BE IT FURTHER RESOLVED that the working group is requested 6 to submit a report of its findings and recommendations, 7 including any proposed legislation, to the Legislature no later 8 than twenty days prior to the convening of the Regular Session 9 of 2025; and

BE IT FURTHER RESOLVED that the working group is requested to dissolve on June 30, 2025; and
