SENATE RESOLUTION

URGING CONGRESS TO TAKE IMMEDIATE AND DECISIVE ACTION TO SUPPORT MIDDLE- AND LOWER-INCOME HOUSEHOLDS IN AMERICA.

WHEREAS, the United States faces an ongoing crisis of 1 inequality with middle- and lower-income households bearing the 2 brunt of economic hardship; and 3 4 5 WHEREAS, access to affordable health care remains a critical issue, with millions of Americans lacking adequate 6 7 coverage, resulting in preventable illnesses and deaths; and 8 9 WHEREAS, the coronavirus disease 2019 pandemic exacerbated 10 existing disparities, disproportionately impacting marginalized 11 communities and underscoring the importance of a robust public 12 health infrastructure and equitable access to health care services; and 13 14 15 WHEREAS, the nation continues to witness an alarming number of traffic fatalities, shootings, suicides, and incidents of 16 domestic violence, highlighting the urgent need for 17 comprehensive solutions to address underlying social and mental 18 19 health issues; and 20 21 WHEREAS, despite being one of the wealthiest nations in the 22 world, the United States ranks poorly in numerous health and 23 social indicators, reflecting systemic failures in addressing the needs of its most vulnerable members of society; and 24 25 26 WHEREAS, it is the duty of Congress to prioritize the well-27 being of all citizens and enact legislation that promotes fairness, justice, and opportunity for every individual; and 28 29 30 WHEREAS, the United States is grappling with the staggering 31 costs of living, including skyrocketing housing prices, 32 exorbitant childcare expenses, and the ever-increasing burden of 33 student-loan debt, which disproportionately affects middle- and 34 lower-income families, hindering their ability to achieve 35 financial stability and social mobility; and 36

WHEREAS, the nation also faces an escalating housing crisis 1 characterized by a severe shortage of affordable housing units, 2 rising rents, low wages that are incongruent with the respective 3 estimates of the cost of living in cities throughout the 4 country, and rampant homelessness, leaving millions of Americans 5 precariously housed or without shelter altogether and further 6 exacerbating economic insecurity and perpetuating cycles of 7 8 poverty; and 9 WHEREAS, the urgency of this situation demands swift and 10 concerted action from Congress to address the multifaceted 11 challenges facing the middle- and lower-income households in 12 13 America; and 14 WHEREAS, the failure to act decisively will perpetuate the 15 decline in the infrastructure of the American public health 16 apparatus and deepen the divide between social classes; now, 17 therefore, 18 19 BE IT RESOLVED by the Senate of the Thirty-second 20 Legislature of the State of Hawaii, Regular Session of 2024, 21 that Congress is urged to take immediate and decisive action to 22 support middle- and lower-income households in America; and 23 24 BE IT FURTHER RESOLVED that Congress is specifically urged 25 26 to: 27 (1) Implement policies to ensure universal access to 28 affordable health care, including the expansion of 29 Medicaid and the establishment of a public option; 30 31 32 (2) Enact comprehensive gun control measures to reduce the incidence of shootings and promote community safety; 33 34 35 (3) Invest in mental health resources and support services to address the root causes of suicide and domestic 36 violence; 37 38 Allocate sufficient funding for public health 39 (4) initiatives and emergency preparedness to effectively 40 combat present and future pandemics; and 41 42
