SENATE RESOLUTION

URGING A TRANSITION TO A PLANT-BASED LIFESTYLE.

1 WHEREAS, a plant-based lifestyle that incorporates plantbased nutrition and plant-based construction materials offers a 2 multitude of beneficial impacts to human health, animal welfare, 3 and the environment; and 4 5 WHEREAS, a plant-based lifestyle also champions Aloha 'Āina 6 by fostering a respectful and nurturing relationship with the 7 land, encouraging practices that protect and enhance the natural 8 environment, thereby ensuring the well-being of future 9 10 generations; and 11 WHEREAS, in particular, a plant-based lifestyle aligns with 12 traditional Hawaiian dietary practices, enriching biodiversity 13 through the cultivation of endemic and canoe plants, supporting 14 the restoration of the Ahupua'a system, aiding in the prevention 15 and mitigation of natural disasters, advancing food security, 16 and advocating for the use of sustainable building materials, 17 thereby fostering a holistic approach to environmental 18 stewardship, cultural preservation, and community well-being; 19 20 and 21 WHEREAS, plant-based nutrition consists primarily of 22 fruits, vegetables, whole grains, legumes, beans, nuts, and 23 24 seeds, while minimizing or eliminating animal products, such as 25 meat, poultry, fish, eggs, and dairy products; and 26 27 WHEREAS, many health care associations advocate for a plant-based diet including the Physicians Committee for 28 29 Responsible Medicine, American Heart Association, and MD Anderson Cancer Center at the University of Texas; and 30 31 32 WHEREAS, a study conducted by the University of Oxford found that a plant-based diet can dramatically reduce greenhouse 33 gas emissions and other harmful effects caused by the meat and 34 35 dairy industry; and 36

WHEREAS, other academic and international institutions like 1 2 Stanford University; University of California, Berkely; and the United Nations Food and Agriculture Organization have all 3 4 reported that phasing out animal agriculture can have an enormous positive impact on reducing the effects of climate 5 change; now, therefore, 6

8 BE IT RESOLVED by the Senate of the Thirty-second Legislature of the State of Hawaii, Regular Session of 2024, 9 that this body urges a transition to a plant-based lifestyle; 10 and 11

13 BE IT FURTHER RESOLVED that certified copies of this Resolution be transmitted to the Governor, Comptroller, Director 14 of Health, Superintendent of Education, Chair of the Board of 15 Education, Director of the Department of Agriculture, Director 16 of the Office of Planning and Sustainable Development, and 17 mayors of each of the counties. 18
