Your Committee received testimony in support of the nomination for the appointment of Carl Bonham from the University of Hawaii Professional Assembly.


Upon review of the testimony and the nominee's qualifications, your Committee recognizes that Carl Bonham earned a Bachelor's degree in Economics, *magna cum laude*, from Tulane University and a Doctoral degree in Economics from the University of Texas. Since 2001, he has served as the Executive Director of the University of Hawaii Economic Research Organization and a Professor of Economics at the University of Hawaii at Manoa. He has participated as an economic expert in numerous briefings held jointly by the House Finance Committee and Senate Committee on Ways and Means and at meetings of the Honolulu City Council Committee on Business, Economic Development, and Tourism. He served on the Council on Revenues from 1996 to 2001 and has presently served on the Council since 2003. Your Committee



believes that Carl Bonham's expertise, experience, and commitment to public service make him highly qualified to continue to serve the State on the Council on Revenues.
