Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2042, H.D. 1, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO MENTAL HEALTH,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to appropriate funds for the Department of Health to contract for the provision of youth mental health and wellness services to address the mental health and wellness needs of youth in the State.

Your Committee on Conference has amended this measure by:

- (1) Inserting an appropriation amount of \$900,000;
- (2) Changing the effective date to July 1, 2024; and




- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.



