Transfers certain functions relating to cultural grants from the Hawaii Tourism Authority to the State Foundation on Culture and the Arts. Effective 7/1/3000. (HD1)	TOU, CAI, FIN

HB 2246, HD1 (HSCR65-24) Status	RELATING TO THE STATE FOUNDATION ON CULTURE AND THE ARTS. Transfers the awarding and administration of certain cultural grants from the Hawaii tourism authority to the state foundation on culture and the arts and establishes a standing selection committee within the foundation to review and award the cultural grants. Appropriates funds for grant administrator positions. Effective 7/1/3000. (HD1)	TOU, CAI, FIN

DECISION MAKING TO FOLLOW

The chair may institute a per-testifier time limit.

Committees meeting in the morning must adjourn prior to the day's Floor Session. Therefore, due to time constraints, not all testifiers may be provided an opportunity to offer verbal comments. However, written submissions will be considered by the committee.

Please refrain from profanity or uncivil behavior. Violations may result in ejection from the hearing without the ability to rejoin.
