SB 2085 Status & Testimony	RELATING TO THE STATE FIRE MARSHAL. Re-establishes the position of the State Fire Marshal.	LBT/PSM, WAM
SB 2231 Status & Testimony	RELATING TO WORKERS' COMPENSATION MEDICAL BENEFITS. Expands workers' compensation medical benefits for firefighters to include coverage for breast cancer and cancer of the female reproductive organs.	LBT/PSM, JDC/WAM
SB 3084 Status & Testimony	RELATING TO THE HAWAII NATIONAL GUARD. Exempts Hawaii National Guard service members activated by the Governor or the Governor's designated representative to state active duty from enrollment in the Employees' Retirement System of the State of Hawaii.	PSM/LBT, WAM
SB 3313 Status & Testimony	RELATING TO THE DEPARTMENT OF LAW ENFORCEMENT. Appropriates funds to increase the salary schedules of deputy sheriffs within the Department of Law Enforcement. Declares that the general fund expenditure ceiling is exceeded.	PSM/LBT, WAM

- Testifiers for this hearing will be limited to **2 minutes** each.
