SB 3348 Status & Testimony	RELATING TO TRANSPORTATION. Changes the state registration fee and the state vehicle weight tax amounts.	TCA, WAM
SB 3287 Status & Testimony	RELATING TO TOWING COMPANIES. Changes the fees that a towing company may charge to tow vehicles left unattended on private and public property. Requires certain towing companies to maintain certificates of good standing issued by the Department of Commerce and Consumer Affairs.	TCA, CPN
SB 2740 Status & Testimony	RELATING TO MOPEDS.  Beginning 1/1/26, requires that every moped rented in the State be an electric moped.	TCA, CPN
SB 3012 Status & Testimony	RELATING TO MOTOR VEHICLE SAFETY INSPECTIONS. Lengthens the time period in which certain vehicles must have a safety inspection.	TCA, WAM
SB 3237 Status & Testimony	RELATING TO AGRICULTURE. Facilitates the control and eradication of invasive species and pests. Establishes a plant nursery licensing program. Requires the Department of Agriculture to designate certain species as pests for control or eradication. Imposes certain limits on imports and transportation. Updates the method by which the Department's noxious weed list is updated.	AEN/TCA, JDC/WAM
