Prohibits individuals without a valid unrevoked license obtained from the Hawaii Board of Veterinary Medicine, or operating under the direct supervision of the same, from performing any surgical procedure on any pet animal. Makes performing any surgical procedure on any pet animal without a valid unrevoked license obtained from the Hawaii Board of Veterinary Medicine, or operating under the direct supervision of the same, a class C felony. Makes cropping and docking offenses of cruelty to animals in the first degree. Takes effect 4/14/2112. (SD3)	JHA
