## Re: G.M. No. 724

G.M. No. submits the nomination of Jon Matsuoka to the Hawai'i Civil Rights Commission (HCRC), for Senate consideration and confirmation. If confirmed, this would be Commissioner Matsuoka's second term.

The HCRC has enforcement jurisdiction of Hawai'i's laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state-funded services. The HCRC carries out the Hawai'i constitutional mandate that no person shall be discriminated against in the exercise of their civil rights. Art. I, Sec. 5.

The statutory qualifications for HCRC Commissioners are laid out in HRS § 368-2(a): "The members appointed to the commission shall be selected on the basis of their knowledge and experience in civil rights matters and on the basis of a demonstrated commitment to the preservation of the civil rights of all individuals."

HCRC staff are greatly appreciative of the contributions that Jon Matsuoka has made as a HCRC Commissioner and his willingness to continue to serve. Jon brings a wealth of experience and expertise

to the Commission, and has an impressive record of demonstrated commitment to supporting civil rights for Hawai'i and its people through his many years in the field of academic social work. As an educator, and as an advisor, Jon's areas of interest and expertise include Indigenous, Asian, and Pacific Islander well-being and communities and he has published voluminous articles in many peer-reviewed journals on these topics. His background adds valuable perspective to the work of the Commission, and we welcome the opportunity to work with Commissioner Matsuoka for another term.
