- How can our education system better harness the abundant non-traditional learning opportunities in Hawaii offered by local non-profits, employers, and community organizations?

We support the nomination of Roy Takumi, as we believe a leader and policymaker with his experience and expertise will represent an exciting new chapter for the BOE. His deep relationships with the DOE, legislature, and community are an exciting and likely unprecedented opportunity to move forward as one system. I have known and worked with and for Roy Takumi since he was first elected to the Hawaii State House of Representatives in 1992.

Roy brings a dedication to public education, experience as a Chair of a number of Committees, a keen mind, an ability to learn from others and the good sense to listen to my advice at least once in-awhile.

Most of you know that Roy can be a curmudgeon with a sharp wit. However I have only seen him carefully and with knowledge lead his committees.

Act 51 SLH 2004 was a product of his ability to work with the Business Round Table, the Senate Eduction Committee, the DOE Superintendent, and the Chair of the Board of Education. This Act withstood a veto which was overridden by the Legislature. However the veto was not ignored and amendments were made in the very same session.
