HOUSE BILL NO. 1527 RELATING TO VETERINARY MEDICINE

Chair Tarnas, Vice Chair Takayama, and Members of the Committee:

Thank you for the opportunity to testify on House Bill 1527. HB1527 amends HRS sections 471-1, 471-2, 471-15, and 711-1008.5. The definition of a pet animal is inserted in section 471-1, HRS. Section 471-2 adds language that the owner and the owner's employees shall not perform any surgical procedure on the animal or animals, including: cesarean section; ear cropping; tail docking; ventriculocordectomy; onychectomy; elastration or castration via banding, of a pet animal. Language is added to section 471-15 where conviction of subsection 471-2(2) violation is a class C felony and subject to a fine not to exceed \$10,000 or imprisonment not more than five years, or both. The Department respectfully opposes.

Accepted practices in livestock management could be construed as illegal under this measure. Therefore, the Department recommends "the animal or animals" in Section 471-2 (2) be changed to "a dog or dogs" because dogs are the species most affected. Similarly proposed amendment to section 711-1008.5 (2) (a) "when the practices are performed by a veterinarian licensed under 13 chapter 471;" should be deleted.

My name is Melelani Oshiro, and I am an Assistant Extension Agent for Livestock programs with the University of Hawai'i at Mānoa's College of Tropical Agriculture and Human Resources (CTAHR). I am pleased to provide personal testimony on HB1527 This testimony does not represent the position of the University of Hawai'i or CTAHR.

I <u>oppose</u> the comments HB1527, which prohibits animal owners and their employees from performing any surgical procedures on the owner's animal or animals and prohibits the elastration, or castration via banding, of a pet animal.

The proposed legislation to deem castration of livestock as a Class C felony in Hawaii would have a devastating impact on the state's livestock producers. The Animal Welfare Institute **strongly supports HB1527** with two small but necessary amendments. This bill has long been needed to close a loophole in our first degree animal cruelty law that has shockingly exempted non-veterinarians from performing painful surgical procedures on animals, without access to pain medication, antibiotics to prevent infection and other critical pre and post-operative care that can only be provided under the supervision of a licensed veterinarian.

While numerous countries and municipalities across the US completely prohibit ear cropping, tail docking, de-clawing and other procedures, this bill would still allow for such procedures IF performed by a licensed veterinarian. Further, the American Veterinary Medical Association opposes ear cropping and tail docking of dogs when done solely for cosmetic purposes, as that remains the primary justification for such unnecessary procedures and thus, the AVMA also encourages the elimination of ear cropping and tail docking from breed standards.

Locally, there have been countless cases of painful "home/backyard" ear cropping and tail cutting incidents done with scissors or garden shears and male dog "castration" being performed using rubber bands, which painfully restricts blood flow to the animals testicles and can result in death. Further, cases demonstrate that these incidents aren't limited to a person doing this to their own animal, but performing these cruel and painful acts on animals belonging to others, falsely presenting themselves as veterinary medical experts and charging fees for these procedures. Under existing law, if a person were to cut off or attempt to cut off any other part of an animal they would be rightfully charged with animal cruelty—whereas under current law there is no penalty for "customary" practices such as cropping or docking.

We ask the Committees to please amend the bill to ensure this gaping loophole is closed once and for all, that it is enforceable and holds those who victimize animals and their owners accountable.

line 14, correct the spelling of Section (2)(E) from "onchectomy" to "onychectomy"

Aloha Chair Tarnas, Vice Chair Takayama and Committee Members,

On behalf of the Hawaiian Humane Society, thank you for considering our support for House Bill 1527, which prohibits animal owners and their employees from performing any surgical procedures on the owner's animal or animals; prohibits the elastration, or castration via banding, of a pet animal; provides that a violation of the prohibitions is a class C felony; clarifies that the offense of cruelty to animals in the first degree does not apply to accepted veterinary practices and cropping or docking as customarily practiced when the procedures are performed by a licensed veterinarian.

This measure closes a loophole in the veterinary licensing statute that owners have used to operate on their own animals, or hire unqualified people to do so, resulting in animals being harmed by backyard surgeries ranging from ear-flap removal to cesarean sections.

We request the following amendment to further clarify the intent of the bill:

Page 2, Line 6-8, strike "the owner and the owner's employees shall not" and amend to read "no person not licensed under HRS 471 shall perform any surgical procedure on a pet animal including, but not limited to:"

And the following amendment to correct a spelling error in the draft:

Page 2 Line 14, correct the spelling of Section (2)(E) from "onchectomy" to "onychectomy."

The Hawaiian Humane Society opposes cosmetic surgery on animals, but we are pleased that this measure would at least require that such procedures must be performed by a licensed veterinarian. It is a good step.

Surgical birth certainly should never be performed by anyone but a licensed veterinarian.

Exxy, an approximately 3-year-old bulldog mix, was brought into our care with a large ventral abdominal hernia and sent out for specialized surgery. The





Exxy before and after surgery for an abdominal hernia, suspected to be secondary to a backyard C-section. She also has very short, cropped ears, which are prone to infection and usually an indication of amateur surgery.

Hawaiian Humane Society veterinarian who examined her and the veterinary surgeon who operated on her concurred that the injury was the result of a backyard cesarean section.

Exxy was lucky enough to survive the mutilation and get the care she needed, but it is safe to expect that many animals in similar situations die without ever making into the care of a shelter or veterinary clinic.

Many of these backyard surgeries are performed for profit-driven breeders who would rather make more money on the animals they sell than go to a licensed veterinarian for either necessary or cosmetic care. Allowing animals to be bred and sold for profit without regard for their welfare is sadly the norm in our state, but this is one harm we can prevent.

We urge the committee to pass HB 1527 and stop this form of animal cruelty. Mahalo for your consideration.

Chair Tarnas and Members of the Committee:

My name is Marcella Chock, and I am the Chairperson of the Hawaii Board of Veterinary Medicine (Board). The Board appreciates the intent and offers comments on this bill.

The purposes of this bill are to: (1) prohibit animal owners and their employees from performing any surgical procedures on the owner's animal or animals; (2) prohibit the elastration, or castration via banding, of a pet animal; (3) provide that a violation of the prohibitions is a class C felony; and (4) clarify that the offense of cruelty to animals in the first degree does not apply to accepted veterinary practices and cropping or docking as customarily practiced when the procedures are performed by a licensed veterinarian.

The Board recognizes that surgical procedures require proper training, knowledge of anatomy, and the ability to prescribe proper pain management therapeutics, which the typical pet owner or their employees would not have received or have access too. The Board suggests the definition of "pet animals" and references to "pet animals" as referenced on page 1, lines 4 and 5, and page 2, lines 15 and 16 be removed, as the issues raised appear to be related only to dogs and not all pet animals.

Further, the Board requests that the terms "animal or animals" be changed to "dogs" on page 2, lines 7 and 8. The Board also requests that subsection (2)(C) "Tail docking" on page 2, line 11, either be removed in its entirety or amended to read: <u>Tail docking or amputation of adult dogs</u>. The Board makes this recommendation as it does not appear that complications appear in the tail docking of neo-natal puppies by owners.

Testimony of the Hawaii Board of Veterinary Medicine H.B. 1527 Page 2 of 2

The Board suggests removing "when the procedure is performed by a veterinarian licensed under chapter 471" on lines 17-19 on page 5.

The Board also recommends that the penalties listed on page 4, lines 8 and 9, be updated to be commensurate with chapter 706, Hawaii Revised Statutes (HRS), as both the maximum fine of \$500 listed and the length of imprisonment listed are significantly under the maximum amounts of \$1000 and one year allowed by chapter 706, HRS.

The Board finds that cruelty to animals is already a class C felony pursuant to chapter 711-1108.5, HRS and believes that creating a felony for violation of chapter 471-2 (2), HRS unduly punishes a pet owner or their employees while exempting other individuals covered in the exemptions from licensure listed in chapter 471-2, HRS. Consequently, the Board suggest removing lines 17 to 20 on page 4.

If the Committee is inclined to pass this measure, the Board prefers the language contained in a similar measure, S.B. 2562.

The Hawaii Veterinary Medical Association and the veterinary community that it represents stand in favor of the intent of this bill, which prevents non-veterinarians from performing surgical procedures on certain animals. We strongly prefer the language of companion bill SB2562 as this would specifically protect the animals (dogs) that are currently injured by such practices, while continuing to allow accepted livestock husbandry practices. Additionally SB2562 does not require addressing the legal definition of "pet animal", which could have many unintended consequences.

Veterinarians have extensive training in surgery, anesthesia, anesthetic monitoring, asepsis, and pain management; their expertise allows them to perform surgical procedures humanely and safely. Unfortunately, it is not uncommon for local veterinarians to be asked to treat pets suffering from botched surgeries performed by non-veterinarians. When harnessing the term surgical, we should take immediate pause. Surgical is something done with great precision, it is a specialty, and it relates to surgeons (those licensed to provide medical care). Surgical care should not be provided or performed by someone that is not trained and educated on how to create a hygienic and sanitary area, how to provide pain relief, how to provide after care antibiotics, how to respond in an emergency, and how to perform the precision needed for the operation. The intent of HB1527 is to prevent individuals from performing illegal surgery on dogs and cats. As a veterinarian and Chair of Hawaii Cattlemen's Council Animal Health and Well-being Committee, I strongly support the **intent** of this measure.

However, as written, the bill would also severely and negatively impact our agricultural community by limiting their ability to care for their livestock needs. Castration and tail docking of calves, lambs/kids and piglets are widely accepted practices that prevent injury and improve the overall well-being of livestock. The procedures are done by skilled livestock producers who adhere to best practices and low stress handling techniques. Previously, I submitted testimony in support of HB 1527, Relating to Veterinary Medicine. After reviewing the bill again, I'd like to respectfully comment that I found the proposed new language to Section 471-2, at page 2, lines 5-7, confusing. I think that the concept is to prohibit any person who is not licensed under Chapter 471 from performing a surgical procedure that does not fall within the listed exceptions; to provide that owners are to use normal "care and treatment," and to state that the procedures listed on lines 9-16 do not fall within normal "care and treatment" for an owner. What confused me was that the new language followed the semi-colon rather than standing on its own.

Another thought for your consideration is to add "but not limited to" after "including" at line 8. It is possible that there may be other procedures that could be performed on pets that are not listed and if "not limited to" is added, then those could also fall within the amended statute.

My name is Halina M. Zaleski and I am a retired Extension Specialist with the University of Hawai`i at Mānoa's College of Tropical Agriculture and Human Resources (CTAHR). I am pleased to provide personal testimony on HB 1527. This testimony does not represent the position of the University of Hawai'i or CTAHR.

I OPPOSE HB 1527 because it will have an enormous negative impact on livestock welfare and on livestock producers because it prevents producers from performing routine animal husbandry practices. There are, for example, thousands of pigs born in Hawai'i every year and I do not think that the state has the resources to provide veterinarians to castrate each one at an age when the procedure is least stressful for the piglet. And then there are the chickens, calves, lambs, kids, etc. We have trained producers to perform routine husbandry procedures in a way that minimizes pain and stress for the livestock.

It is particularly appropriate that this bill is being heard by the House Committee on Judiciary & Hawaiian Affairs, because pig raising has been an important part of Hawaiian culture since the first pigs arrived with the Polynesian voyagers. It would be a shame to make pig raising impossible for all except the largest mainland farms that have the resources to have a veterinarian on staff.

My name is Jenee Odani, and I am a licensed veterinarian in Hawaii. I was formerly the Extension Veterinarian for the University of Hawaii and have over 20 years of experience in veterinary practice. I am also the current president of the Hawaii Veterinary Medical Association (HVMA) and the alternate Hawaii delegate to the American Veterinary Medical Association's (AVMA) House of Delegates. The testimony and comments I am providing are my own and do not represent the position of the University, the HVMA, or the AVMA.

I am grateful for the opportunity to provide personal testimony and comments **OPPOSING HB 1527**.

While I support the spirit of this bill, which is to prevent surgery on dogs from being performed by non-veterinarians, I do not support this bill as it is currently written.

In Section 471-2, I suggest removing "of a pet animal" from (2-F) because it is unclear whether "of a pet animal" refers only to elastration/castration via banding (F), or if it applies to all the surgical procedures listed (A-F). If the "pet animal" limitation does not apply to all the procedures listed, then livestock producers will be dramatically harmed. Therefore, I suggest replacing "animal or animals" in page 2, Line 7-8 with "dog or dogs", "dog(s) and cat(s)", OR "pet animal or animals." This way, it will more clearly allow livestock producers to continue the customary husbandry practices of tail-docking of young piglets and lambs and castration of young calves, piglets, lambs, and kids.

This is important because it is cost-prohibitive to require producers to hire veterinarians to perform these procedures, and there is a shortage of food animal veterinarians in the state who are willing to perform these procedures. These procedures are considered ordinary practice of animal husbandry and are performed by skilled livestock producers who work tirelessly to provide local food for our state.

Lastly, although Section 471-2 (6) allows a farmer to give "another farmer the assistance customarily given in the ordinary practice of animal husbandry," it does not specifically allow the farmer themselves to perform the procedures on their own animal. This is why I believe it is critical that Section 471-2 (2) be modified.
