My name is Shawn Stillman and I am a concerned Owner/Operator of SS Towing HI. I am a father to two children whom I am the sole provider for. I have been in the towing industry for 15 years. I would like to humbly ask for your time to consider my concerns. I am testifying on how the towing industry lacks the support of not only the public but also outside agencies.

In my personal experience I have encountered numerous of recoveries where my life gets put at risk. There have been instances where it has taken two or more hours to recover the vehicle depending on the circumstances. An accident can range from a minor fender bender, a vehicle flipped over in the ditch, having to recover miles off the road to a vehicle split into three pieces. In these type of situations, it takes much longer and requires more labor and the proper knowledge and expertise to complete the job.

Today I wanted to share my story with everyone to elaborate on the risks, labor, and lack of compensation for the towing industry. I would like for the public and outside agencies to understand how my job as a tow truck operator is not taken lightly and how anything can happen at any given time. Support from the public and outside agencies for fair compensation on the more complex jobs would be very helpful.
