In consideration of HOUSE BILL 1886 RELATING TO FIRE PROTECTION

House Bill 1886 proposes authorizing the use of the Reduced Ignition Propensity Cigarette Program Special Fund to support the State Fire Council (Council) and its programs and activities, including hiring administrative personnel. The Department of Land and Natural Resources (Department) strongly supports this measure.

The Department's Division of Forestry and Wildlife (DOFAW) is the primary responder for wildland fires across 1,368,002 acres of the State of Hawai'i's forested watersheds (or 26% of the land area in Hawaii) and supports federal and county responders on remaining areas in the state. DOFAW is a member of the Council and supports increased funding to the Council through the Fund for the Council staff to meet the increased demands upon the Council and to make up for the operational shortfall of the Reduced Ignition Propensity Cigarette Program. The funds would provide for statewide educational efforts to protect life, property, and the environment, such as the statewide firefighter safety guide program for Hawai'i's youth and the residential smoke alarm installation program for Hawai'i's at-risk senior population.



SUBJECT: HOUSE BILL (HB) 1886 RELATING TO FIRE PROTECTION

I am Bradford K. Ventura, member of the Hawaii State Fire Council (SFC) and Fire Chief of the Maui Fire Department. The SFC supports HB 1886, which authorizes the use of the reduced ignition propensity cigarette program special fund to support the State Fire Council and its program and activities, including the hiring of administrative personnel.

The SFC was established by the Hawaii State (State) Legislature in 1979 to replace the State Fire Marshal's office. It is currently comprised of the four county Fire Chief, State of Hawaii, a representative from the Division of Forestry and Wildlife, Department of Land and Natural Resources (DOFAW), and is administratively attached to the State Department of Labor and Industrial Relations (DLIR).

In accordance with Hawaii Revised Statutes §132, the SFC's primary mission is to develop and support a comprehensive fire service emergency management network for the protection of life, property, and the environment for the State. The SFC promotes the standardization of fire service reporting, training, sharing of technology, resources, and best management practices. The SFC may advise and assist the county fire departments where appropriate; prescribe standard procedures and forms related to inspections, investigations, and reporting of fires; and advise the Governor and State Legislature on issues relating to fire prevention and protection and life safety.

On July 6, 2008, during the 24th Hawaii State Legislature Regular Session, Act 218 was passed, and Hawaii became the 36th state requiring only RIPC be sold in Hawaii. This law took effect on September 30, 2009. More than 700 brand/style cigarettes were certified by the SFC as being RIPC-compliant. A \$375 fee was also attached for each brand/style cigarettes that was certified for sale in our state. Almost \$660,000 in RIPC certification fees were collected before an RIPC Program Specialist was hired on January 16, 2014.

The SFC urges the committee's approval of HB 1886.

I am Sheldon K. Hao, Fire Chief of the Honolulu Fire Department (HFD). The HFD supports HB 1886, which authorizes the use of the reduced ignition propensity cigarette (RIPC) program Special Fund to support the State Fire Council (SFC) and its programs and activities, including the hiring of administrative personnel.

The SFC was established by the Hawaii State (State) legislature in 1979 to replace the State Fire Marshal's office. It is currently comprised of the four county Fire Chiefs and representatives from the State Aircraft Rescue Fire Fighting Unit and the Department of Land and Natural Resources' Division of Forestry and Wildlife and administratively attached to the State Department of Labor and Industrial Relations.

In accordance with Hawaii Revised Statutes §132, the SFC's primary mission is to develop and support a comprehensive fire service emergency management network for the protection of life, property, and the environment for the State. The SFC promotes the standardization of fire service reporting, training, technology sharing, resources, and best management practices. The SFC may advise and assist the county fire departments where appropriate; prescribe standard procedures and forms related to inspections, investigations, and reporting of fires; and advise the Governor and State legislature on issues relating to fire prevention and protection and life safety.
