in consideration of HB 1925 RELATING TO THE HAWAII STATE PLANNING ACT.

Chair Ichiyama, Vice Chair Poepoe, and Members of the House Committee on Water and Land.

The Office of Planning and Sustainable Development (OPSD) **supports** HB 1925 which establishes the Hawaii State Planning Act Phase II Update Task Force within the Office of Planning and Sustainable Development and makes an appropriation.

OPSD agrees that HRS Chapter 226, the Hawaii State Planning Act, should be updated to reflect new conditions in Hawaii. In 2018, OP undertook a Phase I review of Ch. 226 and found outdated goals and objectives. Since then, the Legislature has added important objectives supporting climate change adaptation and sustainability. However, a more comprehensive update would benefit future planning for a rapidly changing world. Hawaii is geographically isolated, but not isolated from global climate and economic impacts.

OPSD requires an appropriation and one exempt (1) FTE in order to undertake this project, so long as it does not replace Administration budget priorities. A task force established by law is subject to Sunshine Law and substantial public input is needed to refine and validate proposals for amendments to Ch. 226.

We write in support of HB 1925, Relating to the Hawaii State Planning Act. The purpose of HB 1925 is to establish the Hawai'i State Planning Act Phase II Update Task Force within the Office of Planning and Sustainable Development and to provide one fulltime equivalent (FTE) position to provide support for the task force.

The State (and rest of world) are facing numerous complex, interlocking challenges that are increasing in speed and scale. These challenges require solutions and approaches that are cross-sector and collaborative. This proposal aims to use the opportunity to update and modernize the State Planning Act (HRS 226) to address these complex challenges. Additionally, it assists in resource allocation, coordinates federal, State, and county plans, and integrates major state and county activities.

Phase I of the 2018 comprehensive update is complete. But with the challenges facing the state and its residents, which require close collaboration and planning between all sectors in the state, now is an opportune time to conduct Phase II. This presents the opportunity to build on the work done in 2018, involve more voices from the community in the process to update and simplify the Hawai'i State Plan, and through that process create alignment on how to move our state and its economy successfully and sustainably into the future.
