Honorable Chair Della Au Belatti, and House Committee on Health and Homelessness members, thank you for the opportunity to provide testimony concerning House Bill HB 1941, MAKING AN EMERGENCY APPROPRIATION TO THE DEPARTMENT OF HEALTH TO IMPLEMENT QUALITY IMPROVEMENT RECOMMENDATIONS FOR THE HAWAII STATE HOSPITAL. My name is Billie Yutaka, and I strongly support Bill HB 1941. I have been a psychiatric technician at the Hawaii State Hospital since 2012. As a psychiatric technician, we play a crucial role in providing care and support to patients with serious mental illnesses. In order to be effective at maintaining safety and providing a therapeutic environment, the state hospital is in need of adequate staffing and infrastructure.

The severity of the staffing shortage at the Hawaii State Hospital is unacceptable. We are constantly working overtime to cover our matrix, which leads to fatigue and safety concerns. The Hawaii State Healthcare Association reports a 26.8% vacancy rate for registered nurses as of June 30, 2023 and a 20.9% vacancy rate for direct support professionals as of June 30, 2023. Doctors, nurses, social workers, and techs have high workloads that impact the quality of patient care. Consequences of understaffing include reduced quality of care, increased patient violence, and burnout among remaining staff. On November 13, 2023, Justin Bautista, 29, a registered nurse working at a transitional group home at the Hawai'i State Hospital, was tragically murdered. It was an unnecessary and preventable death. We pondered the question: might it have been averted with more personnel, stronger security measures, and more effective rules that could have been put into place? I agree that it was possible.

Our new addition, a \$160 million psychiatric facility, is described as holding 144 beds; however, we are often at full capacity. We have since experienced overcrowding, leaky roofs, plumbing issues, and a state-of-the-art security system that is unreliable.

We also have six units that are outdated and deteriorating. They lack basic amenities like proper lighting and heating. As well as limited outdoor space and recreational opportunities for patients. We experienced broken windows, mold growth, exposed pipes, malfunctioning ventilation systems, and inadequate electrical wiring. Both patients and staff run the risk of developing more health issues as well as possible legal repercussions.

Having personally experienced the difficulties, I beg you to approve HB 1941. By doing this, we can continue to invest in better facilities and address the severe staffing shortages, as it is our shared duty to deliver safe and efficient care. Better treatment is due to the Hawaii State Hospital's employees and patients. We can make sure they receive the attention and assistance they require to flourish if we act now.
