RELATING TO PHARMACY

The Department of Budget and Finance (B&F) offers comments on this bill.

House Bill (H.B.) No. 2113, H.D. 1: 1) establishes the Daniel K. Inouye College of Pharmacy Special Fund (COPSF) to be administered by the University of Hawai'i and expended on activities related to pharmacist workforce development and planning within the State; 2) establishes pharmacist workforce assessment fees of undetermined amounts for renewed pharmacist licenses, new or renewed wholesale prescription drug distributor licenses, new or renewed pharmacy permits, and new or renewed permits; 3) appropriates an unspecified amount of special funds for FY 25 from the Department of Commerce and Consumer Affairs' Compliance Resolution Fund to be deposited into the COPSF; and 4) appropriates an unspecified amount of special funds out of the COPSF for FY 25 for the purpose of pharmacist workforce development. Revenues for the COPSF include appropriations by the Legislature, pharmacist workforce assessment fees, interest, and grants, gifts and other income.

As a matter of general policy, B&F does not support the creation of any special fund which does not meet the requirements of Section 37-52.3, HRS. Special funds should:

1) serve a need as demonstrated by the purpose, scope of work and an explanation why the program cannot be implemented successfully under the general fund appropriation process; 2) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries or a clear link between the program and the sources of revenue;
3) provide an appropriate means of financing for the program or activity; and
4) demonstrate the capacity to be financially self-sustaining. Regarding H.B. No. 2113, H.D. 1, it is difficult to determine whether the proposed COPSF would be self-sustaining. Thank you for your consideration of our comments.

HB 2113 HD1 – RELATING TO PHARMACY

Chair Yamashita, Vice Chair Kitagawa, and Members of the Committee:

Thank you for the opportunity to submit testimony on HB 2113 HD1. The University of Hawai'i at Hilo (UH Hilo) supports HB 2113 HD1, which establishes the Daniel K. Inouye College of Pharmacy Special Fund to create a Hawai'i Center for Pharmacy which will support pharmacist workforce assessment and planning efforts. The Center will be established through a pharmacist workforce assessment fee, and appropriate funds to advance the profession of pharmacy, as part of an intentional effort to help improve access to quality health care for the people of Hawai'i.

Pharmacists are among the most accessible health care providers, with a doctoral level of expertise and clinical training, and are currently underutilized in Hawai'i. HB 2113 HD1 is modeled after the Hawai'i Center for Medicine and Hawai'i Center for Nursing, which have been instrumental in facilitating the ability of these professions to be proactive and strategic in formulating data-informed solutions for existing and emerging health care challenges in Hawai'i. HB 2113 HD1 will allow pharmacists, who are essential members of current health care teams, to also align with and contribute to this collective effort.

Passage of HB 2113 HD1 represents a profession-driven solution that will allow pharmacy to match the standard already granted to other health care professions (medicine, nursing) in Hawai'i. It will allow for a workforce assessment fee as part of licensing requirements that would create a foundational base and sustainable mechanism for supporting the activities of a Hawai'i Center for Pharmacy.

The Hawai'i Center for Pharmacy will be housed in the Daniel K. Inouye College of Pharmacy, which similar to the existing centers for medicine and nursing, will allow the profession to leverage the academic expertise and unique training and professional networks that are necessary for implementing data-driven approaches and innovative

solutions to improve access to quality health care. In addition, the role of the college in training future pharmacists offers natural synergies for supporting the disbursement of scholarships and loan repayment initiatives to attract to Hawai'i and retain needed talent for service in medically-underserved areas of the state.

In summary, passage of HB 2113 HD1 will support a data-informed, coordinated and intentional effort to position the profession of pharmacy to help fill existing health care gaps in Hawai'i. The college is uniquely suited for housing the proposed Center which will proactively assess, train, and leverage pharmacists, working with pharmacy stakeholders across the state and country, to fill gaps in care related to medication management and safety. Pharmacists are embedded as trusted health care professionals in many remote communities, and many published studies have documented their positive impact on patient outcomes as the health care landscape has shifted to value- and team-based care models. The proposed Center would be instrumental in adapting effective approaches for the unique needs of Hawai'i and creating innovative solutions working in alignment with other stakeholders in today's rapidly evolving health care landscape. The people of Hawai'i deserve access to quality health care and we respectfully ask your support in allowing the profession of pharmacy to be part of the solution through this Center.

Chair Yamashita and Members of the Committee:

My name is James Skizewski, and I am the Executive Officer of the Board of Pharmacy (Board). The Board supports the intent of this bill and offers comments.

The purposes of this bill are to: (1) establish the Daniel K. Inouye College of Pharmacy Special Fund to support pharmacist workforce assessment and planning efforts; (2) establish the pharmacist workforce assessment fee; and (3) appropriate funds.

The Board requests clarification on oversight of such a fund. Without assurances related to oversight, it is unclear who this special fund will benefit.

The Board requests additional information related to the benefit of such a fee to licensees. License fees are provided in proportion to the cost of managing and administering the Board and the Board's related licenses. To increase fees on all licensees under the Board of Pharmacy without a clear benefit to be gained by licensees is of concern.

Lastly, the amount which will be added to initial licensure and renewal fees is unclear. The Board requests clarity on the amount of funding that is being requested.

Testimony in SUPPORT for HB2113, HD1 – Establishment of a Center for Pharmacy

Dear Chair Yamashita, Vice Chair Kitagawa, and members of the Finance Committee:

As a <u>rural</u> healthcare provider, access to comprehensive, high-quality healthcare services is our mission at Moloka'i Drugs. On behalf of our employees and patients, I am testifying in favor of HB2113, HD1, which proposes the establishment of a Center for Pharmacy in Hawai'i.

For the past 15+ years, we have supported the Daniel K. Inouye UH College of Pharmacy (DKICOP) by being a preceptor site for year one to year four interns working at Moloka'i Drugs with our pharmacist-incharge. Unfortunately, not one DKICOP intern we have hosted was raised on Moloka'i. One of the biggest reasons we have had a difficult time "growing our own" on Moloka'i is the pure expense of four years of off-island pharmacy school tuition, room and board, books, fees and travel. One of the proposed roles of the new center will include coordinating pharmacy student loan payment. By having a center helping with pharmacy school student loan payment, we will find more of our Moloka'i students going into the pharmacy profession.

Currently, Moloka'i Drugs is a training worksite for national certified pharmacy technician (CPhT) training for Good Jobs Hawai'i, a partnership among the University of Hawai'i Community Colleges, employers and organizations that "want to help people in Hawai'i attain a good quality job for generations to come." Moloka'i Drugs is also partnering with DKICOP, the University of Hawai'i – Hilo and the University of Hawai'i – Maui College with expanded CPhT development, which will include immunization training for CPhTs. This new center will also help implement retention initiatives for pharmacists and pharmacy technicians, which has always been a concern of rural healthcare facilities, including Molokai Drugs, on the island of Moloka'i with a population of 7,000 residents.

Thank you for your consideration and vote for HB2113, HD1. We at Moloka'i Drugs, Inc. look forward to being the first company signed with the Center for Pharmacy, which will help us make more of an impact in access to quality healthcare services for our patients.

INTRODUCED BY: SAYAMA, BELATTI, HOLT, KILA, KOBAYASHI, LA CHICA, MARTEN, MIYAKE, MORIKAWA, NAKASHIMA, NISHIMOTO, TAKENOUCHI, TAM, TARNAS

EXECUTIVE SUMMARY: Establishes the Daniel K. Inouye College of Pharmacy Special Fund to support pharmacist workforce assessment and planning efforts. Establishes the pharmacist workforce assessment fee.

SYNOPSIS: Adds a new section to chapter 304A, HRS, that establishes the Daniel K. Inouye College of Pharmacy Special Fund. The fund shall be used to support pharmacist workforce assessment and planning efforts, including the recruitment and retention of pharmacists, for rural and medically underserved areas of the State, including: (1) Maintaining accurate pharmacist workforce assessment information and providing or updating personal and professional information, that shall be maintained in a secure database; (2) Providing loan repayment to pharmacists who commit to working in medically underserved areas of the State as part of the Hawaii state loan repayment program administered by the Daniel K. Inouye college of pharmacy; and (3) Providing scholarships to qualifying pharmacy students to be determined by the Daniel K. Inouye college of pharmacy.

Adds a new section to chapter 461, HRS, that imposes the Workforce Assessment Fee. The fee imposed is: (1) \$, for each renewed license as a pharmacist; (2) \$, for each new or renewed wholesale prescription drug distributor license; (3) \$, for each new or renewed pharmacy permit under section 461-14; and (4) \$, for each new or renewed permit under section 461-15. The fee is to be deposited into the special fund.

Makes technical and conforming amendments to sections 461-8 and 461-16, HRS.

EFFECTIVE DATE: July 1, 3000.

STAFF COMMENTS: The 1989 Tax Review Commission noted that use of special fund financing is a "departure from Hawaii's sound fiscal policies and should be avoided." It also noted that special funds are appropriate where the revenues to the funds maintain some direct connection between a public service and the beneficiary of that service. The Commission found that special funds which merely set aside general funds cannot be justified as such actions restrict budget flexibility, create inefficiencies, and lessen accountability. It recommended that such programs can be given priority under the normal budget process without having to resort to this type of financing.

We understand that industry is supporting this measure to "keep up with the Joneses," namely the physicians and the nurses, who we understand already have special-funded programs. Whether to achieve parity or not, the Legislature should be exercising its constitutional responsibilities and determine which of the State's priorities are worthy of funding. If scholarships and loan repayment for new pharmacists and pharmacists-in-training is as important as its proponents suggest, then the legislature could just give a few more dollars to the University of Hawaii to administer such programs. The bill proposes, in essence, partial abdication of that responsibility to the University of Hawaii.

WRITTEN TESTIMONY IN SUPPORT on H.B. 2113, H.D. 1

Chair Yamashita, Vice Chair Kitagawa, and members of the Committee, thank you for hearing this measure which aims to establish the Daniel K. Inouye College of Pharmacy Special Fund to support pharmacist workforce assessment and planning efforts as well as establishes the pharmacist workforce assessment fee and appropriates funds.

The Hawai'i State Center for Nursing (HCSN) was established by a similar manner as proposed in H.B. 2113. Established by the Legislature in 2003 by Act 198 with staffing starting in 2005, the Center was founded "to address nursing workforce issues." The Center is located at the University of Hawai'i at Mānoa Nancy Atmospera-Walch School of Nursing (NAWSON) and reports to its Dean, in addition to being guided by the Advisory Board. The Center is supported by the nurses of Hawai'i through the Center for Nursing Fee. These funds are deposited into a "special fund" account for Center use. In addition, the Center receives support for programs from our in-state schools of nursing, health care facilities across the state, and through grants and funding opportunities from state and national partners.

Over the 19 years that our Center has been in service to the state, we have consistently supported the state in its pursuit to ensure there are adequate number of nurses. In times like the present, where the inevitable retirements of our baby boomer population of nurses was compounded with the instability in the workforce due to COVID, the workforce data we produce, as well as the strategies, programs, and outcomes we deliver have increased value. Our work has facilitated both an increase in educational capacity across schools of nursing in Hawai'i, as well as increase in hiring of new graduate nurses, and far better retention rates for these nurses than for new graduates, nationally.

Workforce centers are valuable assets nationally and locally. HSCN has been in close conversations with the Daniel K. Inouye College of Pharmacy and commends their efforts to support their professional workforce through workforce assessment and planning efforts.

The mission of the Hawai'i State Center for Nursing is to engage in nursing workforce research, promote best practices and disseminate knowledge, cultivate a diverse and well–prepared workforce, support healthy work environments, champion lifelong learning, and strategically plan for sound nursing workforce policy.

I am writing to express the strong support of the Hawai'i Pharmacists Association for House Bill 2113, which proposes the establishment of a pharmacy special fund to create a Center for Pharmacy. We believe that the creation of such a center is not only timely, but essential in addressing critical issues facing our healthcare system and the pharmacy profession.

The proposed roles of the center, including funding 1.0 FTE to serve as the Executive Director for the Center for Pharmacy also include assisting in coordination pharmacy student loan repayment, collecting workforce assessment data, implementing retention initiatives for pharmacists and pharmacy technicians, as well as serving as an entity to coordinate progressive pharmacy practice initiatives, demonstrates a proactive and strategic approach to leveraging a profession that is currently underutilized in comparison to states across the country.

As we navigate through a transformative period in healthcare, characterized by a shift towards a value-based and team-based care model, it is imperative to recognize the indispensable role that pharmacists must play in patient outcomes and access to care. With shortages in various healthcare professions, leveraging the expertise of pharmacists becomes even more critical in ensuring comprehensive and accessible healthcare services for our communities.

The establishment of the pharmacy special fund and Center for Pharmacy would provide the necessary infrastructure to support pharmacists in fulfilling their expanded roles in healthcare. The Hawai'i Pharmacists Association has worked with the Board of Pharmacy and the Daniel K. Inouye School of Pharmacy to mimic the flow of funds that created similar centers for both nursing and medicine. Because of their respective centers, both nursing and medicine have a proactive role in finding innovative healthcare solutions. The Center for Pharmacy special fund is a profession driven, sustainable solution that matches the standard already granted to other healthcare professions in Hawai'i. The proposed allocation of funds will generate just over \$500,000 every two years.

Suggested amendments:

Section 2 340A – (c) Moneys-Monies (spelling correction) in the special fund shall be used to support the Daniel K. Inouye college of pharmacy's activities related to pharmacist workforce assessment and planning within the state <u>driven by the Center for Pharmacy.</u> Provided that the workforce assessment fees transferred and deposited in the special fund pursuant to section 461 – shall be used to support <u>1.0</u> <u>FTE for the Executive Director Position for the Center for Pharmacy</u>, pharmacist workforce and planning efforts, including the recruitment and retention of pharmacists, for rural and medically underserved areas of the state. These efforts will be included, but not limited to:

(1) Allocation of the special funds for 1.0 FTE to serve as the Executive Director for the Center for Pharmacy



- (2) Maintaining accurate pharmacist workforce assessment information and providing or updating personal and professional information, which shall be maintained in a secure data base
- (3) Providing loan repayment to pharmacists who commit to working in medically underserved areas of the State as part of the Hawai'i state loan repayment program administered by the Daniel K. Inouye school of pharmacy: concern for sufficient amount of funds specifically for loan repayment, but we would certainly expect the Center for Pharmacy to assist in creation of more desirable positions and progressive pharmacy practice opportunities in MUAs. There is already a state level loan repayment process for healthcare professionals in MUAs.
- (4) Provide scholarships to qualifying pharmacy students, to be determined by the Daniel K. Inouye college of pharmacy

Section 3: Pharmacist Workforce Assessment Fee to the "Center for Pharmacy Fee" (suggested amendment throughout the bill to create less confusion of utilization for the funds and remind renewing pharmacists of the Center as a resource).

Section 3 (b):

- (1) \$100* for each renewed license as a pharmacist
- (2) \$200* for each new or renewed wholesale prescription drug distributor license
- (3) \$200* for each new or renewed pharmacy permit under section 461-14; and
- (4) \$200* for each new or renewed permit under section 461-15

Request addition of another section to outline oversight and reporting requirements to appease concerns from multiple stakeholders:

SECTION XX: The Center for Pharmacy Advisory Board will consist of 10 members to ensure continued service and development of the pharmacy profession across various practice settings. Advisory board members will consist of the following members:

- 1. One professional representing the medical community
- 2. One professional representing the nursing community
- 3. The executive director or chairperson of the Board of Pharmacy
- 4. The President of the Hawai'i Pharmacists Association
- 5. The Dean of the Daniel K. Inouye School of Pharmacy
- 6. <u>Pharmacist practicing independent community pharmacist</u>
- 7. Pharmacist practicing hospital pharmacist
- 8. <u>Pharmacist practicing ambulatory care pharmacist</u>
- 9. <u>Pharmacist practicing neighbor island pharmacist</u>
- 10. Pharmacist practicing pharmacist, other setting

The Center for Pharmacy will provide an annual report to the DCCA and legislature, as desired.

Of note, even with increases, these are still amongst the lowest registration fees in the country. I urge the committee's support for HB2113, recognizing that the establishment of a Center for Pharmacy is a pivotal step towards ensuring the optimal utilization of pharmacists in our evolving healthcare landscape. The proposed initiatives align with the growing importance of pharmacy in patient-centered care and position our profession to be at the forefront of positive healthcare transformation.
