EXECUTIVE OFFICE ON EARLY LEARNING'S POSITION: Support Intent with Comments

The Executive Office on Early Learning (EOEL) supports the intent of H.B. No. 2591 and offers comments.

EOEL is committed to increasing access to affordable and high-quality early learning opportunities. Child care subsidies and tuition assistance programs, such as Preschool Open Doors (POD), help eligible families to afford child care and preschool tuition rates, alleviating the financial burden many families face when attempting to access early learning opportunities.

We are thankful to the Legislature for the significant investments made to the POD program through an appropriation of an additional \$38 million for the Executive Biennium Budget 2023-2025, made in the last legislative session. This appropriation, pursuant to Act 164, SLH 2023, provides nearly \$50 million dollars allocated to the Preschool Open Doors program, which will now serve 3- and 4-year-old children.

We look forward to continuing to work with the Legislature to support increasing access to quality early learning programs and services and the workforce in the State. Thank you for the opportunity to provide testimony on this measure.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the intent of this bill and provides comments.

<u>PURPOSE</u>: This bill appropriates moneys to the Department of Human Services for the Preschool Open Doors program. Declares that the appropriation exceeds the general fund expenditure ceiling.

Investing in early learning provides children the opportunity to be successful in school and gain that structured preschool experience so that they are better prepared for kindergarten. Notably, Act 164, Session Laws of Hawaii (SLH) 2023, (the executive budget bill) appropriated an additional recurring amount of \$38,800,000 to Program ID HMS 305 to fund subsidies for eligible families for preschool tuition through the Preschool Open Doors Program. This additional funding is already a part of the department's base budget; therefore, the department believes the current appropriation is sufficient at this time.

Further, Act 171, SLH 2023, expanded the Preschool Open Doors Program to include eligible three-year-old children.
