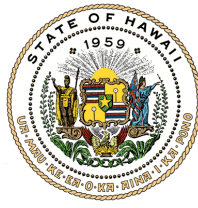

Chair Wakai, Vice Chair Elefante, and members of the Committee:

The Department of Law Enforcement (DLE) **strongly supports**, House Bill 2622, House Draft 1.

This bill appropriates moneys to the DLE to continue with the voluntary firearm buyback program.

The DLE would like to conduct voluntary firearm buyback programs in each county. The requested appropriation would be used to conduct the buybacks, storage and disposal of firearms, costs incurred by supporting agencies and partners, and administrative costs associated with the program.

The DLE recommends \$825,000 for the appropriation.

Comments:

I disagree with the assertion that Gun Buybacks work to reduce gun related crimes, and there has been no evidence to show as such, and for that reason I disagree with gun buybacks on principle, however I am not fully against buybacks as they can serve a legitimate purpose, however limited.

Typically a criminal will either dump, or sell their gun after using it in a crime to another criminal. There are even some criminal rings out there that treat firearms as if they're a rental service. Though some criminals have used buybacks as a means to dispose of evidence by turning in guns that are 'too hot' for them to resell.

There has also been some controversy about buybacks recently, where parts from firearms that were supposedly destroyed after a buyback were found intact after the contractor responsible disassembled the firearms and legally resold parts. This isn't counting other incidents where contractors and even law enforcement officers have stolen firearms, marked them as destroyed, then turned around and sold them intact on the black market.

In previous testimony on SB2346, specifically, in response to the issue of people making cheaply made ghost guns in order to take advantage of the turn in, the Department of Law Enforcement claimed they would not accept such firearms, which is counterintuitive since such weapons are still deadly and illegal under state law despite their crude nature. Through such an act of irresponsibility, public safety is impaired rather than enhanced.

The Department of Law Enforcement also testified that one officer at the buyback mentioned that some of the firearms turned in at the buyback were not only suitable for police use but were actually of the same make and model that they were in the process of buying and inquired if they could simply add the weapon to their armory. The officer in charge reluctantly said they could not keep the firearm due to the wording of the law.

During the recent buybacks on Oahu, people were waiting in their cars for long periods of time, backing up traffic on the road while officers processed the firearms. This also raises the possibility that if such buybacks become a regular thing, criminals might take advantage of a large number of unregistered guns concentrated in one area. They might either go car to car offering a larger amount of cash for the firearms, or simply take a risk and carjack someone waiting in line in the hopes of netting not only a vehicle but weapons as well. Despite the presence of police at the buyback, their presence was still minimal.

The only aspect of the bill that I can support is that the bill does offer a method for those who inherit firearms from a family member or loved one who have no idea what to do with them and conveniently provides a means to safely dispose of them. However, this often causes guns with historic provenance to be destroyed or be turned in for a petty fraction of what their worth is. Thus, I would like to propose the following changes:

1) Advertise and offer a year round turn in where the public can turn in firearms in their possession to their local Police Department's precinct, not the main headquarters. This reduces the distance people will have to travel since guns will be on the streets for a lesser duration of time and will only be on the road for a short distance. If not, everyone will be forced to be funneled to a remote location and may defer any desire for turn-in, thereby counteracting the point of the bill.

2) The Police Department will take custody of the firearms and check to make sure they were not stolen, prohibited, or connected to a past crime.

a) should the firearm in question be connected to a crime or is otherwise illegal, they will be given whatever the standard payout is for the firearm turn in and the Police will properly dispose of the firearm.

b) should the firearm in question be otherwise legal to sell, Police will maintain custody of the firearm and inform the individual that they may elect to have one or more Federal Firearms Licensee(s) (Gunstore) appraise the firearm for its value. If the Possessor elects to instead sell their firearm to an FFL, Police will turn over the firearm directly to the FFL and the FFL will pay the Possessor. If the Possessor does not wish to go through with the FFL transaction they will receive the standard payout.

3) Give some discretion to the responsible department regarding the fate of firearms, whether they be destroyed, retained by law enforcement or another City/State agency for use, offered as a donation to a museum, ect, or auctioned off for the legal gun market to raise funds.

I believe these suggestions would not only save taxpayer money, but also allow those who turn in firearms to get fair value for their property through private means.

I agree with the intent of this bill to give people an easy way to remove unwanted guns without fear of prosecution or interrogation. However I disagree with using taxpayer money to fund the program. In the Senate version SB2346, the Dept of Law Enforcement requested \$825,000 to administer this program. Although this is just a drop in the bucket for the State budget, it feels very excessive for a taxpayer such as myself. As seen in the recent Manoa family tragedy where a knife was used, the weapon is not the problem, it's the person who needs help. The \$825,000 per year could be better spent on mental health programs that target extreme people in need to prevent a tragedy like this from occurring in the future.

I understand that people want the peace of mind for letting the guns go and I feel that gift cards or other compensation is not necessary. I propose changes that accomplishes all of these things in a better way.

1. Allow gun stores to accept the firearms at anytime. This allows for convenient drop off of the firearms anywhere in the State and people would not being intimidated having to turn them into law enforcement.

2. The gun stores can offer to resell the firearm on consignment or turn them into police. This gives the stores the incentive to participate in the program while offering the person more money for their firearm and prevent destruction of a useful item. Or the person can just drop off the firearm with no questions asked and the gun store can then give the firearm to police.

I am writing to express my strong opposition to SB 2845, which seeks to ban the sale and possession of ammunition to individuals under the age of 21. While I understand the importance of firearm safety and regulation, I believe that this bill is both unconstitutional and unnecessary.

Instead of targeting law-abiding individuals who pose no threat to public safety, our efforts should be directed towards implementing evidence-based solutions that address the root causes of gun violence, such as mental health issues, socioeconomic disparities, and illegal firearm trafficking.

In conclusion, I urge you to reject SB 2845 and explore alternative strategies that respect the constitutional rights of individuals under the age of 21 while promoting responsible firearm ownership and safety.
