Aloha Chair Ichiyama, Vice Chair Poepoe, & Committee Members,

My name is Dave Mulinix, Co-Founder and Statewide Organizer for the Hawaii State Chapter of Greenpeace, the largest environmental organization in the world, with an international membership of over 3 million. On behalf of Greenpeace Hawaii's thousands of members and supporters statewide we stand in STRONG SUPPORT of HR74/HCR88, that encourages the state of Hawaii to adopt a proposed constitutional amendment, and the electorate to ratify the proposed amendment, guaranteeing all individuals the right to a clean and healthy environment.

Passage of HR74/HCR88 is important because adding an environmental rights amendment to a state constitution's Bill of Rights guarantees its citizens the inalienable right to a healthy environment, climate, clean air, and clean water. Our current laws and protections aren't working. Corporate for-profit institutions with their heavy influence in government have continually blocked efforts to protect our community from environmental degradation and climate breakdown. Placement in Article I ensures environmental rights are protected on par with other fundamental rights and ensures fair balancing of rights when needed.

Finally, some Hawaii officials have expressed concerns that an environmental amendment might spur frivolous lawsuits. Such concerns are unsupported by the law or facts. There hasn't been a proliferation of inappropriate litigation relying on constitutional environmental rights in the three states where communities already enjoy environmental right protection. Rather, the lawsuits brought have been important and reasonable and have helped protect air, water, soil, human health, and to support the proper interpretation of environmental laws passed by state government. The environmental amendments in Pennsylvania, Montana and New York have not only been relied upon by communities to secure essential environmental protections otherwise being overlooked, but have also been used by state regulatory agencies, attorneys general, and local government bodies to protect their own environmental authority and their ability to pursue environmental protections they have identified as being of primary importance. In fact, there is no litigation that has been dismissed as frivolous because of an environmental amendment claim. Most often, their environmental amendment protections have been brought forth to help government officials and the courts properly interpret, apply and enforce the environmental laws and regulations that are already on the books, as opposed to being free-standing challenges to government overreach.

In closing, ensuring environmental rights protection will, by its nature, strengthen property rights protection because too often pollution migrates onto the property of others. The complement of property rights with environmental rights will allow us to better protect the sanctity of families and homes.

Please pass HR74/HCR88 towards protecting and ensuring our rights to a clean healthy environment.
