Comments:

I support SCR68 in implementing the Hawaiian language in our Dept of Education and hiring Hawaiian speaking teachers. It's been far too long since Hawaii's own language was part of the curriculum in our own schools. The kupuna program supported youth in understanding some Hawaiian ways, but was not enough to get the full understanding of our own culture.

Colonization in every state system tried to obliterate the Hawaiian culture, because only then our systems could be run like the continent in Western thinking. But our roots come mostly from Asian countries with a different way of living, philosophies, and spirirtualism that can be seen in migration patterns from what is called the Far East. Books and history was written with only one perspective and only during the pandemic new truths could be translated from the indigenous groups around the Pacific Rim and around the world. Tahitians say they came from Havaiki, or Hawaii, not what was told in Western writings that Hawaiians came from Tahiti. In Marco Polo's 1435 map held in China, there were clumps of islands jutting out into the ocean from the Bering Strait. Proof that Hawaii, not the Sandwich Islands, were here before we were discovered by Capt. Cook. The Polynesians were sailing in their voyaging canoes across the Pacific Ocean before the European man even learned that the world was round.

Hawaii became the most literate country by 1870s, only 50 years after the arrival of the missionaries. The Hawaiian language should be one of the main languages taught in our schools before colonization, like other countries in the world, who are bilingual. Those who choose to speak their own language should return elsewhere, because they are only using our precious resources and not supporting our communities by not knowing how to do clerical duties such as writing letters or even giving speeches in public. In most of my volunteer and work experiences in business entities, people who were not raised locally only cared that they were taking money home and didn't understand their responsibility to society. Funds need to reach the people of Hawaii and by teaching Hawaiian in schools, those born and raised here may better understand their purpose in life.

As a former part-time DOE elementary school teacher in Central and Honolulu districts in 1986-89 I taught those that needed extra help in English and Math and a year at Queen Liliuokalani Elementary as a Second Language English Proficiency teacher. There were no Hawaiian siblings to teach because of the influence of colonization. But there were two siblings each from Japan, China, Thailand, Korea, Philippines and Truuk Islands. One of the siblings usually clarified my lessons to the other on subjects such as: U.S. holidays, cooking demonstrations, reading maps, directories, and using a rotary phone and how to get resources

from the library. My students would go home and teach their parents, but only a few parents extended their education to know more than their children. Those who did not speak and practice English did not fully grasp our culture and the meaning of being an American citizen.

Please support SCR68. Mahalo Senator Shimabukuro and Senator Fevella for creating this important bill!
