RiseHI Foundation has been a successful Hawaii nonprofit for over six years now, focused on primarily Hawaii's Title I schools. RiseHI provides mentorship to students to build essential life skills - fostering resilience, creativity, and a strong sense of community. The mentorship provided encourages emotional learning, significantly builds self-confidence, and empowers our students to identify and pursue life goals. RiseHI's program "Make it Happen" is curriculum tailored for grades 6-9. For slightly older students, RiseHI's Future Career Planning program - 'Oihana Career Exploration Courses – introduces students to detailed information about potential careers in Hawaii, and helps them to focus on future education and career planning. RiseHI has been embraced by Hawaii schools because of both the effectiveness of the curriculum, and the low cost, which remains at \$40 or less annually per student for high quality materials and state-of-the-art video class support. Current participating schools include: Kapa'a Middle School, Niu Valley Middle School, Kalama Intermediate, Ilima Intermediate, St. Louis School, Waimea High School, Aiea High School, and Maui High School.

This GIA application is written primarily to produce the materials needed to expand classes to additional schools that are excited about the program, thereby making these resources available to students across the state.

I. Introduction

RiseHI's "Make IT Happen" curriculum, adapted for middle schools in Hawai'i, offers an innovative approach to supplement Advisory classes, focusing on social-emotional learning and positive mindset development. This engaging program uses real-life examples from local entrepreneurs and community changemakers to inspire students, encouraging them to visualize their futures, overcome challenges, and embrace their unique paths. The curriculum is designed to equip students with essential life skills, encouraging resilience, creativity, and a strong sense of community, fostering personal and academic growth.

II. About RiseHI

RiseHI's mission is to cultivate equity and access in education by leveraging the powerful stories of kama'āina leaders and changemakers. This initiative aims to inspire and empower Hawai'i's keiki, bridging geographical and socioeconomic divides to offer every child the opportunity to see and realize their potential. By providing a platform that democratizes access to influential kama'āina narratives and resources, we are committed to expanding the horizons of our youth, enabling them to thrive and innovate within their communities in Hawai'i. Our vision is to unlock the untapped potential of the keiki, fostering a transformative impact on their perceptions of opportunity and self-capability.

Established in 2016, RiseHI is a 501c(3) nonprofit organization based in Hawai'i. Committed to enriching the educational experience and sparking inspiration among Hawai'i's keiki, RiseHI has been instrumental in enhancing curricula across various schools in Hawai'i, including Waimea High School, Maui High School, Kealakehe Intermediate, Niu Valley Middle School, Kapa'a Middle School, Saint Louis School and UH West 'Oahu.

III. "Make IT Happen" Program Details

The "Make IT Happen" curriculum and framework was developed for 6th-9th graders and designed as a comprehensive, eight-module program, spanning from 24 - 32 weeks, with each module dedicated to a specific theme:

This structure aims to create a multisensory learning experience, fostering a deep understanding of key life skills and social-emotional competencies.

A distinguishing feature of the "Make IT Happen" curriculum is its incorporation of video case studies featuring 24 esteemed kama'āina from diverse fields. These individuals, ranging from artists and chefs to entrepreneurs and environmentalists, share their personal journeys of conceiving ideas and overcoming challenges to realize their visions. Each story is captured in an engaging 5-7 minute video, bringing these narratives vividly to life.

This foundational approach fosters not only academic success but also the well-being and personal development of each student, preparing them for a successful transition into high school and beyond.



V. Desired Outcomes Per Module

1. Service Summary

RiseHI seeks to advance educational equity and inspire Hawai'i's youth through two very successful flagship curriculum initiatives: (1) the 'Oihana Career Exploration Courses and (2) the Make IT Happen program. With the support of this Grant-in-Aid, RiseHI will implement a transformative learning experience designed to empower middle and high school students by exposing them to diverse career pathways and fostering essential life skills.

The 'Oihana Career Exploration Courses aim to connect students in grades 7-12 to local industries and role models through interactive, online courses. Each course offers an immersive exploration of professions vital to Hawai'i's economy, such as construction management, healthcare, and entrepreneurship. By providing a platform that bridges the gap between classroom education and real-world application, we aim to inspire students to envision and pursue meaningful careers in their communities. The project includes the development and dissemination of nine career pathway courses in the first year, with a goal to expand to 80 courses by 2026, covering the Hawai'i Department of Education's 13 CTE pathways.

The Make IT Happen Curriculum complements this effort by integrating social-emotional learning and personal development into middle school advisory classes. Featuring eight modules, including "Visualize Your Future" and "Perseverance to See It Through," this program equips students with critical skills such as goal setting, resilience, and creative problem-solving. Anchored in the stories of kama'āina changemakers, it inspires students to embrace their cultural identity and take actionable steps toward their aspirations.

2. Outcomes & Measures of Effectiveness:

- Increased student awareness of local career opportunities and pathways.
- Strengthened life skills and social-emotional competencies, as evidenced by pre- and post-program surveys.
- Enhanced alignment between educational content and Hawai'i's economic needs, demonstrated by student participation and feedback metrics.

Together, these initiatives will foster a generation of confident, culturally grounded, and community-minded individuals prepared to lead Hawai'i into a brighter future.





With 2,000 or more students enrolled, we can provide a true "Proof of Concept" for a thorough evaluation by the Hawaii Department of Education, and demonstrate what we have already seen – overwhelmingly positive results, excited teachers and students, and a carefully planned program that can be delivered to each of Hawaii's public school students for an annual cost that is less than providing school lunch for the same student for two weeks.
