1. A brief description of the applicant's background;

The Waimānalo Health Center (WHC) WHC is a community-based non-profit 501(c)3 incorporated in 1989 and located in Waimānalo on the windward side of the island of Oʻahu. As its mission states, "Waimānalo Health Center is rooted in Native Hawaiian values and devoted to improving the health and wellness of all people, regardless of ability to pay, by providing comprehensive primary and preventive health care services of the highest quality." WHC became a Federally Qualified Health Center (FQHC) in 1994.

The Waimānalo Health Center offers a wide range of services:

- Medical Care: Physicians and Advanced Practice Registered Nurses provide patients with routine and preventive health care.
- **Behavioral Health:** Through individualized therapy and group classes, Licensed Clinical Psychologists assist patients with anxiety and depression, chronic pain,

chronic disease management, smoking cessation, stress and anger management and recovery from trauma and abuse.

- Dental: Routine and preventive screening along with emergency dental care are provided at WHC by four Dentists, three Dental Hygienists, and a dental residency program.
- **Vision:** Comprehensive eye exams, preventive vision care, diagnosis and treatment of eye diseases, and optical dispensing are provided by an Optometrist through this clinic.
- Nutrition: Medical nutrition therapy is provided by a Registered Dietitian. Preventive health classes include cooking demonstrations, grocery store tours and weight management. WIC services are also available for families which include breastfeeding support and education provided by Certified Lactation Consultants.
- Native Hawaiian Healing: Ma'iola department provides lomilomi and lā'au lapa'au services to patients in primary care. Plants for these services and a Hānai A Plant program are grown and harvested from the Māla Ho'ōla, a 6,905 square foot cultural healing garden with over 400 plants. Their Ho'olu'olu clinic provides the above services, including no'ono'pono for patients with chronic pain.
- Care Management: High risk, high complex patients referred by primary care or behavioral health are are provided individual care management services in order to improve outcomes or reduce healthcare costs.
- Outreach & Eligibility: Outreach and eligibility workers help reduce barriers to care and assist patients with access to services including: health insurance eligibility, acquiring prescription medication, transportation, assistance with housing, rent, and applications for food stamps and financial assistance, and voter registration.
- **Pharmacy:** Opened in 2020 to fill prescriptions and provide over-the-counter medications, medication counseling and education, and immunizations. The pharmacy also provides a mail order prescription service.
- Youth Mentoring: Kū I Ka Māna, a youth mentoring program, provides an environment for youth to learn about themselves, build character, stay in school, graduate high school, and move on to post-secondary education.
- School Based Health Clinic: A school based health clinic at Waimanalo Elementary and Intermediate School was just initiated to provide primary care, behavioral health services, and health education.
- Mobile Medicine: Delivers medical and support services to houseless individuals and families in Koʻolaupoko in order to reduce emergency room visits and hospitalizations and establish individuals with medical insurance and a patient centered healthcare home.

• Dr. Charman J. Akina Memorial Scholarship: Administered by the Hawai'i Community Foundation and established by WHC with the generosity of foundation donors in memory of Dr. Akina for his countless volunteer hours to help the Waimānalo community and for his impactful service to WHC. The scholarship is open to residents of Waimānalo with demonstrated financial need to attend an accredited two or four year, not for profit institution within the U.S. as an undergraduate, with a 2.7 GPA. Preference is given to KIKM program participants.

Waimānalo Health Center was awarded recognition by the National Committee for Quality Assurance as a Patient Centered Medical Home Level 3 (PCMH-3), the highest achievable recognition for a healthcare provider, with Distinction in Behavioral Health Integration. WHC was the first community health center on O`ahu to be awarded PCMH-3. This recognition acknowledges the quality work that WHC provides as WHC passed all elements of this achievement with 100% satisfaction.

2. The goals and objectives related to the request;

With support from the State of Hawai`i, WHC plans to support the Patient-Centered Health Care Home (PCHCH) approach to providing comprehensive health services to the underserved population of Waimānalo through improvements to its information technology infrastructure. The proposed project would support increased access to comprehensive health services, improved patient experience and cybersecurity enhancements.

The recent construction of WHC's expansion facility allows WHC to continue to meet the growing needs of the community. Further expansion of its information technology infrastructure will support WHC's efforts to continue to serve the underserved community of Waimānalo as well as individuals and families from the entire Koʻolaupoko coast.

3. The public purpose and need to be served;

Access to quality primary and preventive health care results in improved health status of a community and enhances the quality of life for its residents. There are a number of key factors that contribute to the health needs of the Waimānalo community:

Shortage of Healthcare Providers

The Waimānalo community is a federally designated Health Professions Shortage Area (HPSA). In addition, WHC is the only health provider in the Koʻolaupoko area with the FQHC designation, seeing all patients regardless of ability to pay. As the only dental provider in Waimānalo, WHC's HPSA score for dental is 16. WHC specializes in providing comprehensive care to the uninsured and underinsured in the community.

Historically, WHC's target population is quite complex with a plethora of social service and health needs.

Increased Demand for Services

Table 1 illustrates a 10-year trend (2010 to 2020) and the growing needs of WHC's patient population.

As highlighted above, WHC experienced a 24% increase in patient visits over 10 years. In 2010, 31% of patients were uninsured and 64% were at or below 100% of the federal poverty level. In 2020, demographics have improved with 15% uninsured and 48% at or below 100% of the federal poverty level.

In 2023, the most recent year data is available, WHC saw 5,690 patients through 28,140 patient visits. This is a 9% increase from 2020.

Vulnerable Populations Served

Due to its large proportion of Native Hawaiian residents, Waimānalo has a federal designation as a Medically Underserved Population. In addition to the socioeconomic challenges and barriers to health care prevalent with the population served, chronic diseases are overwhelmingly represented in the Native Hawaiian population. Specifically, Native Hawaiians have higher rates of diabetes and obesity than other ethnic groups in Hawai'i. Also, in comparison to other ethnic groups, Native Hawaiians have high rates of depression and substance abuse.

WHC's Board of Directors and key leadership recognize that the most vulnerable populations will remain underserved if actions are not taken to expand WHC's ability to provide quality care that optimizes health outcomes. Since 2010, the WHC strategic plan called for meeting increasing community needs by building expanded infrastructure, and accordingly, overall organizational capacity.

4. Describe the target population to be served; and

Due to its large proportion of Native Hawaiian residents, Waimānalo has a federal designation as a Medically Underserved Population. In addition to the socioeconomic challenges and barriers to health care prevalent with the population served, chronic

diseases are overwhelmingly represented in the Native Hawaiian population. Native Hawaiians have higher rates of diabetes and obesity than other ethnic groups in Hawaii.

Specifically, Native Hawaiians have high rates of being overweight and obese (72.4% of adults), compared to the State rate of 58.4%. The concerning rates for adults are mirrored in the youth population, with 31.2% of Native Hawaiian public middle school children reported to be overweight or obese, and 38.9% of public high school students, as compared to students across Hawaiii at 26.2% and 30.8% respectively¹.

The prevalence of diabetes in Native Hawaiian adults is 13.7%, compared to 9.4% for the State. There is an increase from prior years specifically for Native Hawaiians, as in 2014, the prevalence was 12.8% for Native Hawaiians and 9.7% in the State. Native Hawaiians are on an upward trend with a 7% increase in Native Hawaiian adults diagnosed with diabetes, while the State showed a decrease of 3%.

High rates of tobacco use also contributes to the health disparities amongst Native Hawaiians. Native Hawaiians have high rates of tobacco use with 17.2% of current smokers, compared to the State rate of 12.2%. This shows improvement over the past years, down from 2014 rates of 27% for Native Hawaiians and 14.1% for the State. Similarly, there are higher rates of pregnant Native Hawaiian women smoking 3 months before (17.1%), during (8.1%), and 3-6 months after pregnancy (9.2%), Comparatively, the State rates of smoking for pregnant and postpartum women are significantly lower, smoking 3 months before (9.6%), during (3%), and 3-6 months after pregnancy (4.1%).

High blood pressure also contributes to the health disparities amongst Native Hawaiians, with 34.9% of Native Hawaiian adults with high blood pressure, compared to 27.4% in the State. Showing an upward trend similar to diabetes, the prevalence of high blood pressure in Native Hawaiians in 2013 was 29.7%, while the State prevalence was 28.5%. 18% increase for Native Hawaiians over the past decade, while the State prevalence has decreased by 4%.

In addition to the high prevalence of chronic diseases, substance abuse prevention and treatment is a need. In 2019, alcohol or marijuana use in high schools among Native Hawaiians was 40.8%, significantly higher than the State rate of 28.9%. Similarly, 50.5% of Native Hawaiian youth reported using illicit drugs, higher than the State rate of 39%.

The mental health needs for Native Hawaiians are also dire. 15.3% of Native Hawaiian adults have been diagnosed with depressive disorder, higher than the State rate of 12.8%.

While 33.8% of Native Hawaiian youth reported experiencing depression in the past 12 months, 12.2% attempted suicide and 15.9% made a suicide plan.

5. Describe the geographic coverage.

Waimānalo Health Center primarily serves the underserved geographic area of Waimānalo on the Windward side of the island of Oʻahu, nestled between the Koʻolau Mountains to the south and the Pacific Ocean to the north, and along the only two-lane highway through the community. WHC's entire service area stretches along the northeastern coast of windward Oʻahu, or Koʻolaupoko, from Makapuʻu Point to Kualoa State Park. There are three man-made tunnels through the Koʻolau mountains that windward Oʻahu residents use to access downtown Honolulu; otherwise, individuals would have to traverse around the mountain range via the southeast tip of Windward Oʻahu, or Makapuʻu, or via the North Shore of the northern tip of Windward Oʻahu through Koʻolauloa. The Koʻolaupoko area consists of many white sand beaches and several lush valleys that extend inland to the steep face of the Koʻolau pali, or cliff. The area includes the towns of Waimānalo (96795), Kailua (96734), and Kāneʻohe (96744), with an estimated population of 118,732.²

Although WHC serves patients representing all areas of the island, community-based efforts focus on the large Native Hawaiian population of Waimānalo. This area includes 7,249 Waimānalo residents³ who are Native Hawaiian or part-Hawaiian, approximately 66% of the population of Waimānalo. Waimānalo represents one of the most concentrated areas of Hawaiians in the state. Although this number reflects individuals who reside in the area, many more who reside in neighboring communities consider Waimānalo their home and have special cultural and family ties to Waimānalo.

III. Service Summary and Outcomes

With the support of the State of Hawai`i, Waimānalo Health Center plans to support the Patient-Centered Health Care Home (PCHCH) approach to providing comprehensive health services to the underserved population of Waimānalo.. The Waimānalo Health Center is requesting \$500,000 to significantly enhance its capacity to address the needs of the Waimanalo community through improved access to and quality of care through improvements to its information technology infrastructure.

The proposed project would allow WHC to address issues that impact WHC's ability to enhance its patient-centered medical home approach as well as increase its ability to

expand its patient capacity. Highlighted below are areas that would result in improved service to the community:

- **Expansion of Services**: The proposed project would expand existing health services in this population through an improved electronic health records system. Improved electronic and online efficiencies will allow easy access to health services for patients and also ensure personal health information is protected.
- Full Integration and Improved Efficiences of Services: The project would enhance WHC's ability to reach its most vulnerable populations including the disabled, kūpuna and those without transportation to services. The proposed workflow would provide full integration impacting WHC's ability to effectively utilize its team-based care approach. With current services across three campuses, improved infrastructure efficiencies will ensure seamless, integrated care. Security, patient privacy, electronic health records and technology advancement issues will be more efficiently addressed with the expansion facility.
- 2. Provide a projected annual timeline for accomplishing the results or outcomes of the service:

Timeline for the proposed project will include:

Phase 1 - Due Diligence

WHC has completed the following activities in anticipation of the proposed project:

- Preliminary philanthropic assessment to determine the fundraising feasibility of the project
- Review project with key management staff to determine site preparation, impact on existing services, etc.
- Preliminary research of vendors and features for the proposed project
- Receipt of preliminary proposals and quotes from prospected vendors

Phase 2 – Planning

With approval to proceed from the WHC Board of Directors and Executive Leadership, WHC initiated communication with a proposed vendor. The project team has engaged with the vendor to determine the scope of the project, timeline for completion, assess any anticipated challenges to implementation, conduct an analysis of programmatic needs, executing the vendor contract, etc. This process is ongoing.

Phase 3 – Implementation

During Phase 3, WHC will contract with the vendor to implement the project including transferring patient data to a new electronic health records system, installing needed hardware and equipment to ensure the system runs optimally, training personnel on features of the proposed system including online registration, patient portal, etc.

During Phase 4, all systems for the proposed project will be installed and implemented and WHC will ensure the systems are functioning optimally.

Waimānalo Health Center's <u>unrestricted</u> current assets as of December 31, 2022, are \$12,234,505 This amount is from all cash accounts and receivables less an allowance for bad debt.

WHC possesses the expertise to successfully plan and complete the proposed projects. Below are some related capital projects WHC has successfully executed:

- 2023 Hale Ola 'Akolu Luluku \$500,000 In March 2023, WHC opened an expansion dental clinic in Kāne'ohe with private funding through HDS Foundation and other donors as well as internal funds. WHC renovated an existing dental clinic with upgrades to equipment and information technology infrastructure.
- 2017-2019 Hale Ola `Alua Medical Expansion Building \$13,000,000 In May 2019, WHC opened its 19,542 square foot expansion facility with \$1,000,000 grant award from HRSA and numerous other contributions from government agencies, foundations and private donors. Although construction for this project started in 2017, planning started in 2013 with the creation of a facilities master plan, philanthropic market assessment and a fundraising infrastructure assessment.
- O 2013 WIC Renovations \$324,795 Through funding from the US Department of Agriculture and the State of Hawaii WIC program, WHC renovated an existing Head Start preschool site to WIC services. The renovations included the creation of two private offices and a breastfeeding/education room; installation of new flooring, doors and windows; installation of air conditioning units; renovations to the deck areas; creation of two family restrooms; etc...
- 2013 Vision Services Expansion \$143,207 WHC's vision services expansion included the purchase and installation of major vision equipment totalling over \$89,000. This expansion was funded by WHC and a National Association of Community Health Center Covidien Challenge Grant.
- 2009 Dental Health Services Expansion \$442,083 In March 2009, WHC completed an expansion to oral health services which included renovations along

with major dental equipment purchases and installation. The first dental patients were seen in April 2009.

Service expansion is a major WHC strategic initiative with full support of the WHC Board of Directors and will follow similar structure for leadership engagement and careful monitoring of the budget, timelines and results.

2. Facilities

Waimānalo Health Center will provide services at two campuses which are located in close proximity to each other. The original campus at 41-1347 Kalaniana`ole Highway is referred to Hale Ola `Akahi and Hale Ola `Alua located at 41-1295 Kalaniana`ole Highway is the medical facility that opened in 2019. Hale Ola `Alua is a 2-story facility houses most patient services including medical services, behavioral health services, community services, integrated cultural healing services, to name a few. Hale Ola 'Akahi includes oral health services, WIC, health promotions and diseases prevention, etc. Both properties are on the bus line and across from Waimānalo Elementary and Intermediate School (WEIS). WHC initiated a school based health clinic in January 2025 at WEIS. WHC will also provide dental services in Kāne'ohe at 45-600 Kamehameha Highway. This renovated space is located conveniently along the busline with ample parking on-site.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

Since 2010, the WHC strategic plan called for meeting increasing community needs by building expanded facilities, and accordingly, overall organizational capacity. WHC's Board of Directors and key leadership recognize that the most vulnerable populations will remain underserved if actions are not taken to expand WHC's ability to provide quality care that optimizes health outcomes.

WHC's executive leadership have the management skills and expertise to oversee the construction project while still administering quality health care for the community of Waimānalo and the rest of Koolaupoko. Leading the project will be WHC's Chief Executive Officer:

 Chief Executive Officer: Mary Frances Oneha, APRN, PhDwho has been with WHC for 12 years and lead, the construction of the 19,000 square foot medical expansion facility which opened in 2019. She will also lead the construction of a 5,000 sf dental expansion facility 2025-2026.

Funding from the State of Hawai'i is instrumental in successfully executing the proposed expansion of services. WHC's total annual operating expense budget is expected to increase as a result of the expansion of services. WHC is demonstrating growth currently and will continue to grow in its new facility. Within the existing site, the improved access to care particularly through dental services, will result in additional revenue. WHC assists uninsured patients with acquiring and maintaining public health insurance which results in paid visits in addition to improving health outcomes of these patients. In addition, WHC's PPS reimbursement rate per Medicaid Patient Visit has also increased in recent years.

As a result of additional fund development efforts, fundraising efforts have been enhanced because of increased infrastructure capacity in the development department and relationships sustained as a result of the previous endeavors. The increase in communication and first-time contributions for the campaign will begin lifelong relationships with individuals, corporations and businesses.

(b) Not received by the applicant thereafter.

Funding from the State of Hawai'i is instrumental in successfully executing the proposed facility expansion. If the State of Hawai'i does not support the proposed project, WHC will continue with its plan to strategically secure resources for the project both from the public and private sector.

Without support from the State of Hawai'i, the proposed project will be delayed until private sources of funding are secured.


In addition to delaying the project, WHC may also determine if plans may need to be scaled back resulting in loss of expanded services for patients.
