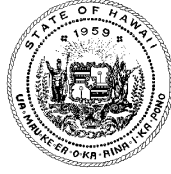

REPORT TO THE 2025 LEGISLATURE

AS REQUIRED BY ACT 57,
SESSION LAWS OF HAWAII 2019

**Department of Human Resources Development
December 2024**

Background

The Department of Human Resources Development's (DHRD) mission is to provide timely and responsive leadership, resources, and services to fully support the State of Hawai'i in the recruitment, management, and retention of a high-performing workforce based on the merit principle as defined by [HRS §76-1](#).

Act 57, Session Laws of Hawai'i 2019, as amended by Act 151, Session Laws of Hawai'i 2023, states the Director of the Department of Human Resources Development shall:

1. Facilitate and expedite the hiring and recruitment for civil service positions under the jurisdiction of the department of human resources development; and
2. Have the authority to reclassify and abolish vacant positions within state departments and agencies that are under the jurisdiction of the department of human resources development, subject to the following conditions:
 - a. Prior to reclassifying or abolishing any vacant position as provided under this paragraph, the director shall submit a report to the legislature no later than twenty days prior to each regular session. The report shall include a list of vacant positions for reclassification or abolishment, identify the agency each position is attached to, provide reasons for reclassifying or abolishing the position, and state the duration the position has been vacant; and
 - b. The director may reclassify or abolish any vacant position as provided under this paragraph no earlier than sixty days after the report has been submitted to the legislature as provided under this paragraph.

The inaugural report was submitted to the 2020 Legislature. No actions were taken to reclassify or abolish any positions in that report to establish a baseline assessment of the current situation and challenges among departments in the State of Hawai'i Executive Branch.

The report submitted to the 2021 Legislature identified and recommended that 46 positions vacant prior to 2011 be abolished. Three of those were abolished in the budget. The report to the 2022 Legislature identified and recommended 63 positions, which had been vacant five years or more, for abolishment. One position was abolished by the Legislature. The 2023 Legislature received the annual report that identified 131 positions, which had been vacant for five years or more, for abolishment. The Legislature abolished five of the recommended positions. The 2024 Report to the Legislature recommended 115 vacancies, which had been vacant for four years or more, for abolishment. Of those 115, four were abolished in Act 230, SLH 2024.

Civil Service Vacancy Statistics

DHRD continues to recruit and screen applications for the Executive Branch agencies and to assist them with filling their department vacancies. Table 1 provides the recent years' vacancy data for the Executive Branch.

DHRD averages about 500 open recruitments on any given day. In the last four years, DHRD Employee Staffing Division (ESD) Recruitment, Certification and Examination total employees have increased from 13 to 18 by filling vacancies. Like many other employers, COVID-19 had a huge impact on the State's workforce. Coming out of the pandemic and the 2020 Executive Branch hiring freeze, State departments were eager to fill their vacancies. A simple comparison of recruitment statistics from pre-COVID, in 2020,

compared to 2024, highlights the tremendous growth in recruitment efforts over the last four years.

- Civil service recruitments increased 55%, from 460 to 712;
- Applications received grew 89%, from 15,971 to 30,131;
- Applications screened increased 97%, from 12,800 to 25,217;
- Certified lists issued to departments jumped 301%, from 1,122 to 4,503; and
- Qualified eligibles referred to departments surged 294%, from 13,302 to 52,370.

While DHRD referred more than 52,000 qualified applications (some applicants were referred to more than one job vacancy) in one year, ESD has been seeing this trending upwards each year since the end of the pandemic. However, despite receiving 52,000 eligible candidates, departments filled 66% of requisitions this year, up from 44% four years ago. Requests to fill increased 60%, from 896 to 1,435, with the number of new hires filling positions rising 147%, from 393 to 969.

The increase in eligible candidates does not directly correlate with improved vacancy filling rates, suggesting that departments may be facing challenges in selecting suitable candidates or that job descriptions are not aligned with the available talent pool.

As expected, the sheer volume of the number of applications received and requests to fill vacancies has kept DHRD recruitment staff busy. DHRD has been fortunate to fill vacancies in ESD but is still working to return to pre-pandemic staffing levels. Additionally, with the hiring of new employees comes the necessary training period, thus working through increased numbers of applications will take some time. As ESD employees are fully trained, and DHRD fills the newest group of recruitment positions authorized in 2024, DHRD expects to make swift improvements in processing applications and augmenting efforts with the use of technology to enhance the efficiency of the recruitment process.

Non-Civil Service (Exempt) Vacancy Statistics

In addition to the state civil service classes, Departments are authorized to establish and fill positions that are exempt from civil service, pursuant to HRS §76-16. Table 3 provides data on departments exempt position counts and their vacancy rate as of November 1, 2024.

Statewide Movement

DHRD tracks the movements of employees in, within, or out of a department. Each “move out” creates a vacancy within the state workforce. Table 4 shows the statewide count of the various types of moves out from FY17 through FY24 for all Executive Branch departments, excluding the Department of Education and University of Hawai’i.

- Moves Within Department are transfers or promotions to permanent civil service positions. This also includes movements from temporary/exempt/89-day hire appointments into permanent, civil service positions.
- Moves Out of Department means the employee moved to a different position in a different department.
- Retirements are self-explanatory but include reasons such as Voluntary Retirement (381), Dishonesty (5), and Ordinary Disability (1).
- Terminations include both voluntary and in-voluntary terminations, including individuals who have left state government for other opportunities. The most common reasons for leaving include Personal Reasons (219), Other Reasons/Unknown (208), Other Employment Private (80), Other Jurisdiction (76), Discharge (44), Accept Exempt Position (39), Death (33), Work for City & County of Honolulu (19), and Health Reasons (12).

Of the 1,146 individuals who left state employment through termination or retirement in FY24, one person was dissatisfied with their pay, one person was dissatisfied with their hours, and two people were dissatisfied with their supervisor. A detailed breakout of the explanation of reasons that employees left state government can be found in Appendix A.

Table 4: Statewide Types of Turnover and Moves Out from FY17 – FY24

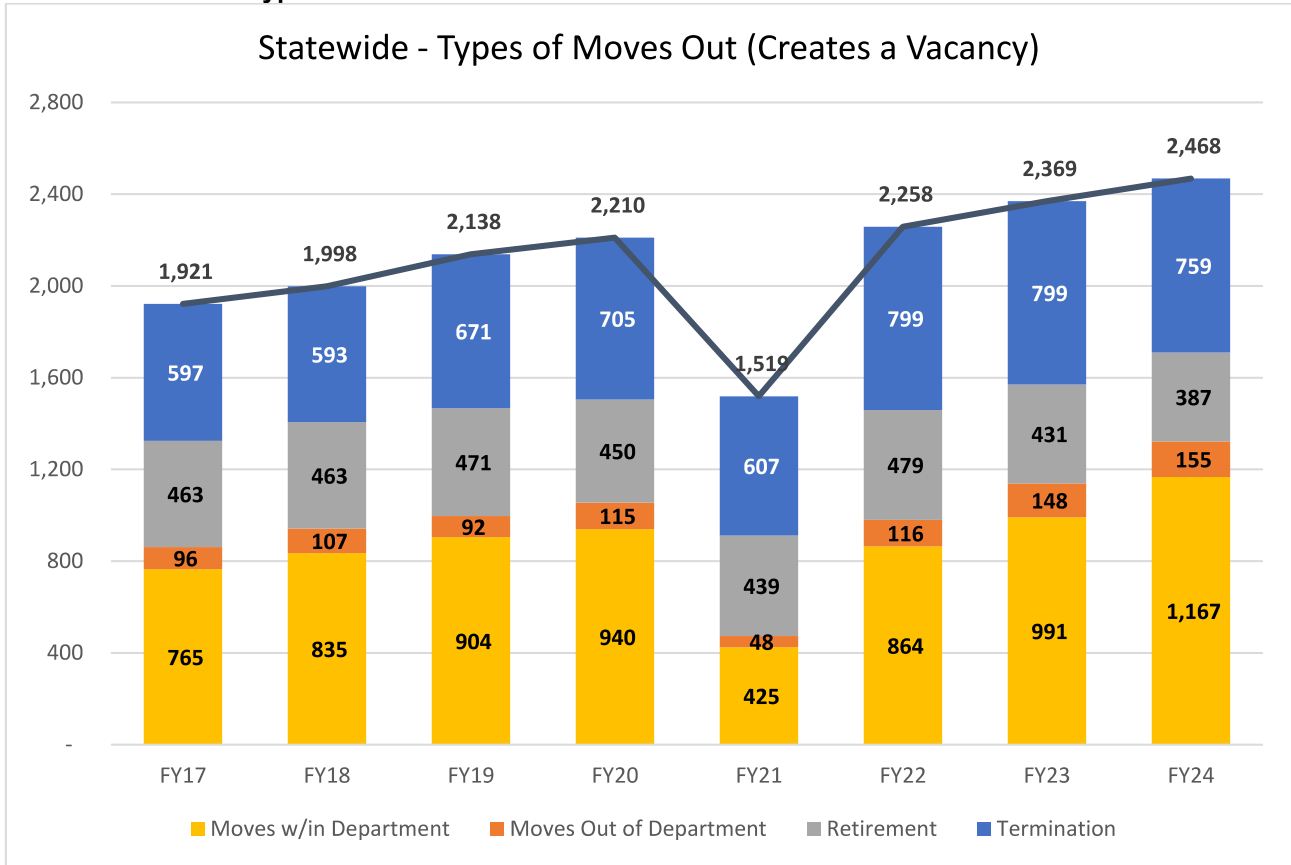
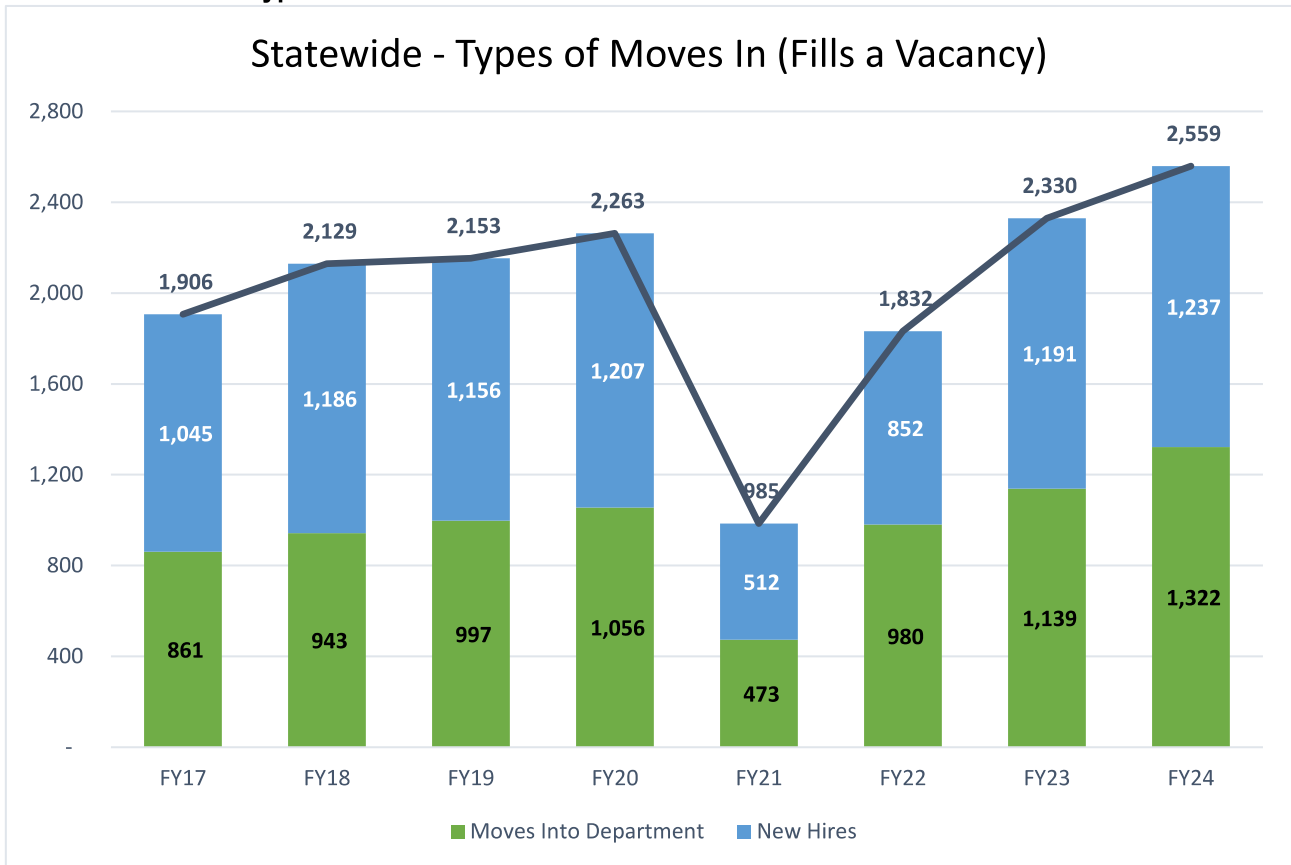


Table 5: Statewide Types of Moves Into and New Hires from FY17 – FY24



State employees often transfer to a different department for professional growth or a higher paying position. The movements in Table 5 fill a vacancy and show the statewide total of types of moves into a department, either from the same department or different department, and new hires from FY17 to FY24.

The substantial dip in FY21 is attributed to the hiring freeze for funded civil service positions imposed by Governor David Ige, which was in place from April 2020 through July 2021, per [Executive Memorandum 20-01](#).

The State is finally seeing a net increase in positions being filled; something that hasn't happened since FY20, prior to the COVID-19 pandemic. Thus, the decrease in the statewide vacancy rate this year. The breakout of moves in and out by department can be found in Appendix B.

Retirement Projections

DHRD's annual State of Hawai'i Workforce Profile Report submitted to the Legislature each year projects the eligible retirements for the Executive Branch workforce over the next five fiscal years. Table 6 provides the details and breakout of retirement projections for the Executive Branch.

Vacancies by Class of Work in Executive Branch

With 31% of the workforce eligible to retire in the next five years, there is a significant risk of losing institutional knowledge and experienced personnel, which could severely impact the state government's ability to provide essential services.

The high number of vacant positions in the State of Hawai'i presents several critical challenges and opportunities for improving workforce management and service delivery. Table 7 identifies the highest number of vacancies by class of work as of November 1, 2024. In Table 7, the classes of work are combined for all levels. For example, Office Assistant (OA) total vacancies include counts for OA II, III, IV and V levels. If an applicant applied for and was qualified at multiple levels, they are counted at each level for which they are qualified. Additionally, there are often multiple recruitments per year. If an applicant applies more than once for the same level and are found to be qualified, they are counted each time they apply and are deemed qualified.

Recruitment Strategies

With Hawai'i facing an unprecedented labor shortage and to address vacancy issues, the State Recruiting Office realized the importance of utilizing different strategies to attract prospective candidates to State employment. The following outlines a few of the methods focused on this year:

Outreach/Marketing

Following the successful on-screen advertising campaign with Consolidated Theatres in October 2023, the DHRD Recruiting Office has continued its partnership with two additional ad campaigns in 2024. These campaigns ran for 12 weeks each, from May 13 to August 4 and from October 14, 2024, to January 5, 2025. During these periods, 30-second promotional videos were presented 2-3 times before every movie at various locations, including Kāhala, Ward, Pearlridge West, Mililani Cinema 14, 'Olino by Consolidated Theatres, and Kapolei Theatres. The two recruitment videos, created by DHRD staff, featured state employees from diverse career groups, such as blue collar/trades, office administration, information technology, law enforcement, and health services.

In addition to the Consolidated Theatres campaign, DHRD has entered into advertising contracts with the University of Hawai'i at Mānoa Athletics, TheBus, and Hawai'i's Network of Malls. The contract with UH Mānoa Athletics provides visibility for state recruitment at the Stan Sheriff Center during all men's and women's volleyball and basketball games throughout the 2024-25 school year, targeting approximately 75,000 residents and students.

DHRD has also begun advertising on TheBus with a 6-month contract covering 480 buses that operate daily routes throughout O'ahu. This initial contract aims to secure better placement for future advertising. Additionally, DHRD has a one-year print advertisement on display at the Kalihi and Alapai Transit Centers.

Furthermore, a one-year contract with Hawai'i Network of Malls allows DHRD to place print advertisements in 16 shopping malls and centers, reaching an average of 2.2 million shoppers each month. DHRD plans to extend its reach to additional malls on O'ahu in the coming year. Overall, DHRD will continue to seek new opportunities to expand its marketing and branding efforts.

Targeted Recruitment and Job Fairs

Throughout 2024, DHRD has actively leveraged social media platforms like Facebook, Instagram, X (formerly Twitter), and LinkedIn to promote state recruitments and job fair initiatives. In February 2024, DHRD signed a one-year contract with LinkedIn to utilize their Talent Solutions services, which include career pages to showcase the executive branch and job postings, as well as an automated job wrapping process that streamlines and accelerates job listings. However, as the contract approaches its end, there is insufficient evidence to determine the impact of this strategy on recruitment figures, prompting DHRD to continue assessing its effectiveness.

Recognizing the competitive job market, DHRD emphasizes the importance of maintaining a strong presence at various career fairs and outreach events to engage directly with potential applicants. The State Recruiting Office collaborates with state agencies to represent state job opportunities and employee benefits effectively. In the first half of 2024, DHRD participated in 13 events, including career fairs at the University of Hawai'i at

Mānoa, the University of Hawai'i West O'ahu, Chaminade University, and Hawai'i Pacific University, which facilitated connections with college graduates. DHRD also coordinated participation in public events organized by the Star Advertiser at the Neil Blaisdell Center.

In the second half of 2024, the State Recruiting Office collaborated with other departments to represent the State Executive Branch at 16 additional career fairs and outreach events, specifically targeting students graduating with relevant degrees. Participation included events at universities and the Neil Blaisdell Center, as well as fairs hosted by Joint Base Pearl Harbor-Hickam, Kahi Mohala, and the Hawai'i Technology Development Corporation.

To further enhance recruitment efforts, DHRD hosted targeted fast-track recruitment events aimed at expediting the application and screening process. These events allowed DHRD to implement new procedures, including on-site application acceptance for roles such as Office Assistant, Library Assistant, Registered Nurse, Social Worker, and Professional Trainee, as well as on-site screening and interviews. A total of 496 applications were received during these events, with 373 individuals qualified, 479 interviews scheduled, and 66 individuals hired by participating departments as of October 9, 2024. DHRD continues to collaborate with counterparts on the neighbor islands to participate in local events, assisting in filling state vacancies across the islands.

SkillBridge

In July 2024, DHRD's application was approved by the U.S. Department of Defense's SkillBridge program on behalf of the State of Hawai'i. SkillBridge creates a partnership with employers and current active-duty service members and provides the service member an opportunity to receive specific training or participate in an internship or apprenticeship with an employer during their last three to six months of their military service. This program assists the service members with transitioning to civilian life and will provide training or experience, with the hope that the service members will apply for a vacant position upon retirement or separation.

To promote the State's SkillBridge partnership with service members, DHRD corresponded with each branch of service to highlight the State's endeavors. DHRD staff have also attended SkillBridge fairs and recruiting events held by the Joint Based Pearl Harbor Hickam to meet with members, promote our opportunities, and gain more insight into the SkillBridge program from their SkillBridge Coordinators and other approved partners.

DHRD initially focused on IT positions, looking to create partnerships and pathways from active-duty military to filling civil service vacancies. While numerous service members expressed an interest in our program since its inception, none possessed information technology experience. Therefore, to reach a broader pool of exiting service members, DHRD recently expanded our opportunities to include Account Clerks, Building Maintenance Workers, Office Assistants, and Registered Nurses, with more classes to be added in the future.

DHRD has been working with various departments to identify department specific classes of work that will benefit from SkillBridge and will continue to collaborate with the managers to secure our first partnership request.

[Hele Imua State of Hawai'i Internship Program](#)

Since its inception in September 2022, the Hele Imua State of Hawai'i Internship Program has seen significant developments, particularly following the memorandum of agreement signed between DHRD and DLIR in September 2023. This agreement formalizes the support that DHRD will provide to the internship program. As part of this collaboration,

DLIR has assigned an exempt Workforce Program Specialist to DHRD to assist with the internship program and support the interns directly.

The Workforce Program Specialist began working with DHRD in November 2023, taking on the responsibility of coordinating programs and developing a five-course curriculum specifically for the Hele Imua interns. The primary goal of the internship is to equip interns with quality work experience, preparing them for careers in their chosen industries. This structured approach aims to enhance the interns' employability and better prepare them for future opportunities within state government and beyond. The program includes:

- 1) Hele Imua Meet and Greet – scheduled bi-monthly, providing an overview of the learning management system, their intern learning plan, and specifics about the in-person trainings, focused on the application, interview, and placement process. 151 interns attended between January 2024 and September 2024. Meetings will continue twice a month for the remainder of the calendar year.
- 2) Hele Imua In-Person – this all-day session covers resume creation/refreshment, NeoGov and the State’s application process, and an interviewing process workshop. 72 interns have attended 6 sessions so far in 2024 and there is one more session scheduled in November 2024.
- 3) Hele Imua Recruitment Workshop – Hands-on workshop with the intern and a DHRD recruiter, exploring positions for which the intern would qualify. 19 interns attended two sessions in 2024 and one more class is scheduled in 2024.
- 4) Hele Imua Open House – a networking event for current interns where former interns, now employees, hosted a round-table discussion on their experiences, and a Legislator Q&A session. One event was held in 2024.
- 5) Hele Imua Learning Path – compilation of approximately 23 online/on-demand training courses for all interns including an overview of State government, Equal Employment Opportunity (EEO) Training and Workplace Violence Program training. 164 interns were enrolled in 2024.

Updated Classes of Work

The job title "Secretary" has become outdated in both the private and public sectors, prompting a shift toward more contemporary titles like "Administrative Assistant." To keep the State’s job titles current and appealing to potential applicants, DHRD has retitled the Secretary series to Administrative Assistant and the existing Administrative Assistant series to Executive Specialist, effective July 16, 2024. This modernization aligns job titles with industry standards, positioning the State to attract top talent more effectively.

Following these changes, there has been a noticeable increase in the total number of applications received for both series, indicating that the new titles have positively impacted recruitment efforts. Moving forward, DHRD is committed to exploring additional ways to

modernize its classification and compensation system to further enhance its appeal to prospective employees.

Compensation Updates

Engineer Salary Schedule

To address the challenges in recruiting and retaining employees within the Engineer series, DHRD developed a separate salary schedule aimed at enhancing competitiveness. These classes of work have faced significant difficulties in filling positions and were classified as a shortage category several decades ago, leading to multiple increases in shortage rates paid through a differential.

The new salary schedule integrates these shortage differentials into the base pay, creating a revised structure that aligns more closely with market rates and offers higher wage levels. This adjustment is expected to improve recruitment efforts while also aiding in the retention of employees who are nearing retirement eligibility. By making these changes, DHRD aims to ensure a more stable and qualified workforce within the Engineer series.

New Shortage Categories

To enhance recruitment and retention efforts, several classes were designated as shortage categories in 2024, including Highway Construction Inspector, General Construction Inspector, Special Education Teachers (within the Department of Health), Planners, and Airport Operations Controller. Additionally, hiring rates for Child Welfare Services (CWS) positions—including Human Services Professionals, Social Workers, and Child/Adult Protective Services Specialists—were also increased due to the critical nature of these roles and the ongoing challenges in filling them. These measures aim to address workforce shortages in key areas and ensure that essential services remain effective and accessible.

Recommendations

In the years since the inception of the Act 57 Annual Report, DHRD has identified multiple positions to be abolished using various parameters (10 years, 5 years, then 4 years vacant). In 2021 – DHRD identified 46 vacant positions, three were abolished Act 088 (SLH 2021). In 2022 – DHRD identified 66 positions, one was abolished in Act 248 (SLH 2022). In 2023 – DHRD identified 131 positions, nine were abolished in Act 164 (SLH 2023).

This year, DHRD, in partnership with the Department of Budget and Finance (B&F), continues to identify numerous long-standing state vacancies.

In July 2024, each Executive Branch department was requested to update and clean up their human resources management system data, making sure positions are removed if they had been abolished, if the not to exceed (NTE) date had passed, etc. In August 2024, each Executive Branch department was provided with a list of their vacant positions that have remained unfilled for more than four years. Departments were allowed to explain the reasoning for the length of vacancy.

As of November 1, 2024, 419 civil service positions have been vacant for four years or more.

Conclusion

In recent years, State employees were changing positions or leaving state service faster than departments could fill vacancies, which has caused the State’s civil service vacancy rate to steadily increase. However, this past year, DHRD has taken extraordinary measures to reverse the upward trend. Recruitment activity, interest, and workload has increased in almost every area from the number of advertised recruitments, applications received and screened, lists issued and eligibles referred to departments. In addition, the Executive Branch faces an ageing statewide workforce that is approximately 31% eligible to retire within the next five years.

DHRD has made tremendous progress increasing recruitment efforts, but there is still more work to be done helping departments update their position descriptions; conducting a comprehensive review of the State’s Classification and Compensation system to update and modernize our framework and minimum qualification requirements; and developing a workforce survey to gain better insight into our employees’ needs and ways to support them with retention efforts.

DHRD remains committed to creating and providing value to the State of Hawai’i Executive Branch by supporting State agencies with their human resources needs and supporting employees with opportunities for professional development.

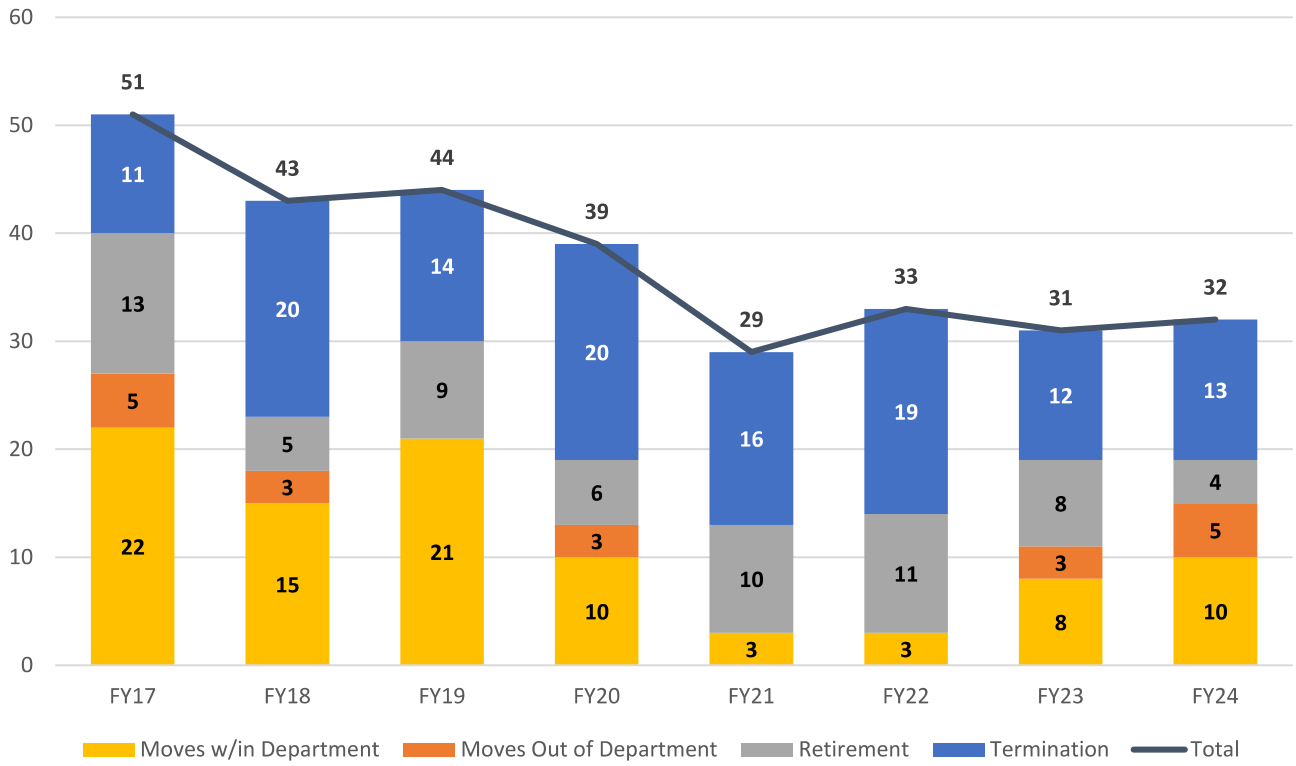

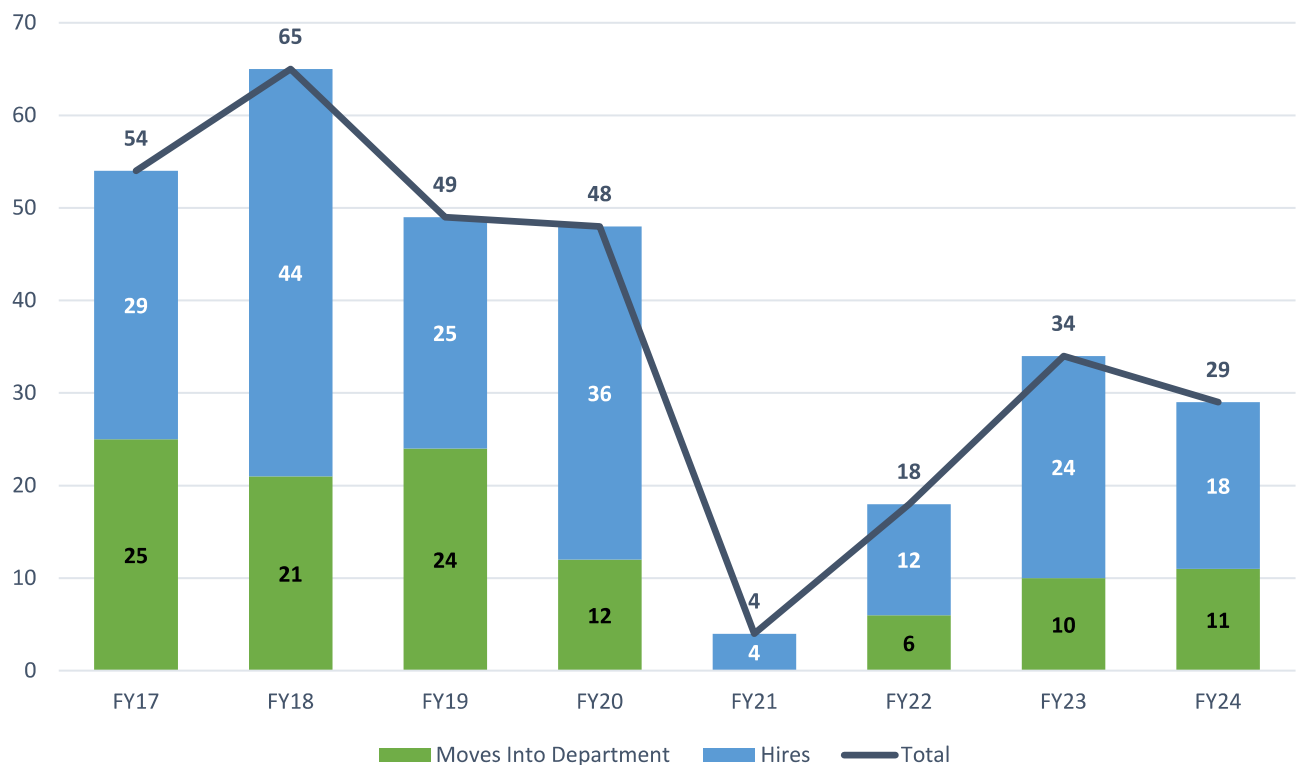

Types of Moves Out of Department (Creates a Vacancy)

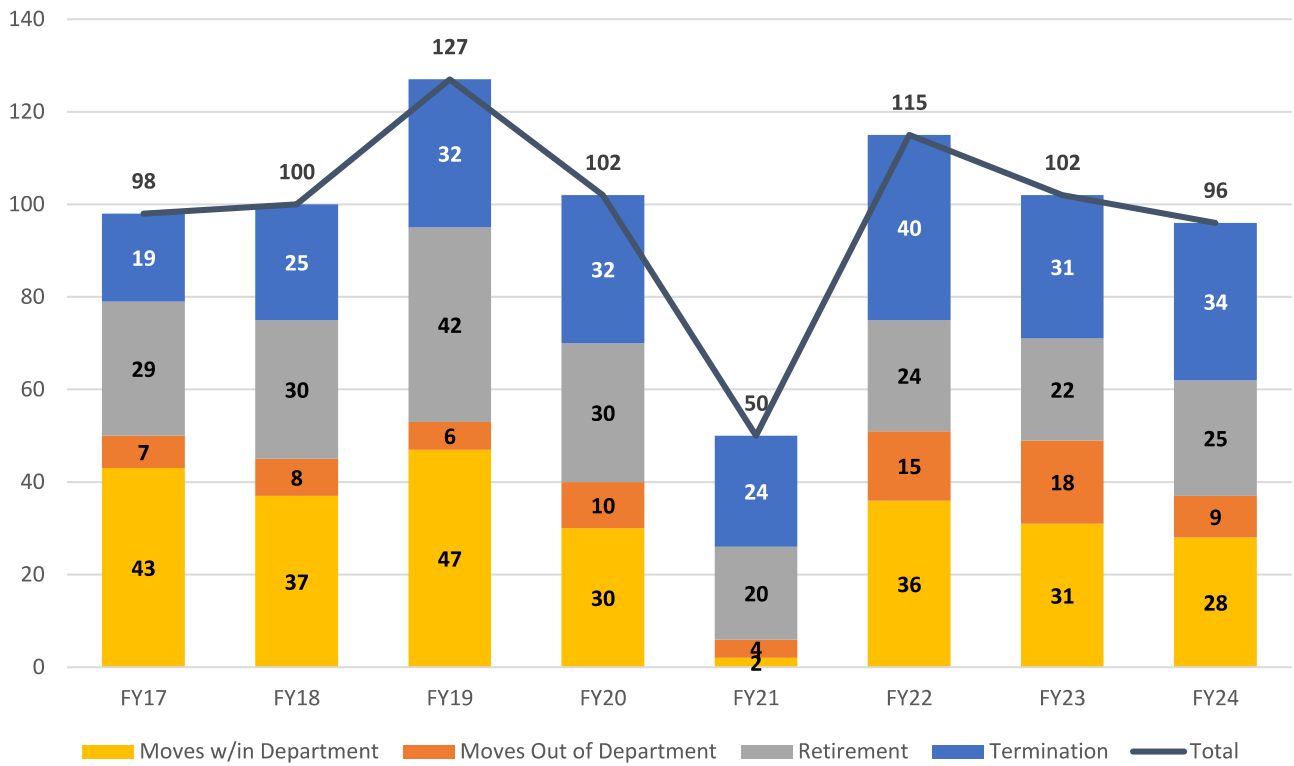


Types of Moves Into Department (Fills a Vacancy)

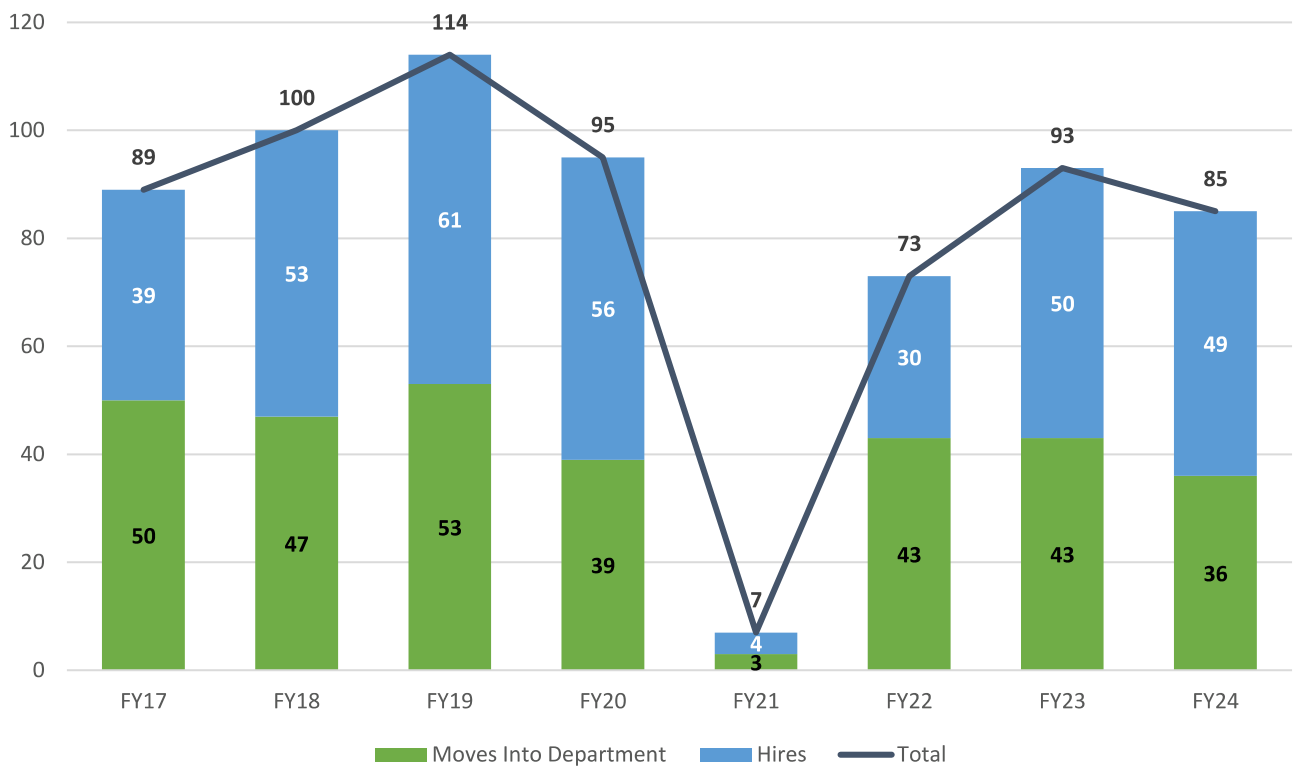


DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES (AGS)

Types of Moves Out of Department (Creates a Vacancy)

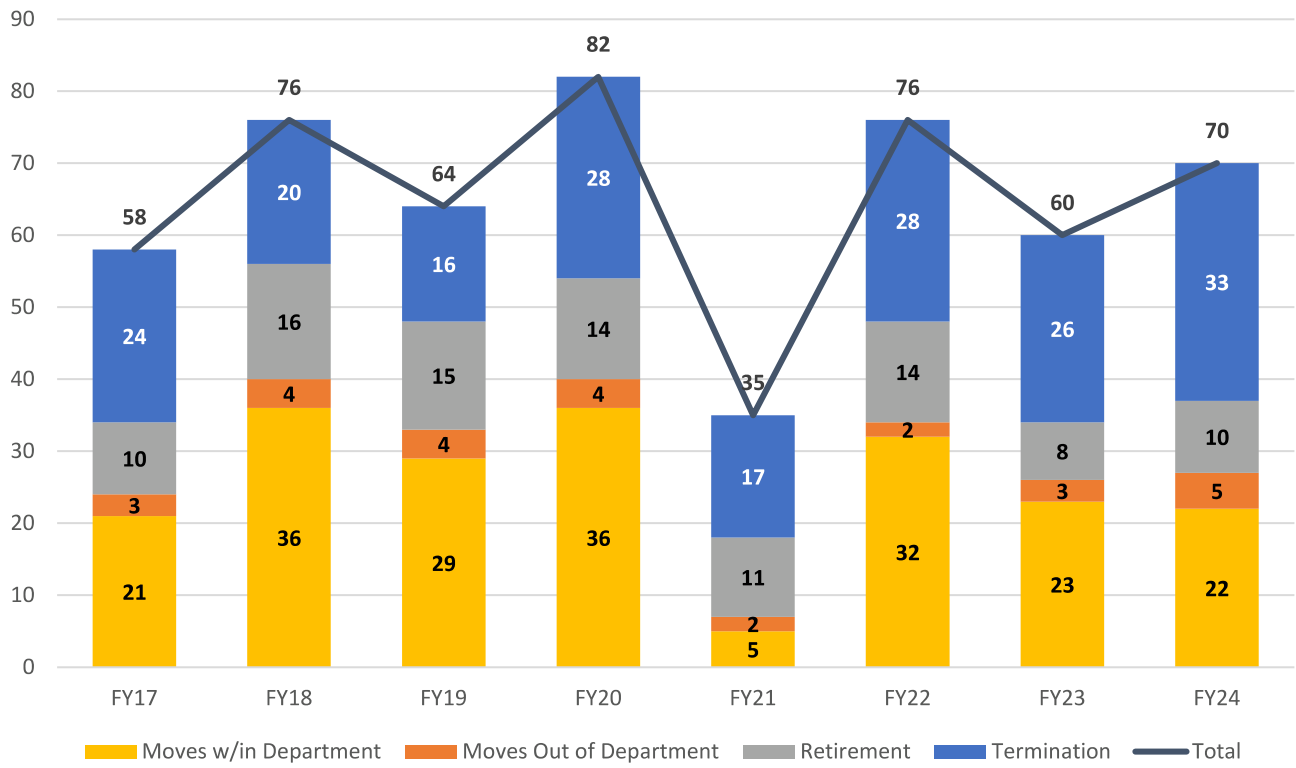


Types of Moves Into Department (Fills a Vacancy)

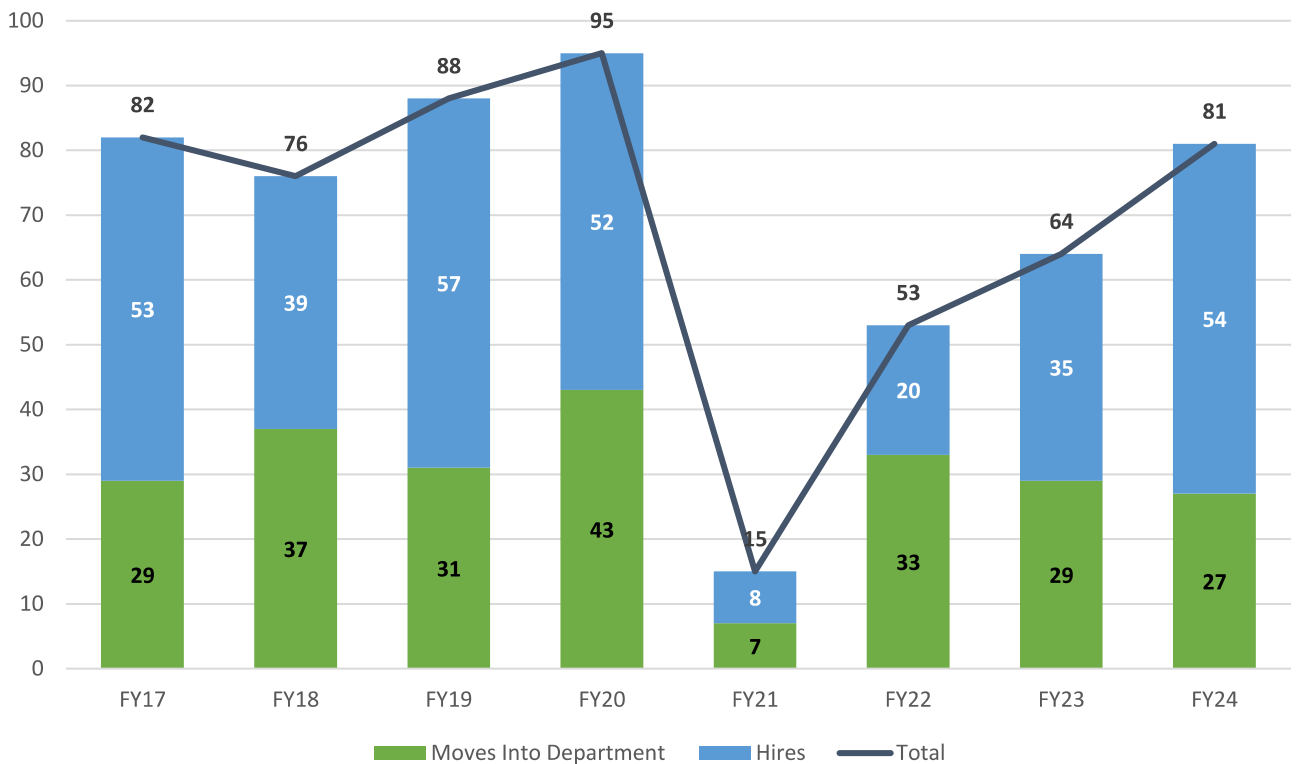


DEPARTMENT OF THE ATTORNEY GENERAL (ATG)

Types of Moves Out of Department (Creates a Vacancy)

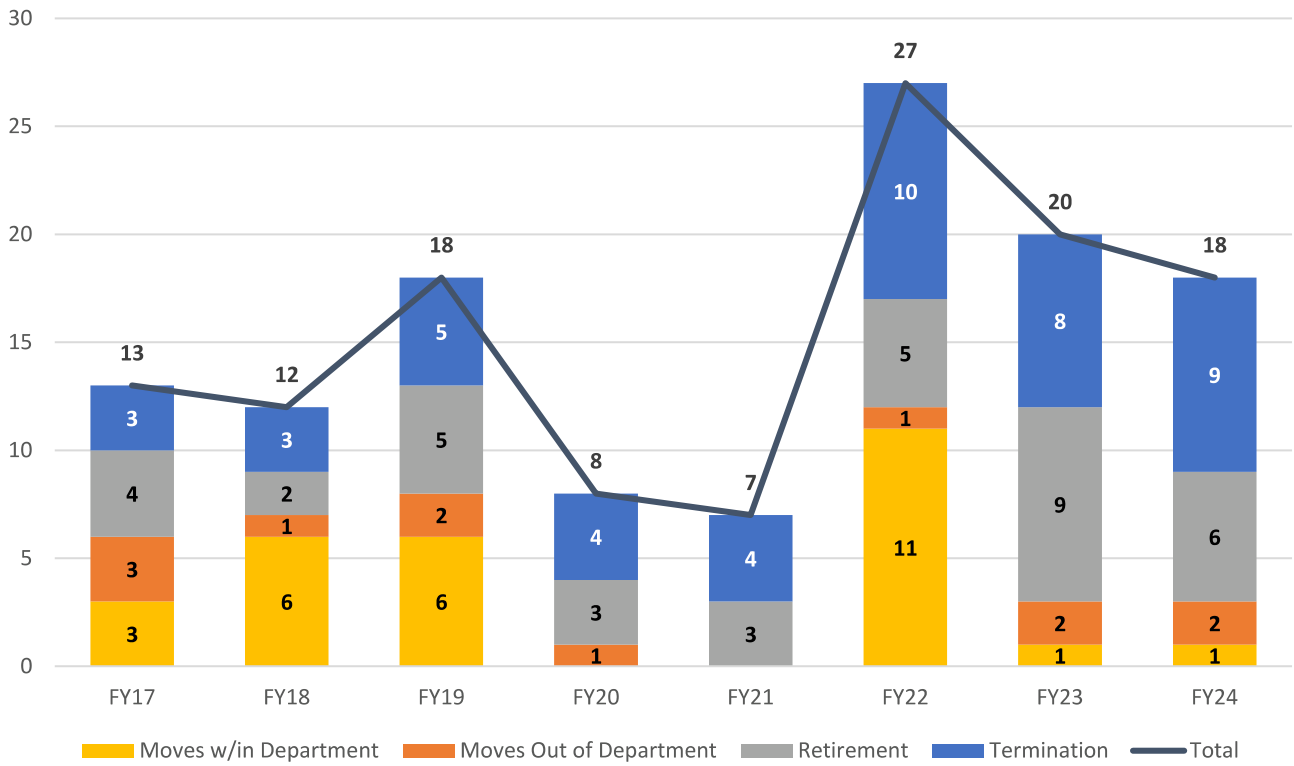


Types of Moves Into Department (Fills a Vacancy)

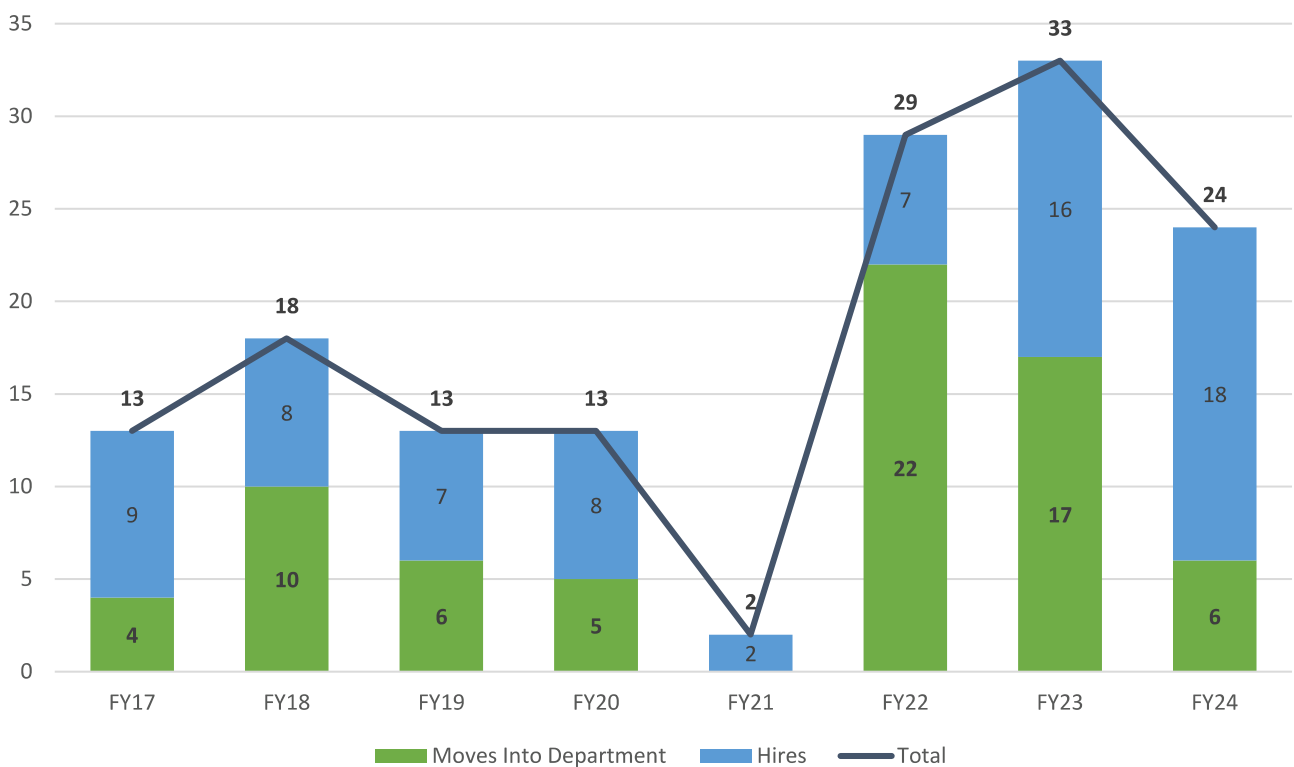


DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT & TOURISM (BED)

Types of Moves Out of Department (Creates a Vacancy)

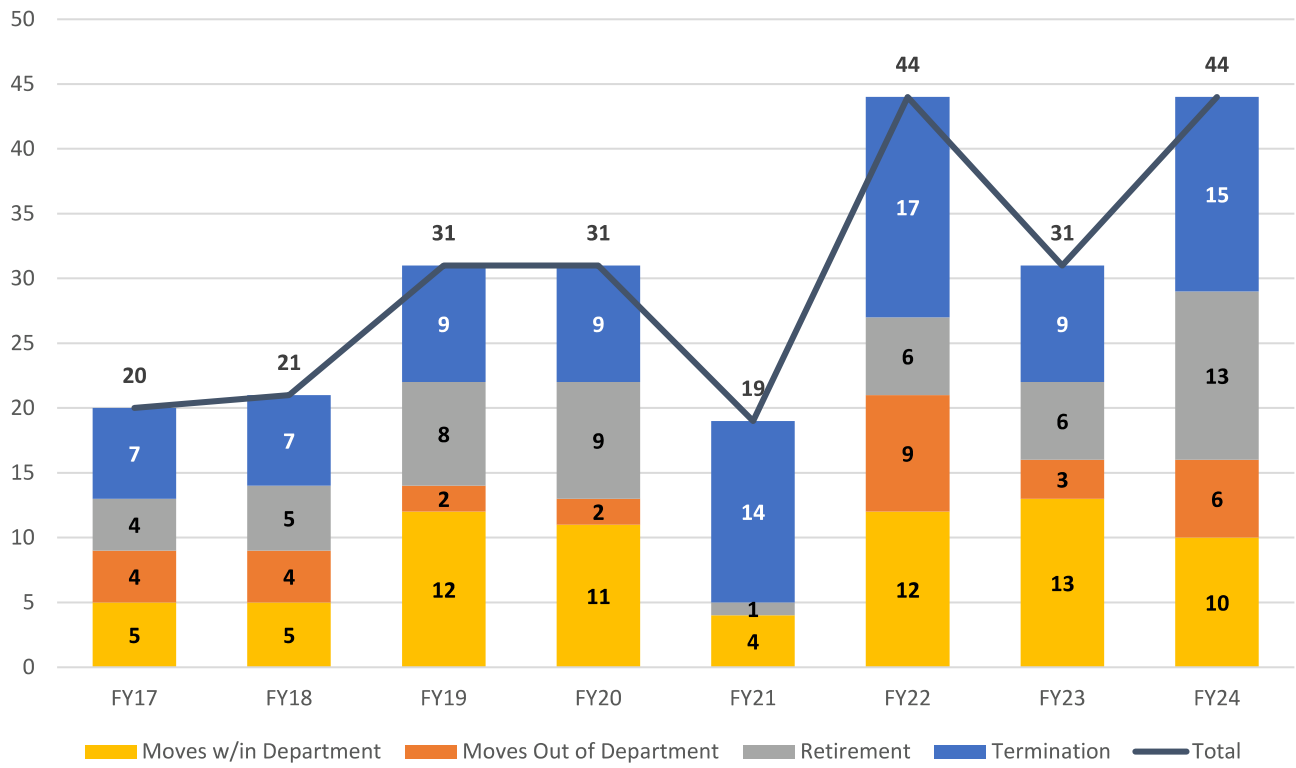


Types of Moves Into Department (Fills a Vacancy)

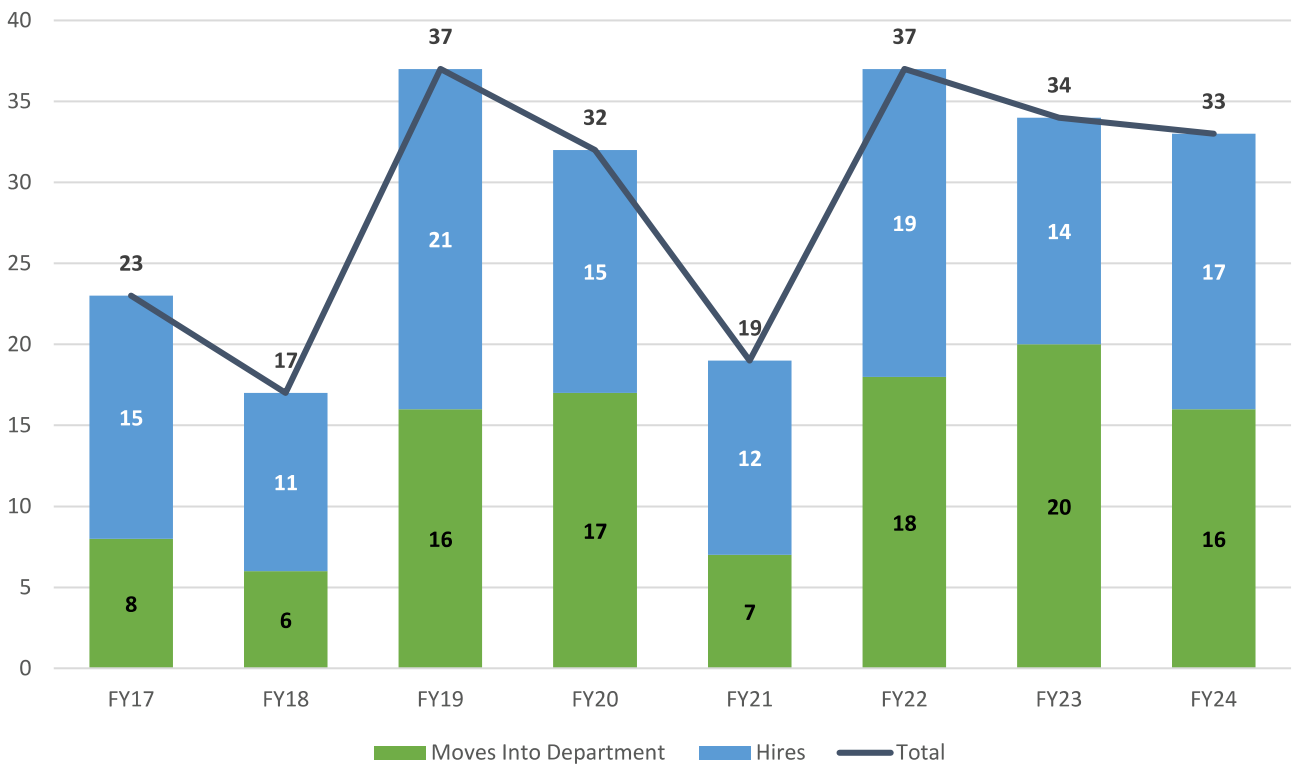


DEPARTMENT OF BUDGET AND FINANCE (BUF)

Types of Moves Out of Department (Creates a Vacancy)

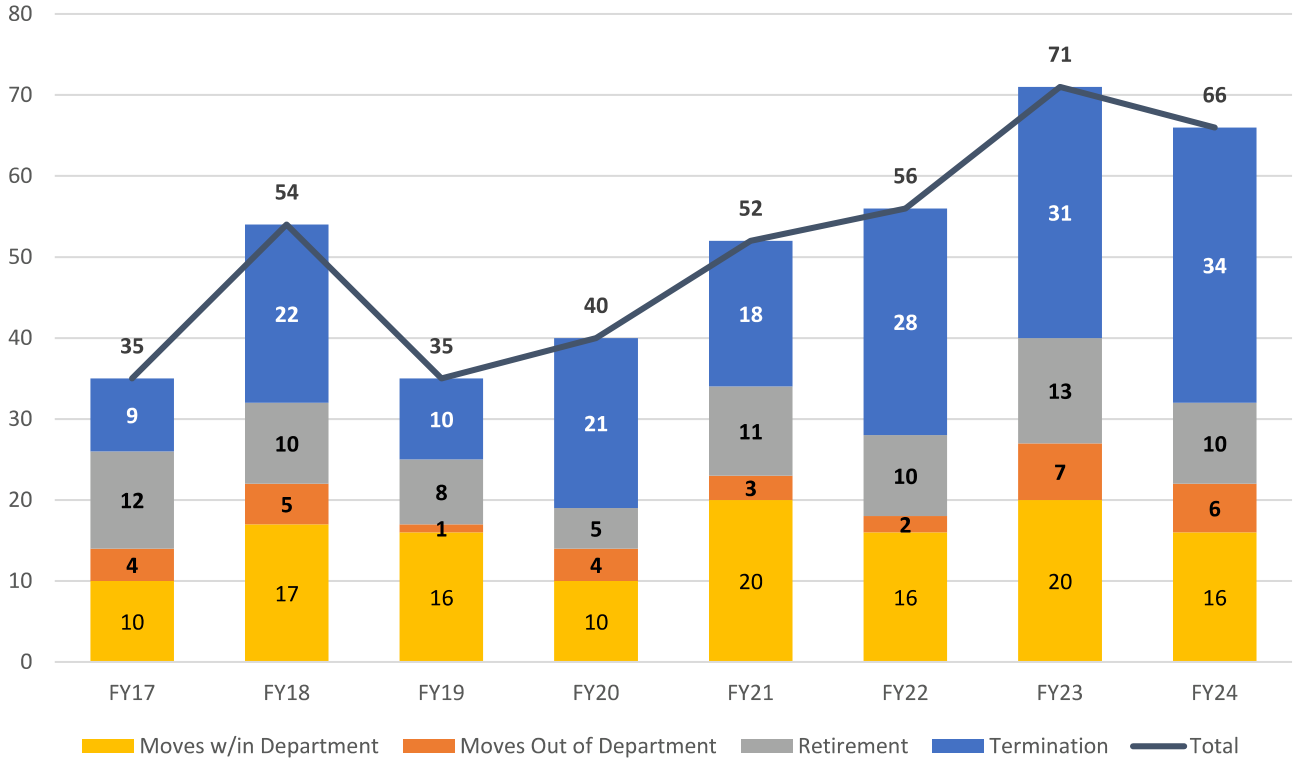


Types of Moves Into Department (Fills a Vacancy)

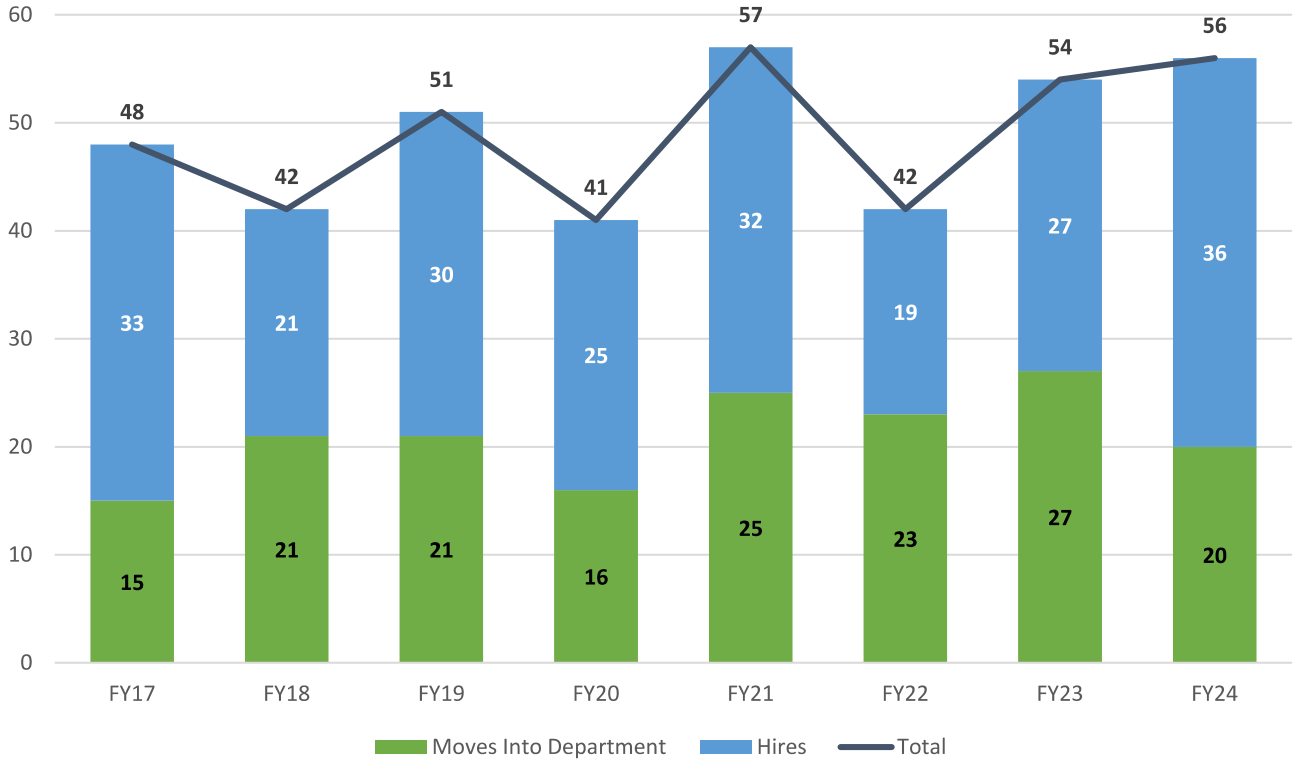


DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS (CCA)

Types of Moves Out of Department (Creates a Vacancy)

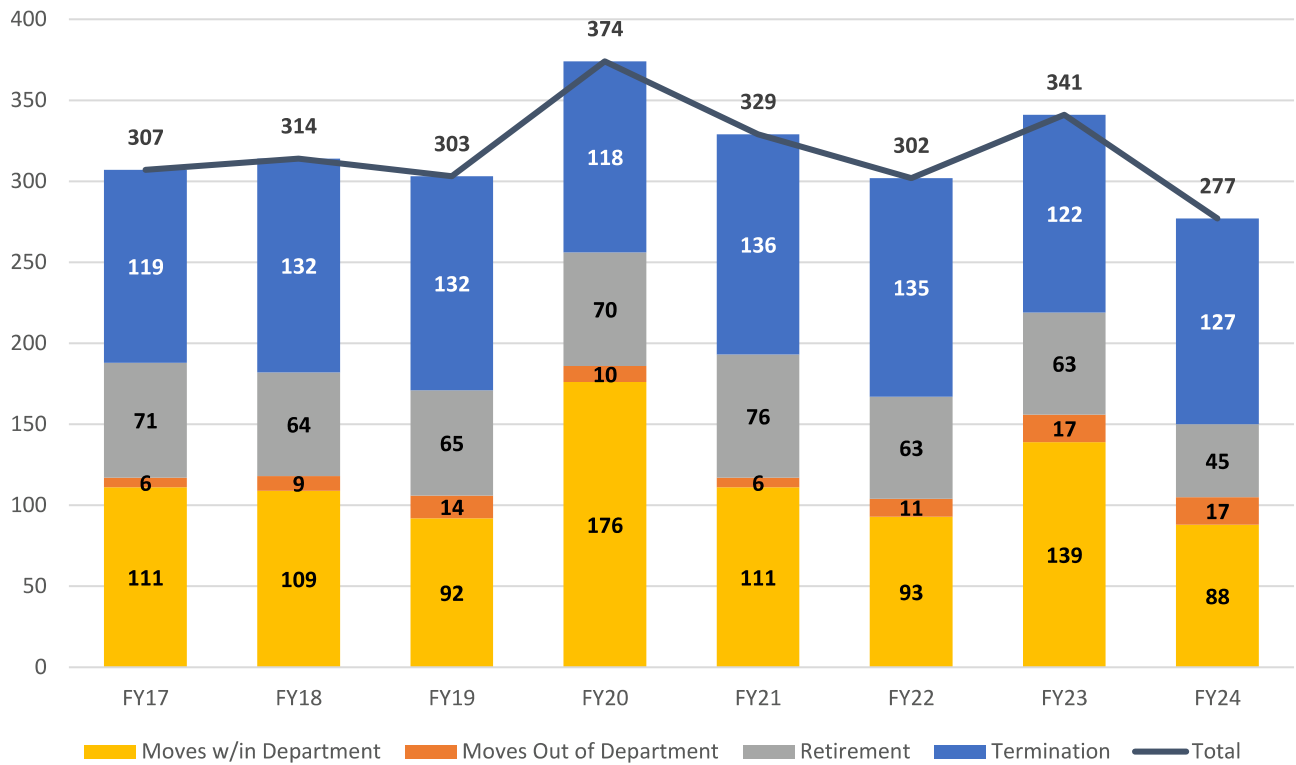


Types of Moves Into Department (Fills a Vacancy)

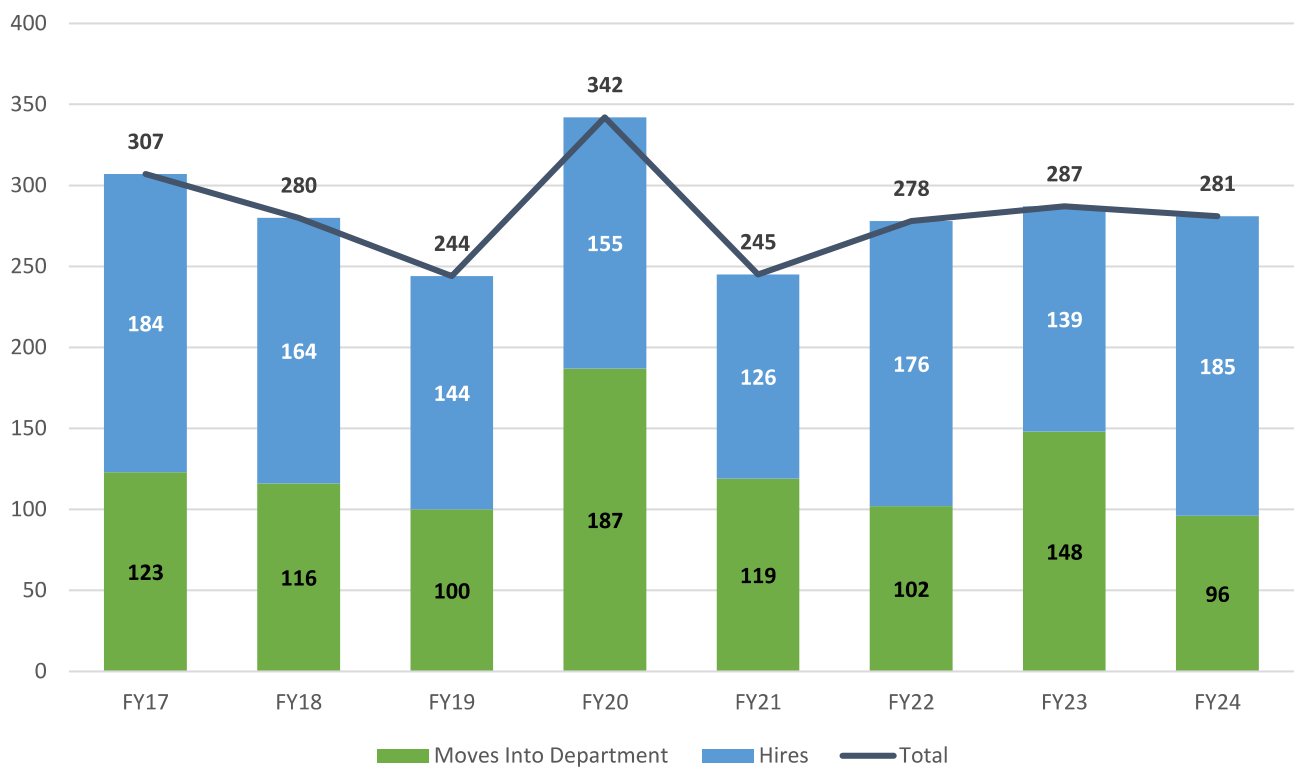


DEPARTMENT OF CORRECTIONS AND REHABILITATION (DCR)

Types of Moves Out of Department (Creates a Vacancy)

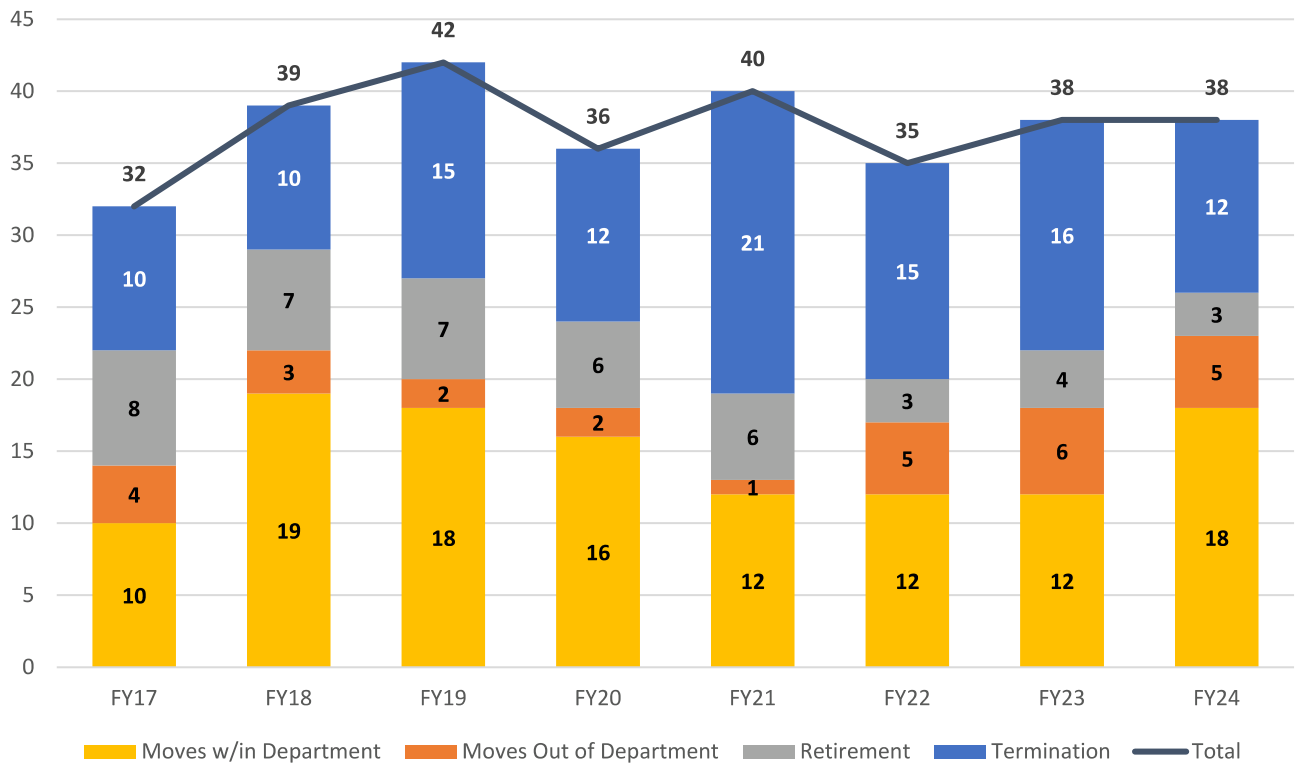


Types of Moves Into Department (Fills a Vacancy)

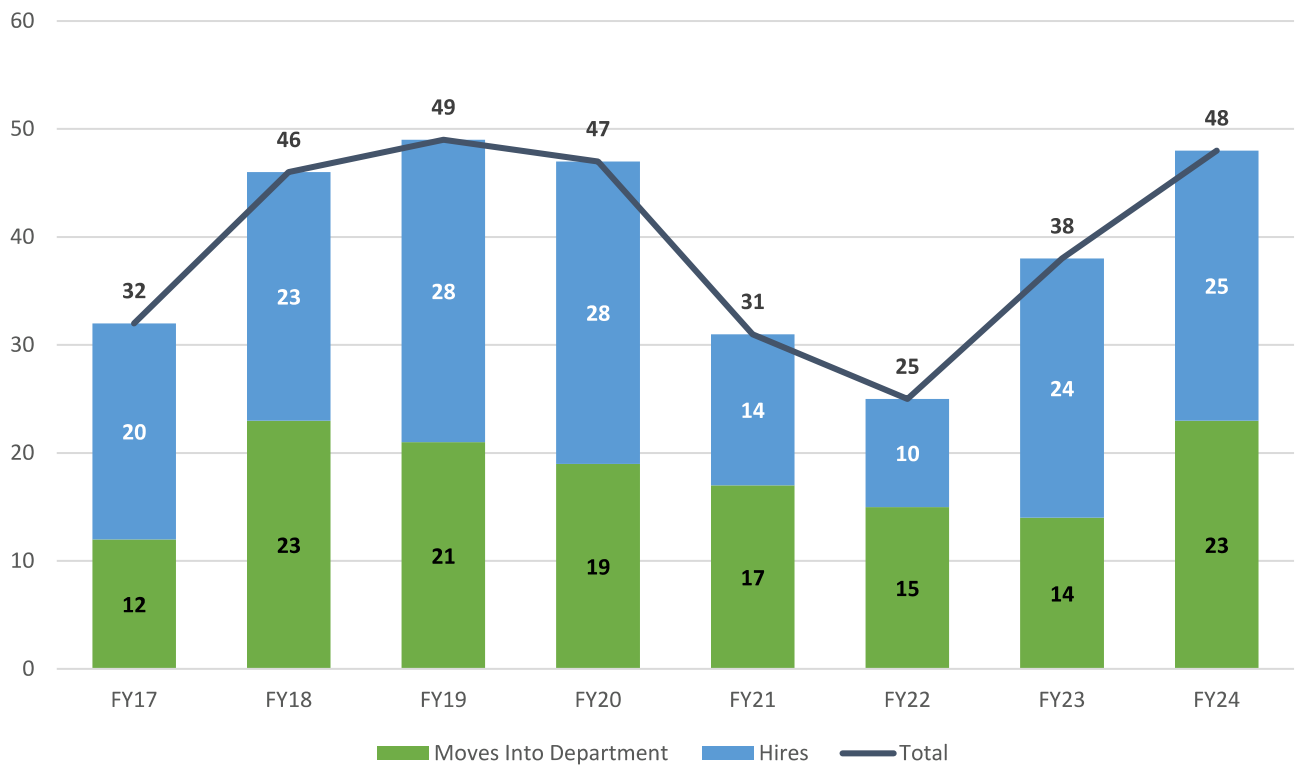


DEPARTMENT OF DEFENSE (DEF)

Types of Moves Out of Department (Creates a Vacancy)

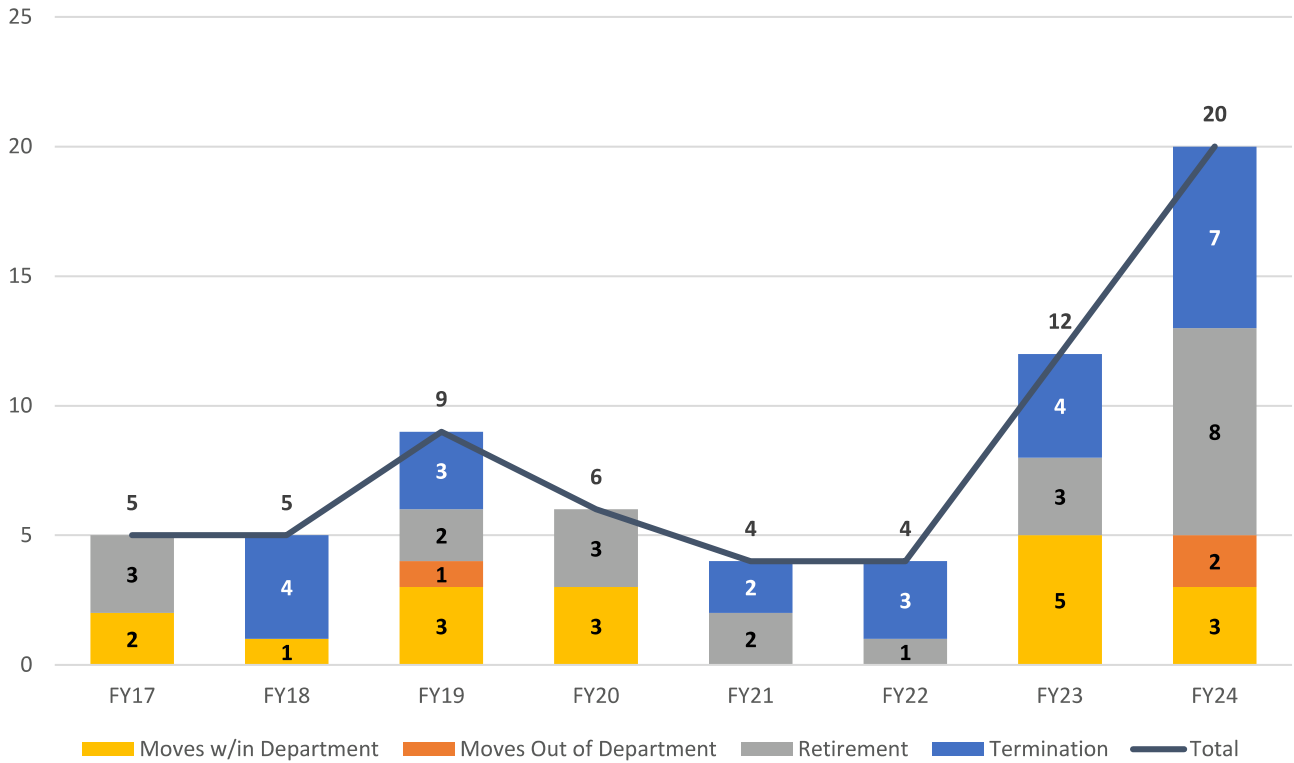


Types of Moves Into Department (Fills a Vacancy)

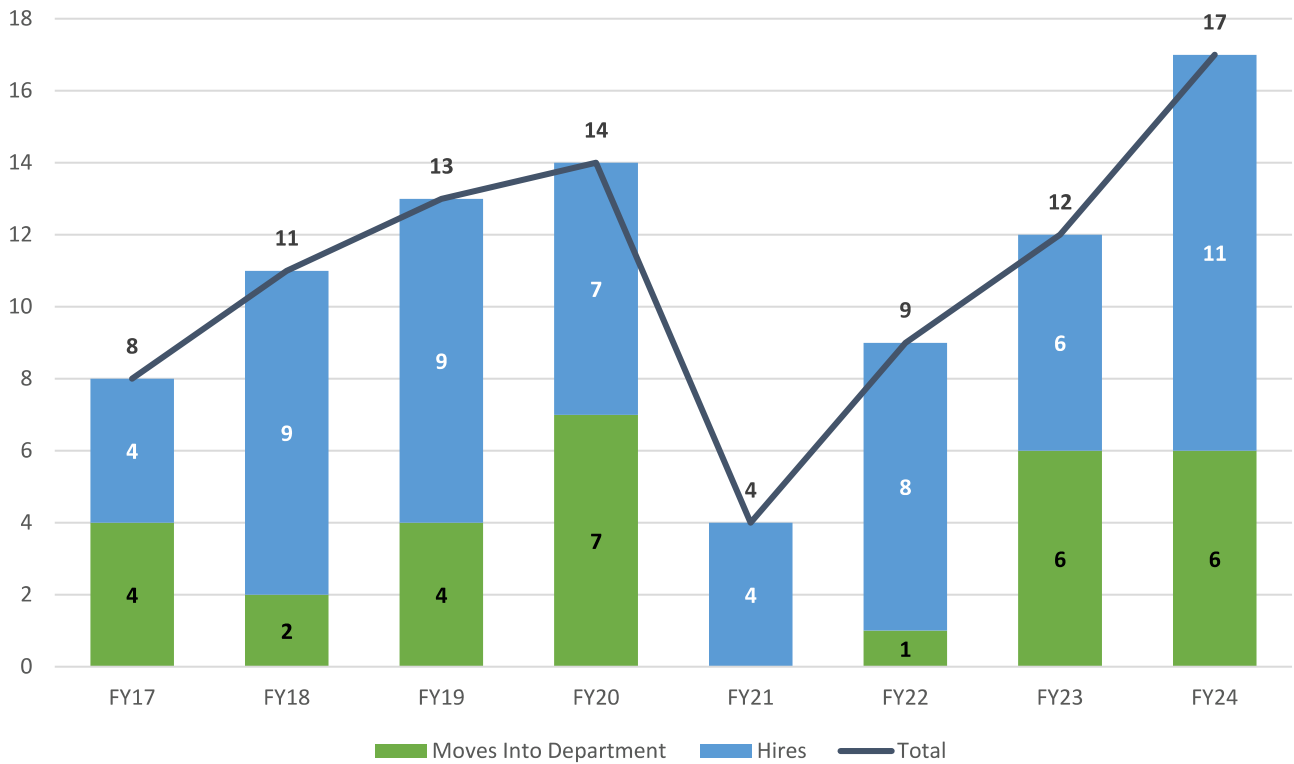


DEPARTMENT OF HAWAIIAN HOME LANDS (HHL)

Types of Moves Out of Department (Creates a Vacancy)

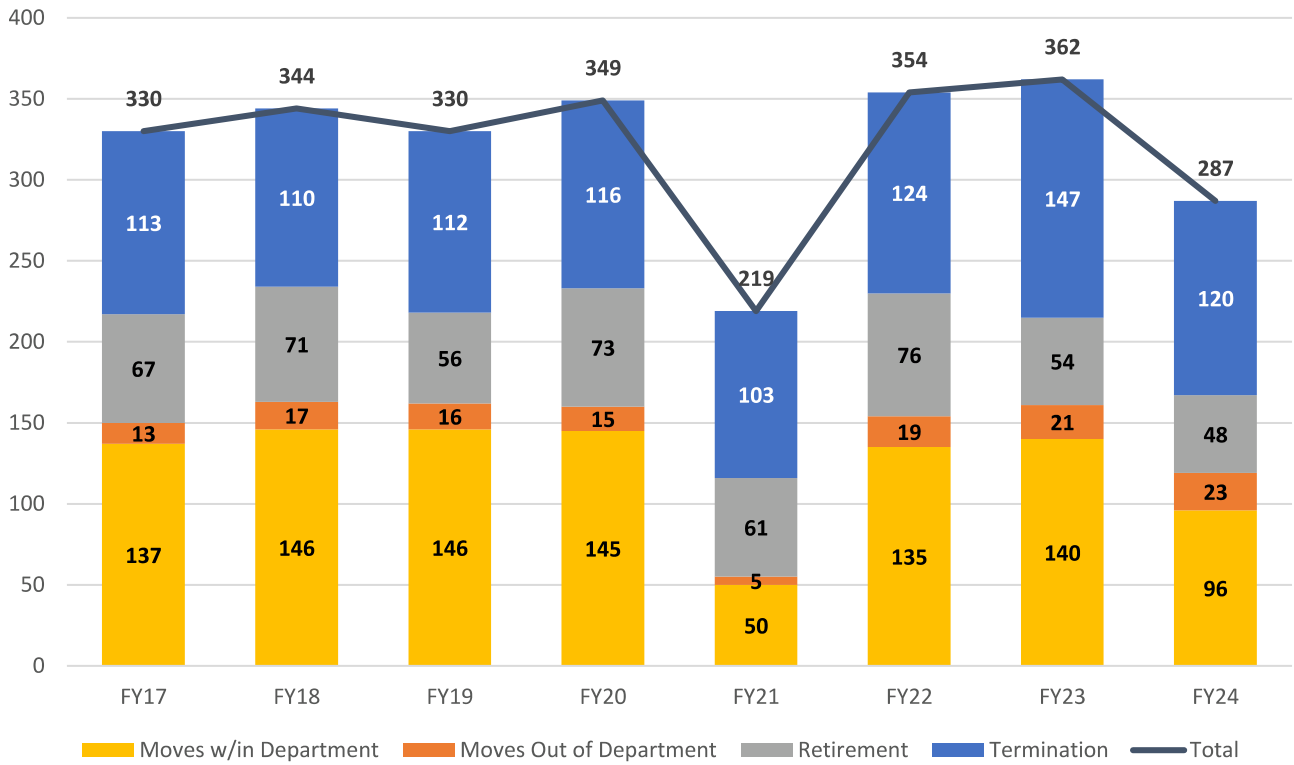


Types of Moves Into Department (Fills a Vacancy)

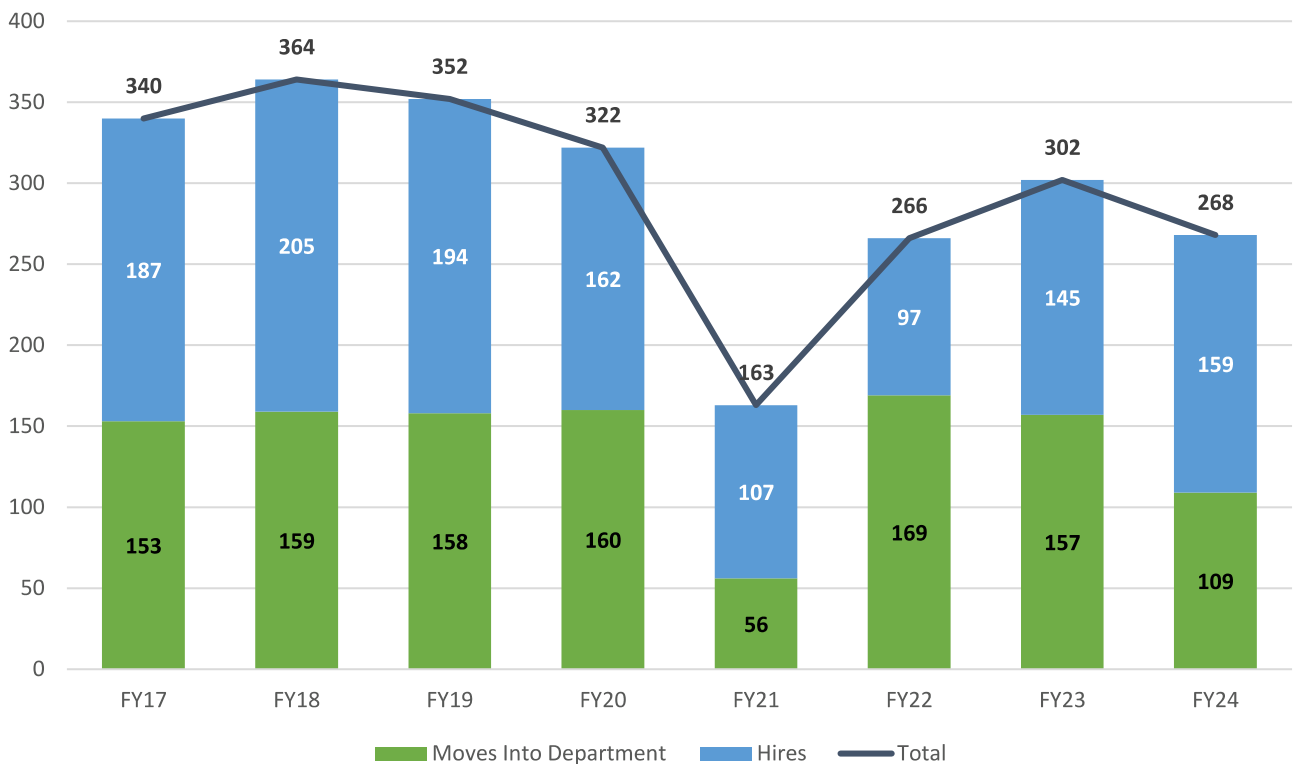


DEPARTMENT OF HUMAN SERVICES (HMS)

Types of Moves Out of Department (Creates a Vacancy)

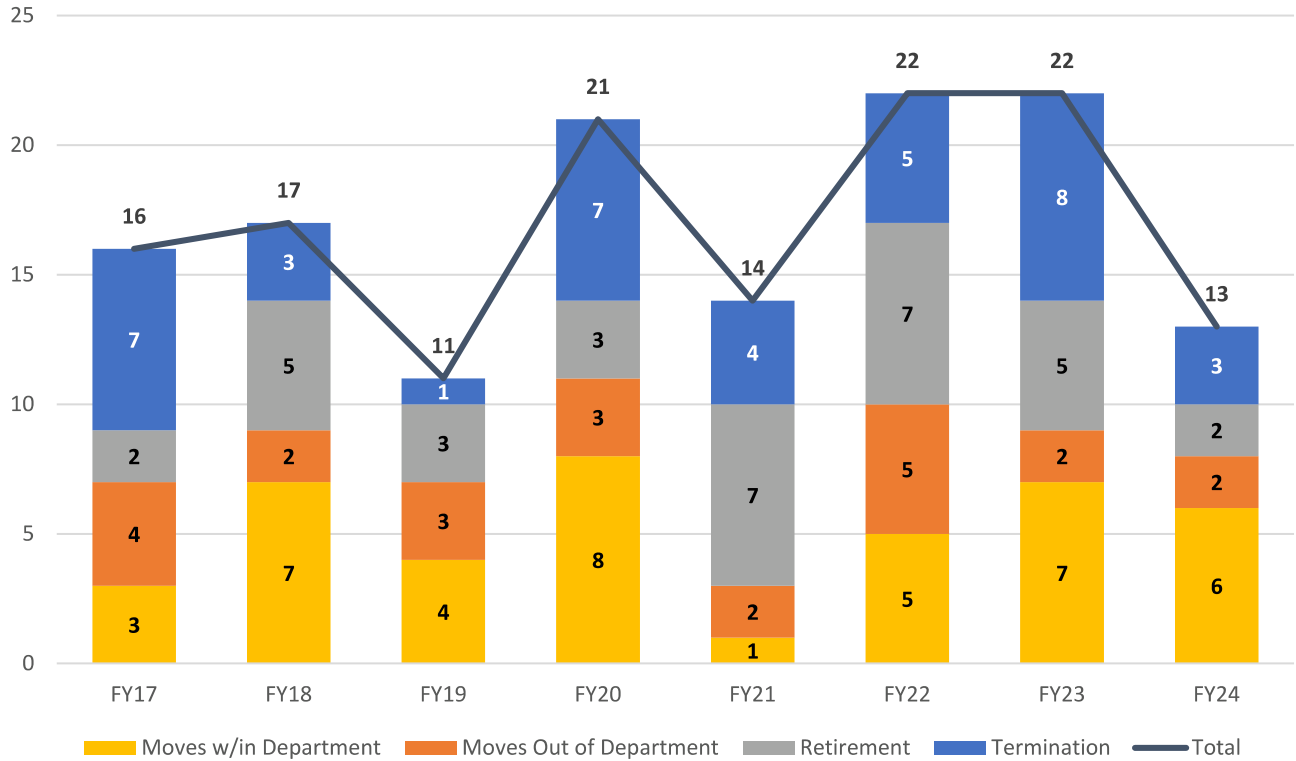


Types of Moves Into Department (Fills a Vacancy)

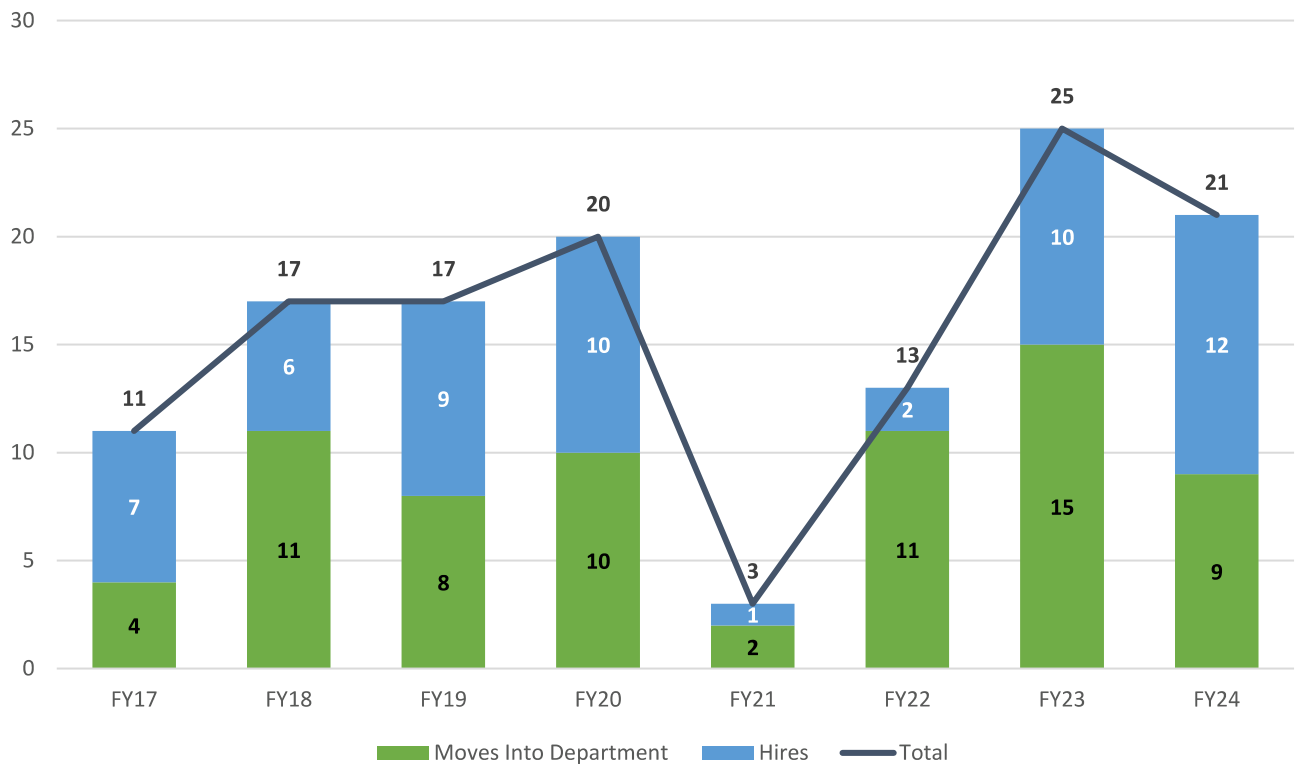


DEPARTMENT OF HUMAN RESOURCES DEVELOPMENT (HRD)

Types of Moves Out of Department (Creates a Vacancy)

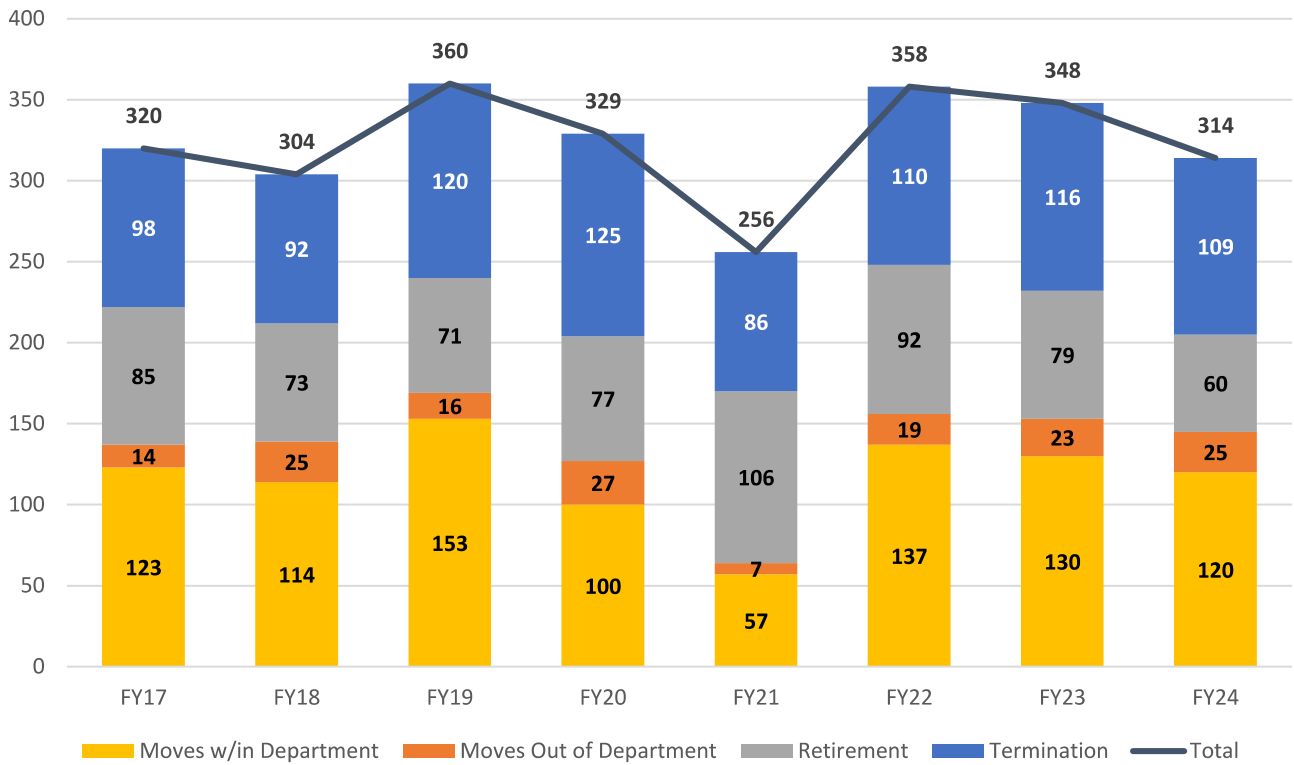


Types of Moves Into Department (Fills a Vacancy)

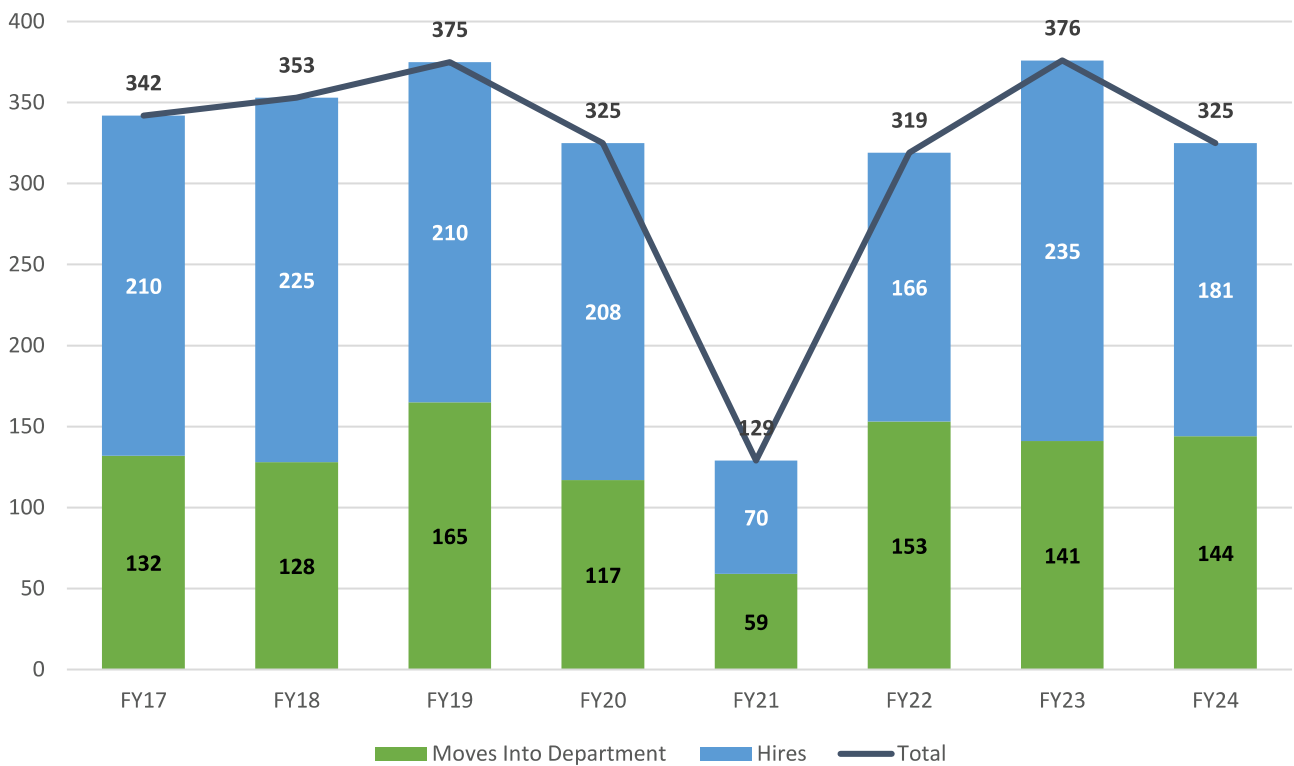

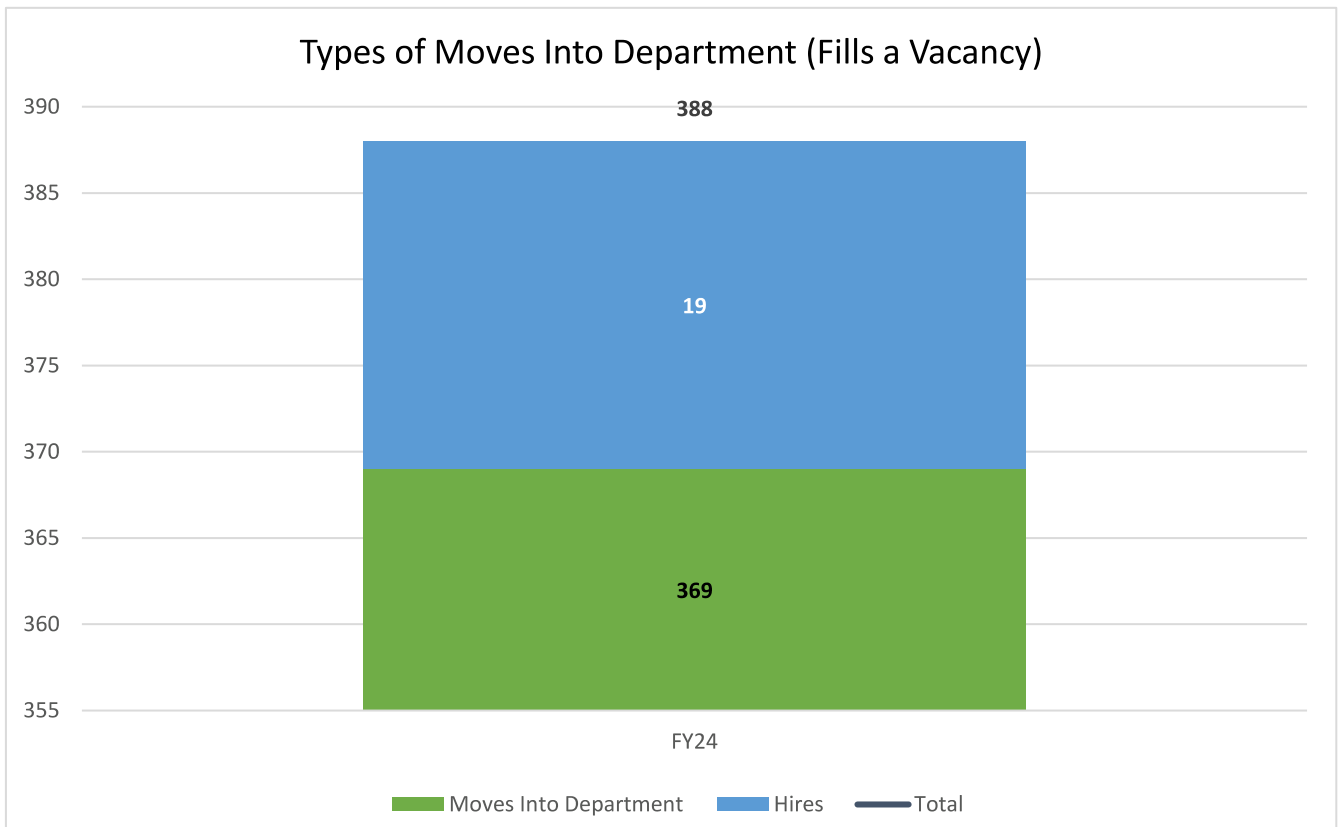
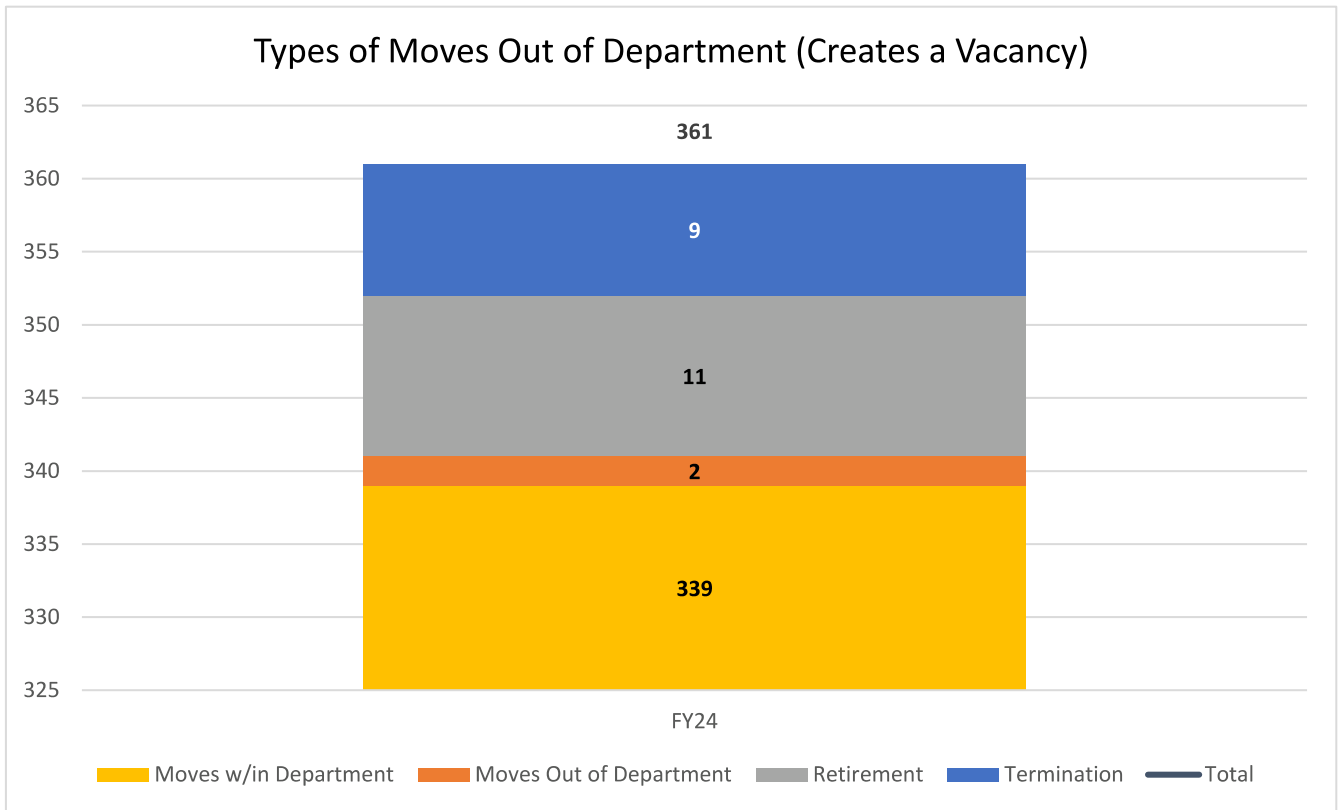
Types of Moves Out of Department (Creates a Vacancy)



Types of Moves Into Department (Fills a Vacancy)



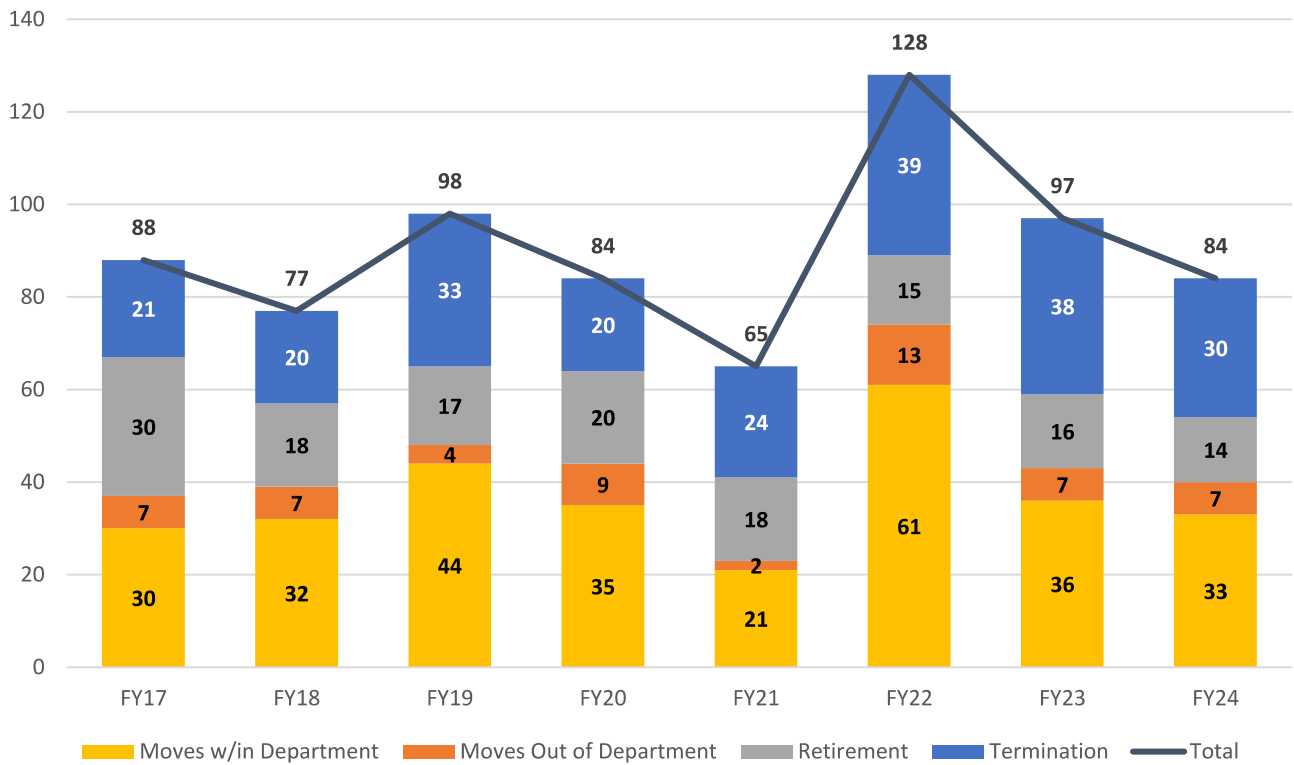

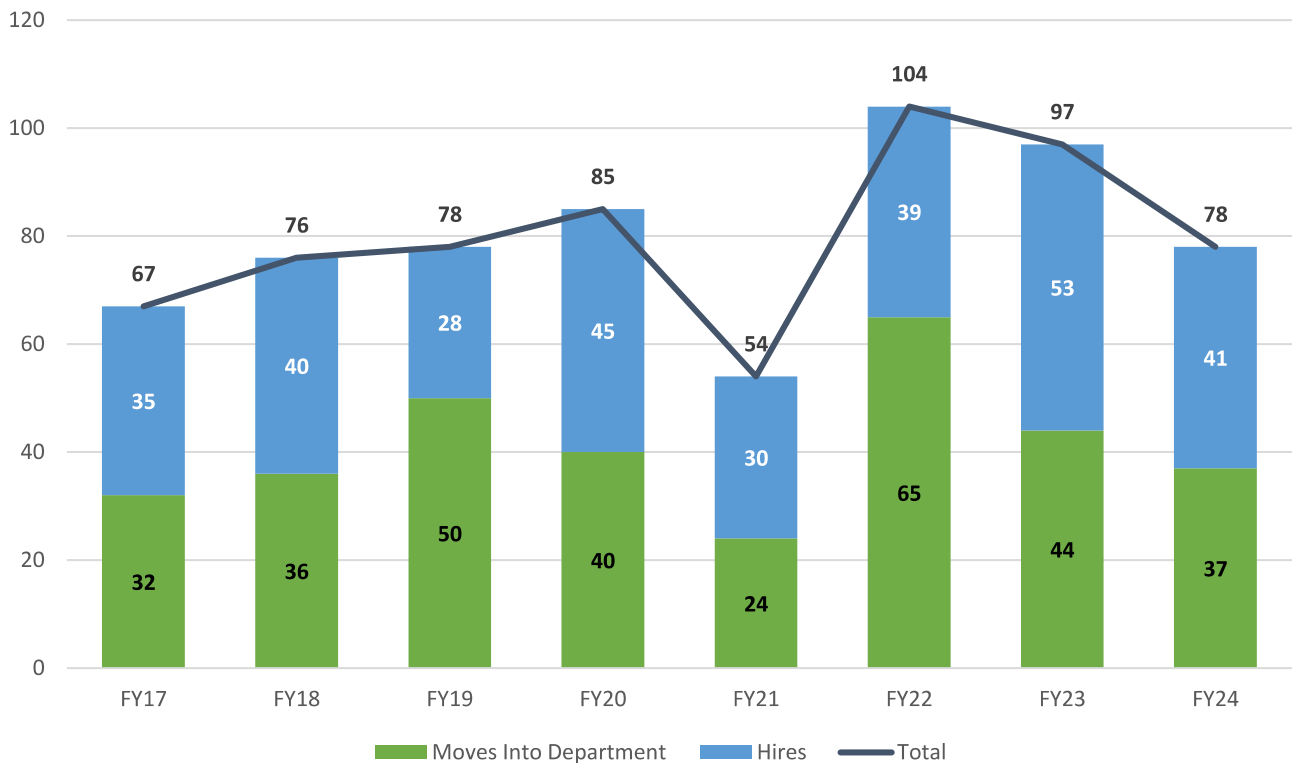

Types of Moves Out of Department (Creates a Vacancy)

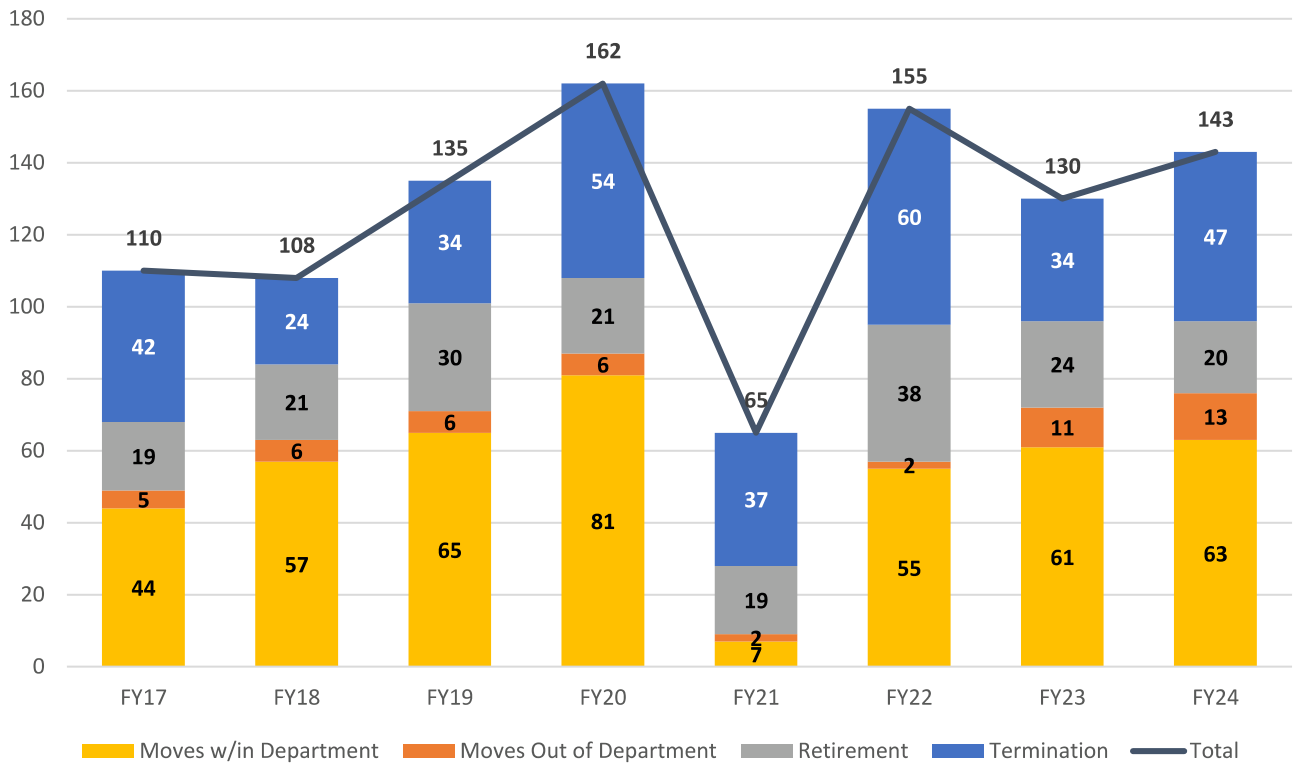


Types of Moves Into Department (Fills a Vacancy)

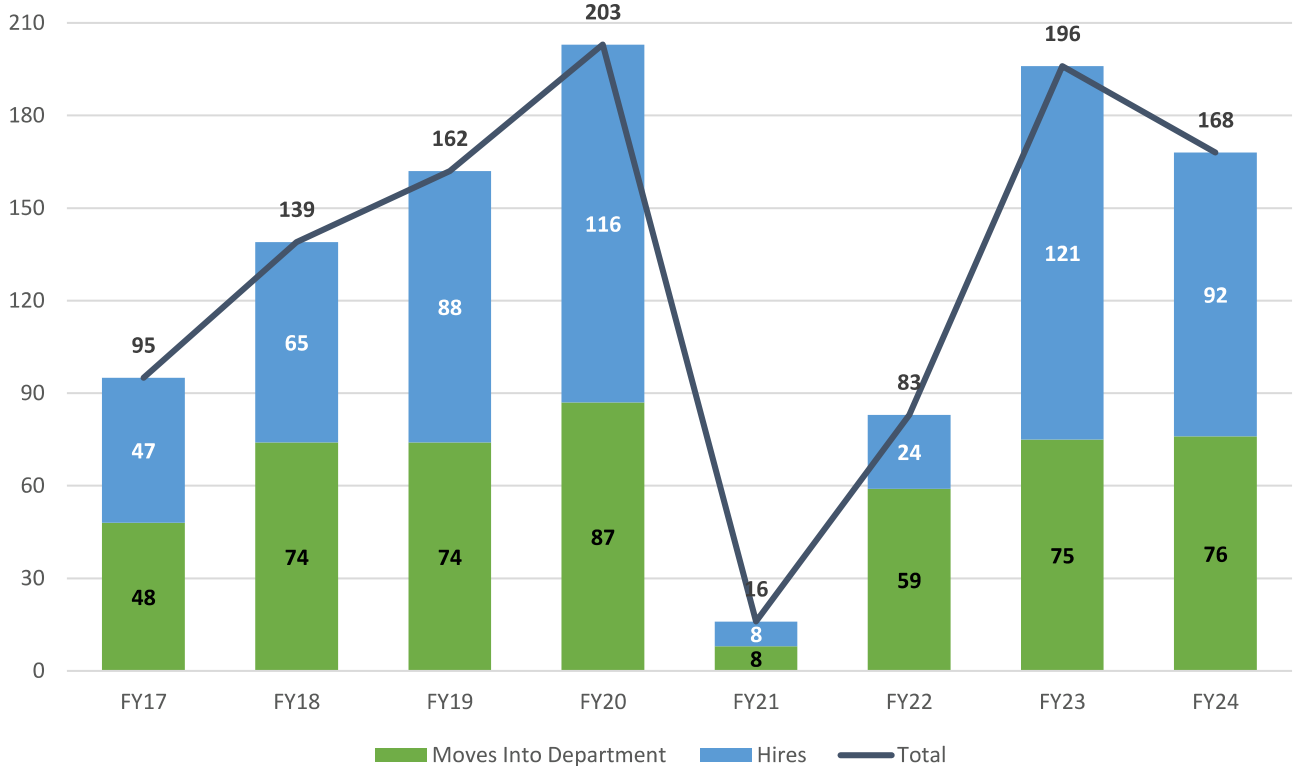


DEPARTMENT OF LAND AND NATURAL RESOURCES (LNR)

Types of Moves Out of Department (Creates a Vacancy)

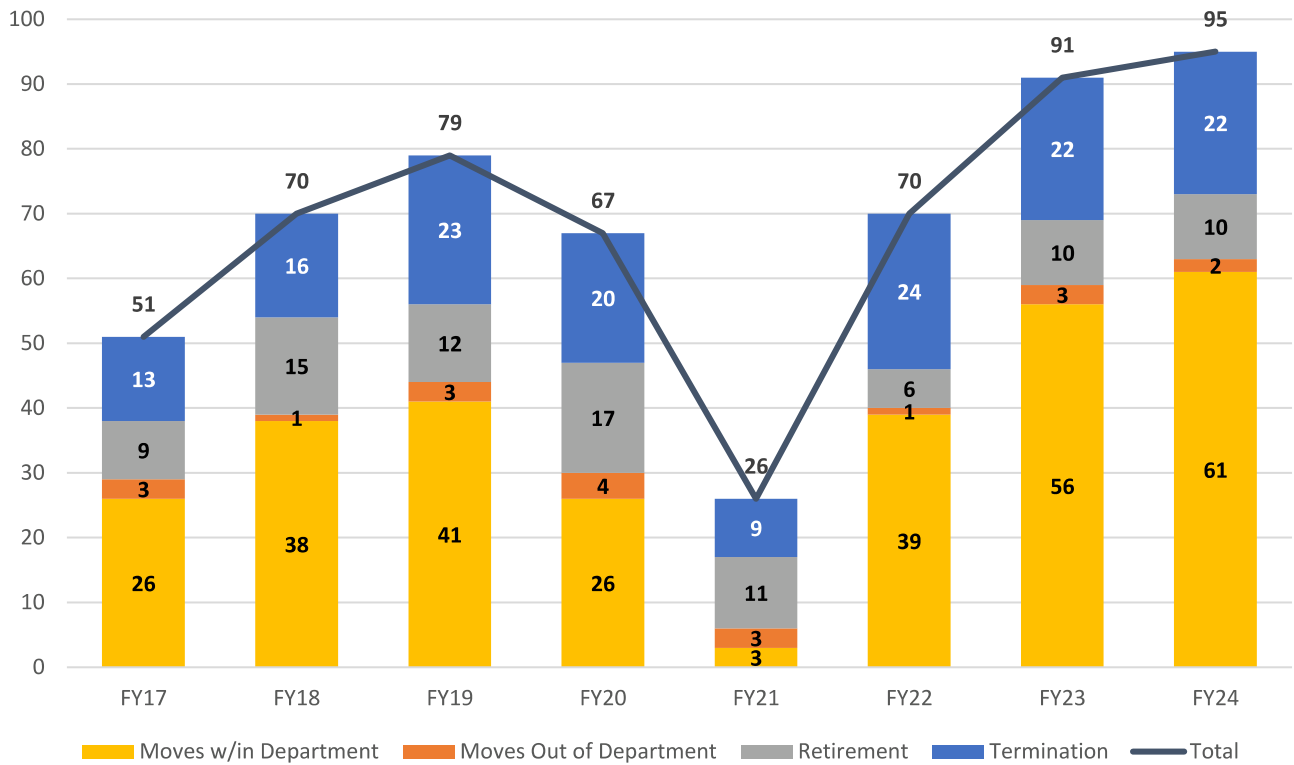


Types of Moves Into Department (Fills a Vacancy)

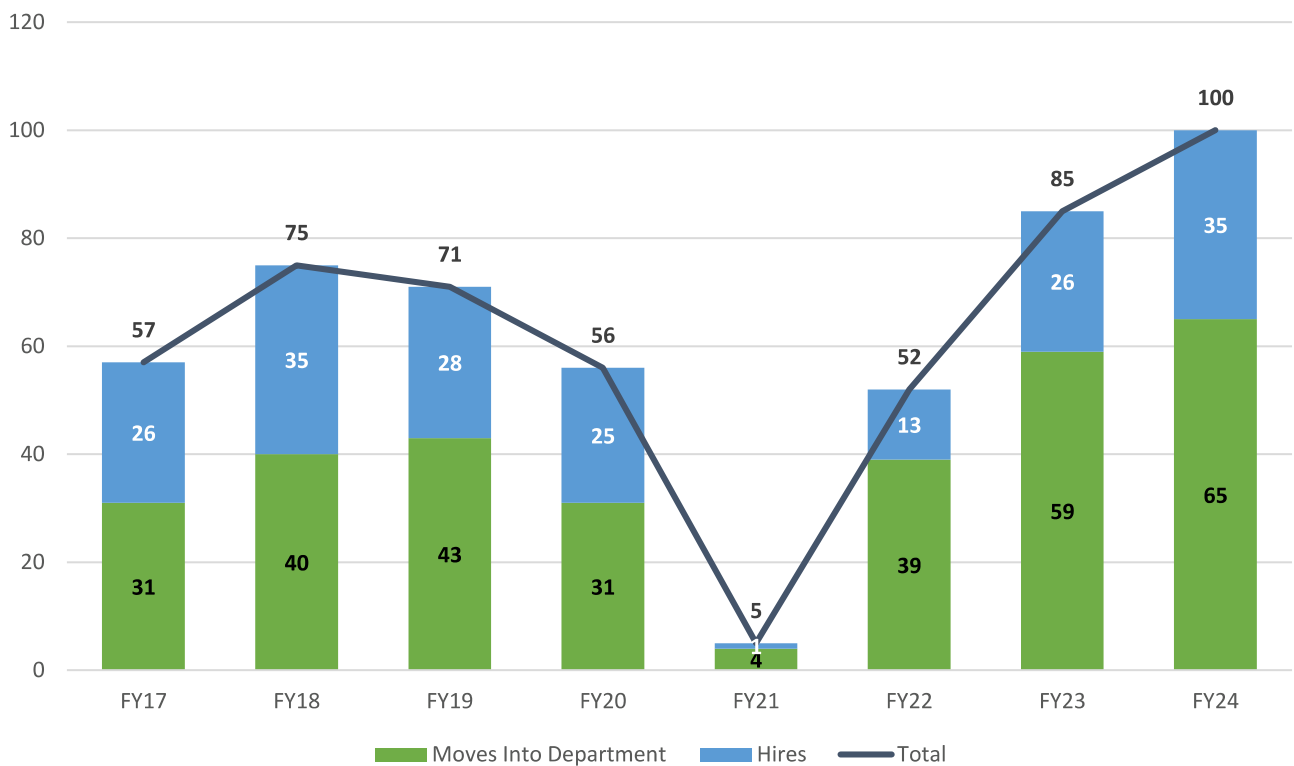


DEPARTMENT OF TAXATION (TAX)

Types of Moves Out of Department (Creates a Vacancy)

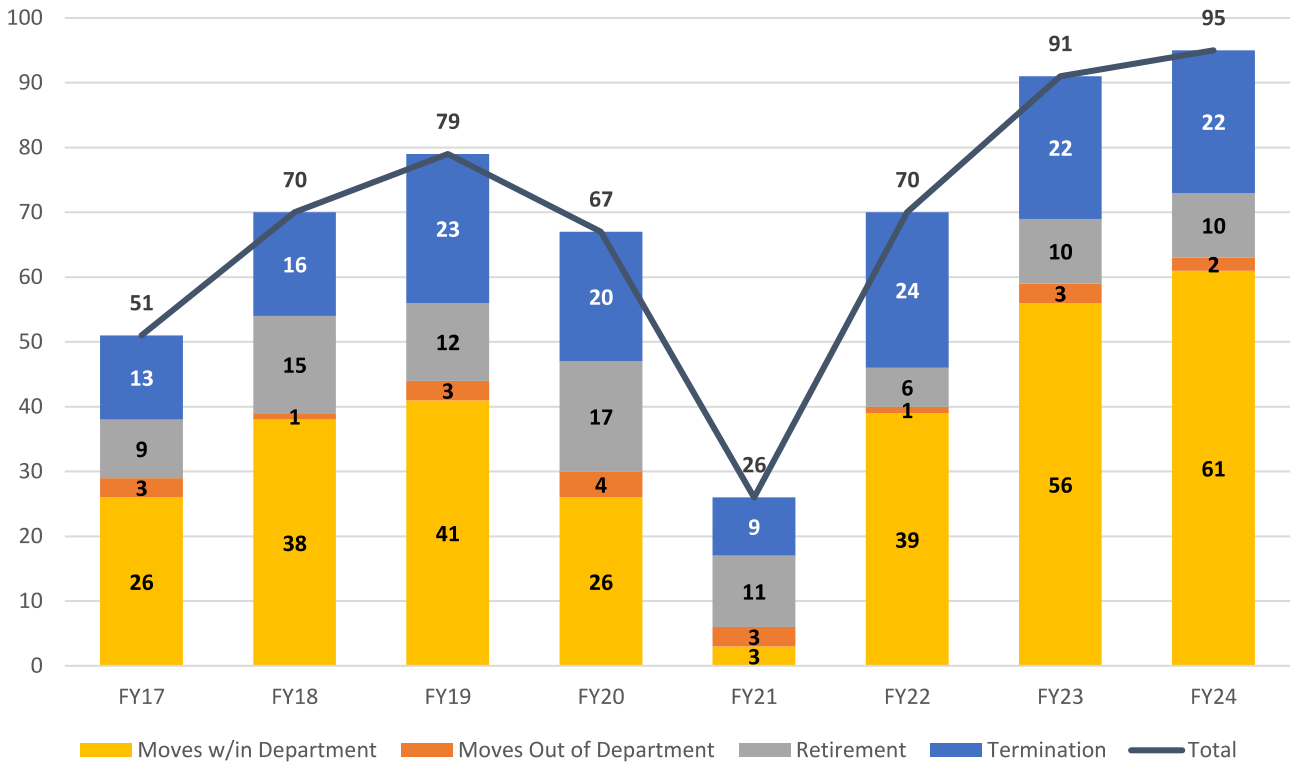


Types of Moves Into Department (Fills a Vacancy)

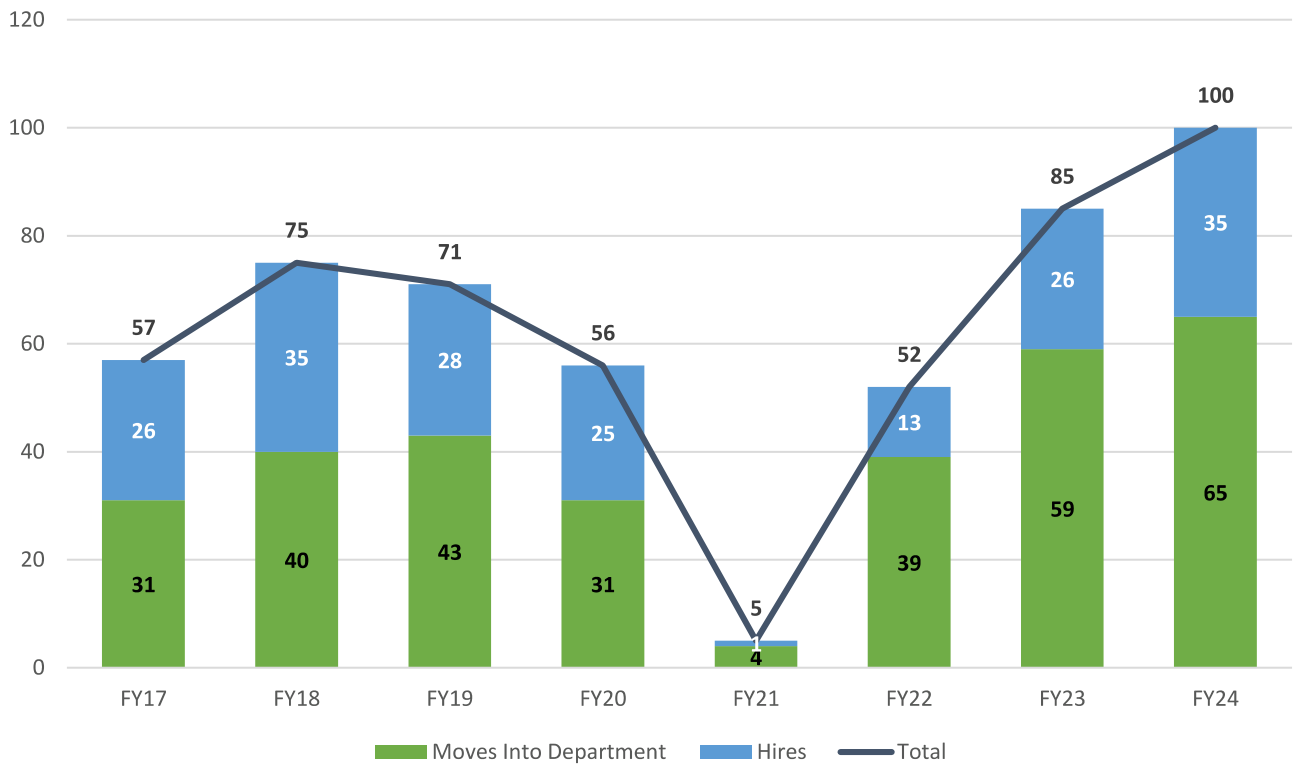


DEPARTMENT OF TRANSPORTATION (TRN)

Types of Moves Out of Department (Creates a Vacancy)

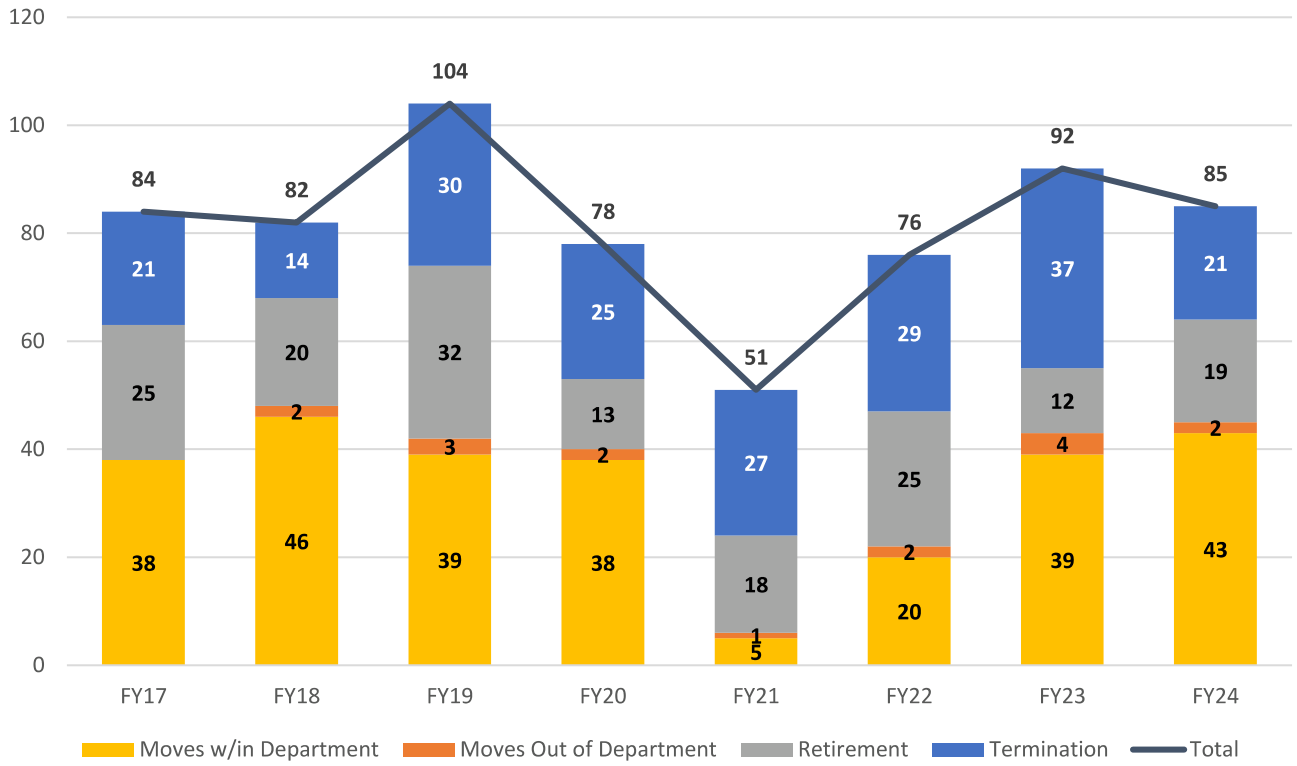


Types of Moves Into Department (Fills a Vacancy)

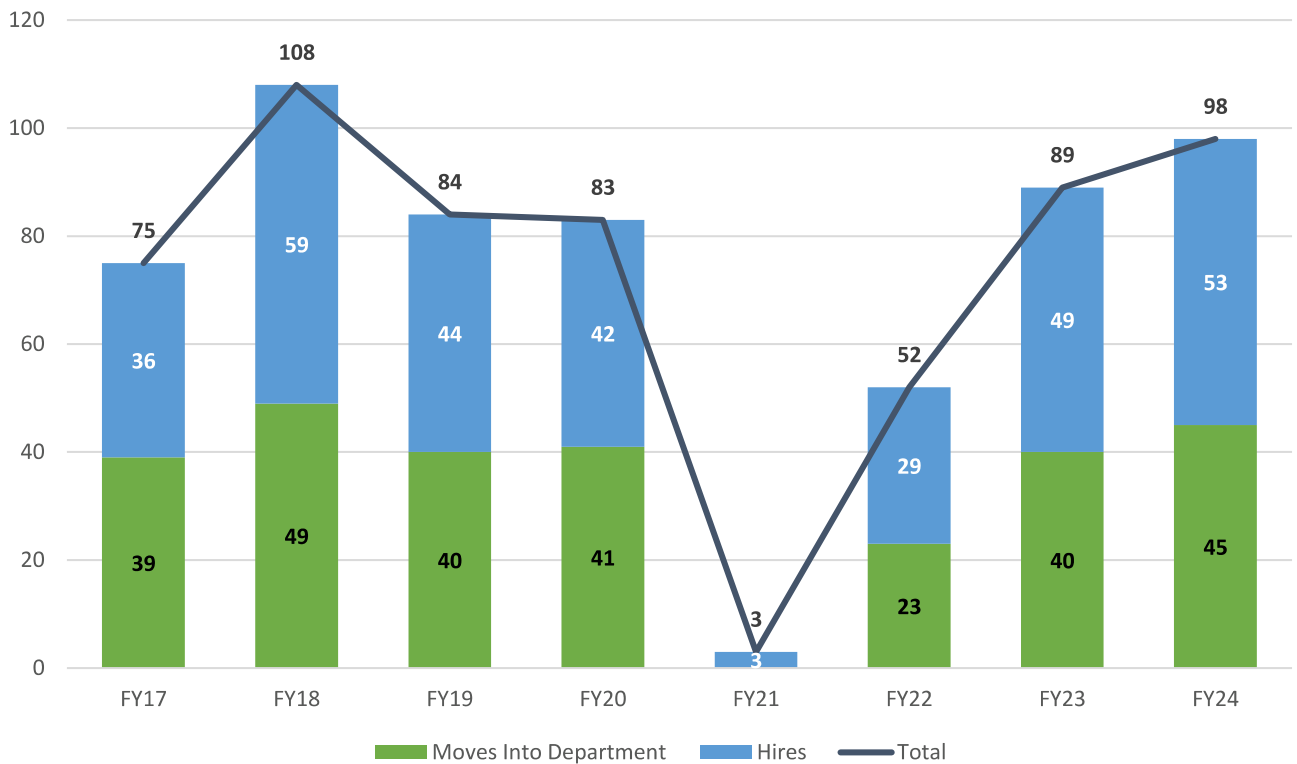


HAWAII STATE PUBLIC LIBRARY SYSTEM (HSPLS)
