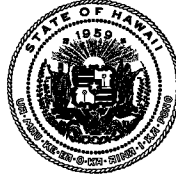

## **INTRODUCTION/BACKGROUND:**

The Legislature of the State of Hawaii, during its Regular Session of 2024, has proposed a resolution to honor the bravery and sacrifice of Hawaii's first responders. The resolution calls for the Department of Accounting and General Services (DAGS) Public Works Division (PWD), to form a working group and coordinate its efforts to plan and construct a Hawaii First Responders Memorial. This memorial aims to provide a lasting tribute to the first responders who have selflessly served the community and paid the ultimate price in the line of duty.

### **1. Objective:**

- **Establish a Memorial:** House Concurrent Resolution (HCR) No. 97 has tasked the Department of Accounting and General Services to establish a working group to plan and construct a memorial to honor Hawaii's first responders who have died in the line of duty.

### **2. Working Group Composition:**

- **Chairperson:** The Comptroller or their designee will lead the working group.
- **Fire Chiefs:** Representatives from the Honolulu, Hawaii, Maui, and Kauai Fire Departments.
- **Ocean Safety Chiefs:** Representatives from the City and County of Honolulu, Hawaii Fire Department representative with experience in ocean safety, Maui County, and Kauai.
- **Emergency Services:** The Director of Honolulu Emergency Services or their designee.
- **Medical Response:** A representative from American Medical Response in Hawaii.
- **Union Representatives:**
  - President or designee from the Hawaii Firefighters Association, Local 1463, IAFF 646, AFL-CIO.
  - State Director of the United Public Workers AFSCME Local 646, AFL-CIO.
  - Executive Director of the Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO.
- **Family Members:** Two family members of fallen first responders to be invited by the Comptroller.

### **3. Memorial Specifications:**

- **Honorees:** First responders, such as firefighters, lifeguards, paramedics, emergency medical technicians, medical flight nurses, and pilots.
- **Attributes:** The memorial will be permanent, perpetual, and constructed using private funds.
- **Purpose:** To highlight bravery and the public service spirit of first responders.

#### 4. Responsibilities:

- **Planning:** Determine the location and development of the design criteria and strategy for funding the planning, design, and construction of the memorial.
- **Coordination:** Oversee construction and maintenance, ensuring ongoing upkeep through private or legislative funds.
- **Reporting:** Submit a comprehensive report by November 30, 2024, detailing plans, costs, and legislative needs.

## **PLANNING AND COORDINATION**

### 1. Working Group Plans and Findings

The working group for the Hawaii First Responders Memorial (HFRM), established under HCR No. 97 held its inaugural meeting on November 4, 2024. A walking tour of various memorials was conducted on November 19, 2024, to gather inspiration and ideas for the design of the Hawaii First Responders Memorial. The second meeting is scheduled for December 4, 2024.

Going forward, the working group plans to meet during the first week of each month. These regular meetings will ensure that progress is made through the collaborative efforts of all members as they work toward the completion of the memorial. Additionally, Public Works will coordinate regular meetings, assist in establishing a framework, and continue to provide support and guidance to help the working group successfully build the memorial.

### 2. Working Group Recommendations and Projected Costs

- The working group reviewed cost estimates for past memorial projects, with projected expenses for the new memorial ranging between \$1.5 million and \$2.25 million, depending on the location, size, and improvements required.
- The importance of establishing a foundation, potentially a 501(c)(3) nonprofit, to manage fundraising and ongoing maintenance efforts was discussed.
- Joe Earing, Planning Branch Manager, suggested seeking funding for planning purposes, including engaging with consultants to evaluate potential sites. He also recommended prioritizing State or County property for the memorial's location.

### **I. Introduction and Purpose of the Meeting**

- Meoh-Leng Silliman introduced herself, representing Keith Regan.
- The meeting was noted as the kickoff meeting for the Hawaii First Responders Memorial Working Group.
- Meoh-Leng emphasized the significance and meaningful endeavor of the memorial and the department's commitment to the initiative.
- Present were representatives from various stakeholders, including fire chiefs, emergency services, and families of fallen first responders.

## **II. Overview of Memorial Honorees and Legislative Support**

- The memorial will honor first responders who died in the line of duty: firefighters, lifeguards, paramedics, and medical flight nurses.
- Legislative support was acknowledged from Representative Linda Ichiyama, Senator Glenn Wakai, and Councilwoman Radiant Cordero.
- Eddie Fujioka was requested to attend by Representative Ichiyama for his involvement in the resolution.
- The purpose of the memorial was reiterated as a recognition of the sacrifices made by first responders.

## **III. Memorial Specifications and Types**

- Joseph Earing discussed types of memorials, including statues, works of art, and large-scale installations and shared an Inventory Map.
- Existing memorial examples were mentioned, such as the King Kamehameha statue and the Hawaii Law Enforcement Memorial.
- The group was prompted to consider preferred types of memorials and locations.
- The visibility and accessibility of the memorial to the public were highlighted as critical factors.

## **IV. Discussion on Memorial Location**

- Eddie Fujioka suggested the Capital District as a potential site, citing its visibility and proximity to public events.
- Financial and logistical feasibility of the Capital District was discussed, especially near the Law Enforcement Memorial, due to existing infrastructure.
- Clarifications on the location of the Law Enforcement Memorial were provided by Joseph Earing.

**V. Cost Considerations** Joseph Earing provided estimates for past memorial costs, discussing projected expenses for the new memorial, ranging from \$1.5 million to \$2.25 million.

- The need to form a foundation (possibly a 501(c)(3)) to manage contributions through fundraising efforts and maintenance was emphasized.
- Joe Earing mentioned seeking funding for Planning purposes (engaging with Consultants) to investigate sites; but he encouraged to try to go on State or County property.



- Eddie Fujioka shared insights from the Hawaii Law Enforcement Memorial regarding the involvement of labor unions and private contributions to mitigate costs.

## **VI. Organizational Structure and Next Steps**

- Gordon Wood emphasized the establishment of organizational positions within the working group, recommending a co-chair and secretary.
- Suggestions for family members to join the working group were discussed, with Tiffany Allen volunteering to reach out to interested families.
- Developing a clear vision for the memorial and potential legislative considerations were underscored.

## **VII. Planning and Logistics for the Memorial**

- Gordon Wood proposed a walking tour of potential sites in the Capital District to evaluate their suitability.
- Councilwoman Cordero reiterated her support for the memorial and the possibility of utilizing city property for the site.
- A request for a map of existing memorials for evaluation was made, and it was agreed that the group would provide this resource and organize the walking tour.

## **VIII. Final Discussions and Action Items**

- Pao-Chi Hwang asked if there is a list of individuals to be dedicated to the memorial, with Rep. Ichiyama offering to share the working list.
- The need for a checklist of action items and a point of contact to consolidate information was discussed.
- Tony Benabese was designated as the point of contact for coordinating efforts leading to the next meeting.
- It was agreed to continue discussions in the next meeting regarding location, cost, and organizational structure.

## **Action Items**

1. Investigate potential sites for the memorial, including state or county properties, and obtain necessary approvals.
2. Seek planning funding to advance the project.

3. Explore in-kind donation and volunteer labor opportunities.
4. Organize the working group structure, including the appointment of a co-chair, secretary, and treasurer.
5. Outreach led by Tiffany Allen to family members of fallen first responders for participation in the working group.
6. Arrange and schedule a walking tour (approx. 2 hrs.) to assess potential sites around The State Capital District.
7. Share the working list of individuals to be honored in the memorial.
8. Provide the Inventory Map from The Monuments and Works of Art in the Capitol District.

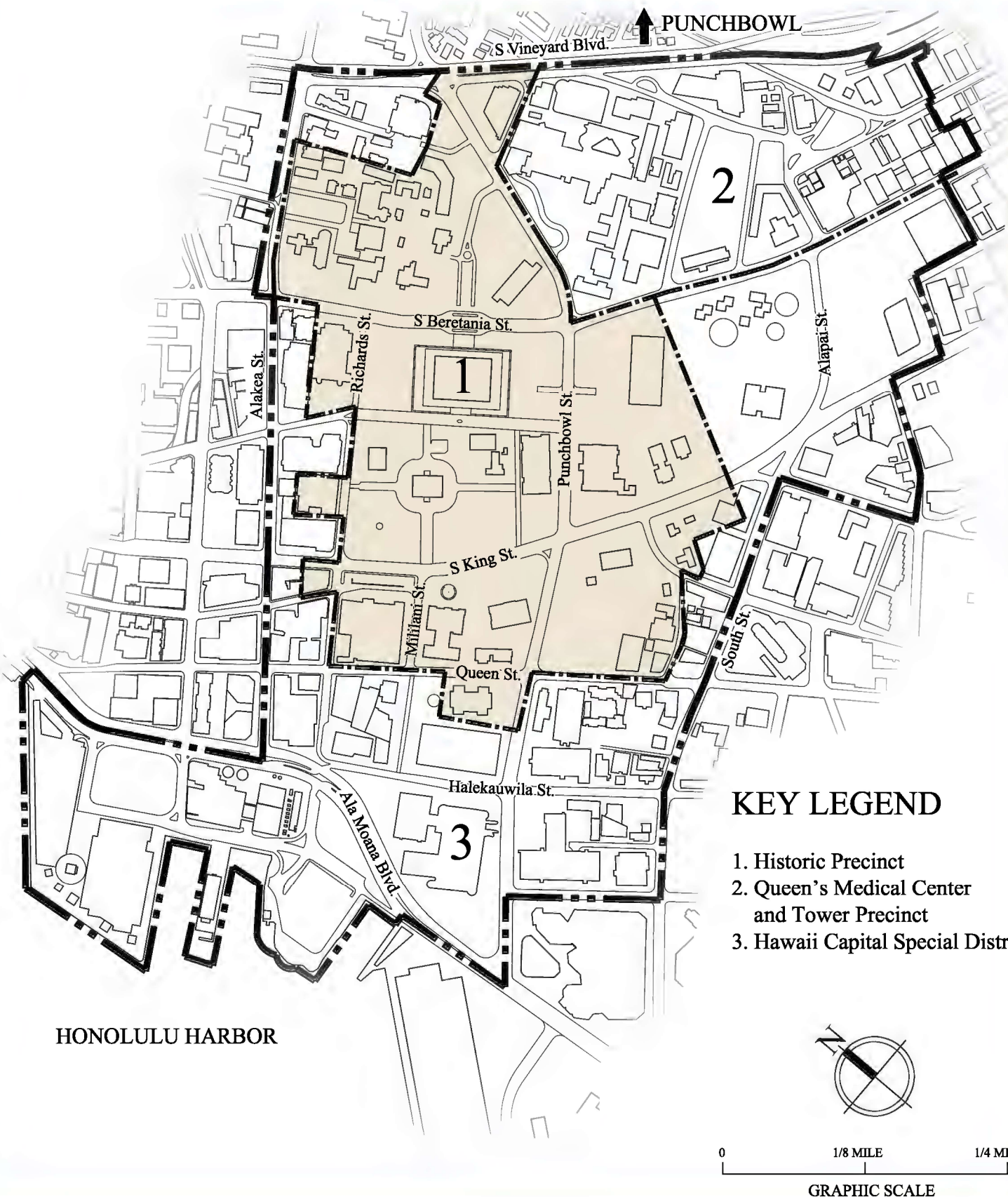

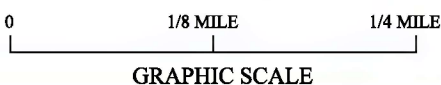
## **HCR 97 Working Group Walking Tour - State Capital District**

- 1. The Hawaii Law Enforcement Memorial:** Tribute to those men and women who selflessly gave their lives in the performance of their duties.
- 2. Nagasaki Bell:** A memorial gift from survivors of the bombing of Nagasaki.
- 3. The Eternal Flame:** A metal sculptured torch that burns endlessly as a tribute to all men and women from Hawaii who served with the Air Force, Army, Coast Guard, Marines, and Navy in the major and minor conflicts in which the United States was engaged.
- 4. Korean-Vietnam War Memorial:** Pays tribute to service members who died in those conflicts. Dedicated on July 24, 1994 by Benjamin J. Cayetano, fifth Governor of Hawaii, the monument consists of 768 black marble pedestals engraved with the names of 312 service members of the Vietnam War.
- 5. Honolulu World War II Memorial:** Located at the corner of Punchbowl Street and S. King Street, this memorial was dedicated in 1944. The base of the memorial has the names of 880 Hawai'i residents who lost their lives in the war.
