A BILL FOR AN ACT

RELATING TO NUISANCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the department of
- 2 health's responsibility to protect both public and environmental
- 3 health is essential, especially as climate change increases
- 4 pressures on resources and communities. The recognition that
- 5 the health of a community is closely tied to environmental
- 6 conditions underscores the importance of preventing threats to
- 7 the environment. Therefore, it is critical that the department
- 8 of health has the clear legal authority and mandate to act not
- 9 only in response to direct threats of disease but also when
- 10 nuisances pose a risk to the public or environmental health of a
- 11 community.
- 12 Accordingly, the purpose of this Act is to clarify the
- 13 legal authority of the department of health to prevent and
- 14 address nuisances that threaten public or environmental health,
- 15 both of which affect the overall health and well-being of the
- 16 people of the State as a whole.

1	SECTION 2. Chapter 322, Hawaii Revised Statutes, is
2	amended by amending the title of part I to read as follows:
3	"PART I. PREVENTION AND ABATEMENT OF NUISANCES"
4	SECTION 3. Section 322-1, Hawaii Revised Statutes, is
5	amended to read as follows:
6	"§322-1 [Removal, prevention.] Prevention; abatement;
7	destruction; removal. The department of health and its agents
8	shall examine into all nuisances, <u>such as</u> foul or noxious odors,
9	gases or vapors, water in which mosquito larvae exist, sources
10	of filth, and all causes of sickness or disease, on shore, and
11	in any vessel, which may be known to them or brought to their
12	attention, [which] that in their opinion are dangerous or
13	injurious to public health or environmental health, or both, and
14	into any and all conditions created or existing [which] that
15	cause or tend [to cause sickness or disease or] to be dangerous
16	or injurious to public health or environmental health, or both,
17	and shall [eause the same to be abated, destroyed, removed, or
18	prevented.
19	For purposes of this part, a nuisance shall include:
20	(1) Toxic materials that are used in or by-products of the
21	manufacture or conversion of methamphetamine, and

1	clandestine drug labs that manufacture
2	methamphetamine; and
3	(2) Odors and filth resulting from a person feeding feral
4	birds.]
5	prevent, abate, destroy, or remove the nuisance or condition
6	that causes a nuisance."
7	SECTION 4. Statutory material to be repealed is bracketed
8	and stricken. New statutory material is underscored.
9	SECTION 5. This Act shall take effect upon its approval.
