# A BILL FOR AN ACT

RELATING TO SHORELINE MANAGEMENT AREAS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 205A-22, Hawaii Revised Statutes, is		
2	amended by amending the definitions of "special management area		
3	minor permit" and "special management area use permit" to read
