A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that school health
- 2 assistants may administer medications to students who require
- 3 certain medications in public schools. However, due to
- 4 increasing vacancies for school health assistants, many schools
- 5 experience challenges in meeting the needs of students who are
- 6 prescribed medications or may benefit from receiving medications
- 7 in emergency situations while on campus. This lapse of
- 8 continued care may risk the health and safety of students who
- 9 rely on the timely administration of certain medications.
- 10 To ensure the health and safety of students, other school
- 11 staff who volunteer to administer medication can be effective
- 12 substitutes once these individuals complete training and general
- 13 instruction on medication administration. Therefore, requiring
- 14 volunteers to complete training that includes correctly
- 15 interpreting the health care provider's orders; identifying the
- 16 correct student; identifying the correct route of
- 17 administration, either oral, nasal, or topical; confirming the

1	correct dose; administering medications at the right time of		
2	day; and documenting medication administration, can ensure		
3	accountability and the necessary safeguards for student health.		
4	Accordingly, the purpose of this Act is to authorize public		
5	school employees or agents who have completed appropriate		
6	training to administer medication for students consistent with		
7	standards applicable to school health assistants.		
8	SECTION 2. Section 302A-853, Hawaii Revised Statutes, is		
9	amended by amending subsection (a) to read as follows:		
10	"(a) School health assistants, and public school employees		
11	and agents trained by a health care professional employed or		
12	contracted by the department, may assist students by		
13	administering oral, nasal, and topical medication, and in		
14	emergency situations, other premeasured medication; provided		
15	that:		
16	(1) If the student receiving the medication is a minor, a		
17	parent or guardian requests and authorizes the		
18	administration of medication;		
19	(2) The medication has been prescribed by a [licensed]		
20	physician[, as defined in section 334-1, or by a		
21	practitioner] or physician assistant licensed pursuant

1		to chapter 453, an advanced practice registered nurse
2		with prescriptive authority[+] licensed pursuant to
3		chapter 457, or by another licensed health care
4		practitioner with prescriptive authority;
5	(3)	The administration of the medication is with the
6		approval of a health care professional within the
7		department, department of health, or health care
8		service as defined in section 323D-2 pursuant to a
9		written agreement with the department; and
10	(4)	The administration of the medication is necessary for
11		the health of the student and for the student's
12		attendance at school."
13	SECT	ION 3. Statutory material to be repealed is bracketed
14	and stric	ken. New statutory material is underscored.
15	SECT:	ION 4. This Act shall take effect upon its approval.
