A BILL FOR AN ACT

RELATING TO TRANSPORTATION SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the availability of
- 2 school bus services is essential to student attendance. School
- 3 bus services are particularly crucial for families who live in
- 4 rural and remote areas, as well as students who come from
- 5 socioeconomically disadvantaged communities. Currently, there
- 6 is a nationwide shortage of school bus drivers. This shortage
- 7 is impacting the State, forcing the suspension or partial
- 8 suspension of school bus services to central Oahu and east
- 9 Hawaii island. In the 2024-2025 school year, a total of one
- 10 hundred thirty-eight routes were temporarily suspended,
- 11 affecting nearly three thousand seven hundred twenty students
- 12 who signed up for bus transportation.
- 13 The legislature further finds that, to address the shortage
- 14 of school bus drivers in Hawaii, the governor issued an
- 15 emergency proclamation in August 2024 to allow the department of
- 16 transportation to grant exemptions for the use of vehicles other
- 17 than school buses to transport students. Specifically, this and

- 1 subsequent related emergency proclamations allow for the
- 2 transport of students using vehicles other than school vehicles
- 3 by drivers possessing a commercial driver's license with an
- 4 endorsement authorizing the driving of vehicles carrying
- 5 passengers. The legislature believes that making this exemption
- 6 permanent may help alleviate the lack of school bus drivers.
- 7 The purpose of this Act is to ensure that certain
- 8 provisions of the governor's August 2024 emergency proclamation
- 9 on school bus services is placed into statute by authorizing the
- 10 use of motorcoaches, small buses, and vans for school bus
- 11 services; provided certain conditions are met.
- 12 SECTION 2. Section 286-102, Hawaii Revised Statutes, is
- 13 amended by amending subsection (b) to read as follows:
- 14 "(b) A person operating the following category or
- 15 combination of categories of motor vehicles shall be examined as
- 16 provided in section 286-108 and duly licensed by the examiner of
- 17 drivers:
- 18 (1) Mopeds;
- 19 (2) Motorcycles, except for autocycles as described in
- 20 paragraph (2) of the definition of "motorcycle" in
- section 286-2, and motor scooters;

1	(3)	Passenger cars of any gross vehicle weight rating,
2		buses designed to transport fifteen or fewer
3		occupants, trucks and vans having a gross vehicle
4		weight rating of eighteen thousand pounds or less, and
5		autocycles as described in paragraph (2) of the
6		definition of "motorcycle" in section 286-2; and
7	(4)	All of the motor vehicles in category (3) and any
8		vehicle that is not a commercial motor vehicle.
9	A sc	hool bus, small bus, motorcoach, or van operator shall
10	be properly licensed to operate the category of vehicles that	
11	the operator operates as a school bus, small bus, motorcoach, or	
12	van and s	hall comply with the standards of the department of
13	transportation as provided by rules adopted pursuant to section	
14	286-181."	
15	SECT	ION 3. Section 286-181, Hawaii Revised Statutes, is
16	amended as	s follows:

18	"(b)	The department of transportation shall grant
19	exemptions	s for the use of vehicles other than school vehicles,

3	(2)	Impractical due to economic factors.
4	No exempt	ion shall be granted for the qualifications of
5	individua	ls driving a bus as defined in section 286-2 and [such]

7	(c)	The exemptions in subsection (b) shall be granted:
8	(1)	To the department of education to administer to
9		[public] department schools based on criteria
10		developed by the departments of transportation and
11		education; provided that the department of education
12		shall submit a report to the department of
13		transportation at the end of each school year on the
14		extent to which these exemptions were [utilized;]
15		used;
16	(2)	To the state public charter school commission to
17		administer public charter schools based on criteria
18		developed by the departments of transportation and
19		education; provided that the state public charter
20		school commission shall submit a report to the
21		department of transportation at the end of each school

1		year on the extent to which these exemptions were
2		used;
3	[(2)]	(3) To a board of independent schools, which is
4		registered with the department of commerce and
5		consumer affairs, to administer to private schools
6		utilizing criteria developed by the departments of
7		transportation and education; provided that the board
8		shall submit a report to the department of
9		transportation at the end of each school year on the
10		extent to which these exemptions were utilized;
11	[-(3)	Only for [4] For the transport of pupils to and from
12		school functions or school-related activities [but
13		not], for transportation to and from a school[;], and
14		for transportation to and from designated drop off
15		locations and pick up locations established by the
16		department of education, in consultation with the
17		department of transportation;
18	[(4)]	(5) Only when each pupil being transported has
19		obtained a written statement from the pupil's parent
20		or legal guardian waiving the State's liability; and

1	(197) (6) In accordance with the procedures and criteria
2	established by rules of the department of
3	transportation.
4	(d) [The] Notwithstanding any law to the contrary, the
5	department of transportation may grant exemptions for the use of
6	vehicles other than school vehicles [for the transportation of
7	students requiring special education and services], including
8	the use of motorcoaches, small buses, and vans that may not meet
9	school bus regulations but shall otherwise meet vehicle
10	requirements and qualifications set forth in chapter 19-143,
11	Hawaii Administrative Rules, for school bus services, when an
12	adult staff chaperone escorts students being transported between
13	designated locations off-campus and designated locations on-
14	campus, when the department of transportation finds that
15	compliance with this section is impossible or impractical;
16	provided that an adult staff chaperone provided by the
17	department of education escorts students being transported
18	between designated off-campus and designated on-campus
19	<u>locations;</u> provided <u>further</u> that no exemption shall be granted
20	for the qualifications of individuals driving a bus as defined

- 4 rules and standards relating to school vehicles, equipment, and

- 10 (3) School vehicle operation;
- 11 (4) School vehicle maintenance and maintenance records;
