A BILL FOR AN ACT

RELATING TO CONDOMINIUMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 514B, Hawaii Revised Statutes, is
- 2 amended by adding a new section to subpart C of part VI to be
- 3 appropriately designated and to read as follows:
- 4 "S514B- Governing documents; electronic copies. (a)
- 5 Notwithstanding any other provision to the contrary in the
- 6 declaration, bylaws, or house rules, an association shall
- 7 provide an electronic copy of its governing documents, as
- 8 amended or restated, to a unit owner or the unit owner's
- 9 authorized agent, upon request, at no cost to the unit owner or
- 10 the unit owner's authorized agent.
- 11 (b) For the purposes of this section, "governing
- 12 documents" means the declaration; bylaws; covenants, conditions,
- 13 and restrictions; and house rules."
- 14 SECTION 2. Section 514B-154.5, Hawaii Revised Statutes, is
- 15 amended as follows:
- 16 1. By amending subsection (b) to read:

- 1 "(b) Subject to section 514B-105(d), and except as
- 2 provided under section 514B- , copies of the items in
- 3 subsection (a) shall be provided to any unit owner or owner's
- 4 authorized agent upon the owner's or owner's authorized agent's
- 5 request; provided that the owner or owner's authorized agent
- 6 pays a reasonable fee for duplication, postage, and stationery[7]
- 7 and other administrative costs associated with handling the
- 8 request]."
- 9 2. By amending subsection (d) to read:
- "(d) [Any] Except as provided under section 514- , any
- 11 documents, records, and information, whether maintained, kept,
- 12 or required to be provided pursuant to this section or section
- 13 514B-152, 514B-153, or 514B-154, may be made available
- 14 electronically to the unit owner or owner's authorized agent if
- 15 the owner or owner's authorized agent requests such in writing."
- 16 SECTION 3. Statutory material to be repealed is bracketed
- 17 and stricken. New statutory material is underscored.
- 18 SECTION 4. This Act shall take effect upon its approval.
