A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to authorize county
- 2 police officers to enforce the statewide traffic code on all
- 3 public streets, roadways, and highways within the State.
- 4 SECTION 2. Chapter 291C, Hawaii Revised Statutes, is
- 5 amended by adding a new section to part I to be appropriately
- 6 designated and to read as follows:
- 7 "S291C- County police officer authority. Each county
- 8 police officer may enforce this chapter for any violation of
- 9 this chapter that occurs on any federal, state, or county
- 10 street, roadway, or highway."
- 11 SECTION 3. New statutory material is underscored.
- 12 SECTION 4. This Act shall take effect upon its approval.
