# A BILL FOR AN ACT

---

RELATING TO TRANSPORTATION.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1       SECTION 1. The purpose of this Act is to authorize county  
2 police officers to enforce the statewide traffic code on all  
3 public streets, roadways, and highways within the State.

4       SECTION 2. Chapter 291C, Hawaii Revised Statutes, is  
5 amended by adding a new section to part I to be appropriately  
6 designated and to read as follows:

7       "\$291C- County police officer authority. Each county  
8 police officer may enforce this chapter for any violation of  
9 this chapter that occurs on any federal, state, or county  
10 street, roadway, or highway."


11       SECTION 3. New statutory material is underscored.


