#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 The legislature finds that the Ala Wai canal SECTION 1. 2 was built in the 1920s and is the largest artificial waterway in 3 the State. Floating debris in the canal has been a persistent 4 problem, which severely harms recreational users and the State's 5 aquatic habitats in nearshore waters. In October 2024, heavy 6 rain in the watershed area caused serious concerns for 7 downstream tenants, including those at the Ala Wai small boat 8 The legislature recognizes that the division of boating harbor. 9 and ocean recreation of the department of land and natural 10 resources has spent hundreds of thousands of dollars to collect and dispose of the floating debris at the Ala Wai small boat 11 12 harbor. However, more funding and assistance is needed to 13 better manage floating debris in the Ala Wai canal.

14 Accordingly, the purpose of this Act is to appropriate15 funds to the university of Hawaii to:


