This is to inform you that on June 6, 2025, the following bill was signed into law:

A BILL FOR AN ACT

RELATING TO A RATE STUDY FOR HOME HEALTH SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that home health services
- 2 are a crucial part of the health care system. Home health
- 3 services include higher-level skilled care such as physical
- 4 therapy, occupational therapy, speech therapy, wound care, and
- 5 health management of complex chronic conditions. These services
- 6 are typically provided by nurses and therapists to homebound
- 7 individuals recovering from surgery or acute illnesses who need
- 8 ongoing medical support but do not need to be hospitalized or
- 9 institutionalized.
- 10 The legislature additionally finds that reimbursement for
- 11 home health services is declining, which is affecting patient
- 12 access to care. The Partnership for Quality Home Healthcare
- 13 projects that medicare will cut federal funding for home health
- 14 services by \$25,000,000,000 between 2020 and 2029.
- 15 Additionally, a survey conducted by the Healthcare Association
- 16 of Hawaii found that Hawaii's medicare-certified home health
- 17 agencies lost an average of \$1,186 per medicaid patient served.

- 1 As a result of decreases in reimbursement from these two major
- 2 payment sources, the proportion of medicaid patients treated by
- 3 these surveyed home health agencies decreased from twenty-five
- 4 per cent to sixteen per cent between 2020 and 2024.
- 5 The legislature also finds that these losses are similarly
- 6 attributable to increasing costs, particularly the cost of
- 7 labor, and are making it difficult for home health agencies to
- 8 adequately recruit and retain their workforce. The Healthcare
- 9 Association of Hawaii's 2022 workforce report found that the
- 10 vacancy rate for health care positions in the home health
- 11 services setting was thirty-nine per cent, the highest
- 12 percentage of vacancies across professions. The high vacancy
- 13 rate reflects reimbursement that is insufficient to make home
- 14 health a competitive setting for nurses, therapy providers, and
- 15 aides.
- 16 The legislature further finds that it has considered
- 17 increasing medicare reimbursement rates for other home and
- 18 community-based services providers, such as home care agencies,
- 19 which provide services primarily focused on assistance with the
- 20 activities of daily living, such as bathing, dressing, and meal
- 21 preparation. However, home health agencies were not included as

- 1 part of the rate studies conducted by the United States
- 2 Department of Health and Human Services and therefore have not
- 3 had their rates reviewed or updated as part of those legislative
- 4 efforts.
- 5 Accordingly, the purpose of this Act is to provide funding
- 6 for the department of human services to conduct a rate study for
- 7 medicaid home health services in Hawaii, which will serve as a
- 8 foundation for future informed decision-making and support the
- 9 continued delivery of high-quality, accessible home health
- 10 services to medicaid recipients in the State.
- 11 SECTION 2. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$250,000 or so much
- 13 thereof as may be necessary for fiscal year 2025-2026 to conduct
- 14 a rate study on medicaid home health services in the State.
- 15 The sum appropriated shall be expended by the department of
- 16 human services for the purposes of this Act.
- 17 SECTION 3. This Act shall take effect on July 1, 2025.
