
A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT COST ITEMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 PART I

2 SECTION 1. There are appropriated or authorized from the
3 sources of funding indicated below to collective bargaining
4 statewide (BUF 102) the following sums or so much thereof as may
5 be necessary to fund for fiscal biennium 2025-2027 all
6 collective bargaining cost items in the agreement negotiated
7 with the exclusive representative of collective bargaining unit
8 (8):

14 SECTION 2. Funds appropriated or authorized by this part
15 shall be allotted by the director of finance to the appropriate



1 state departments for expenditure in the respective fiscal year
2 for the purposes of this part.

4 SECTION 3. There are appropriated or authorized from the
5 sources of funding indicated below to collective bargaining
6 statewide (BUF 102) the following sums or so much thereof as may
7 be necessary to fund for fiscal biennium 2025-2027 the salary
8 increases and other cost adjustments authorized by chapter 89C,
9 Hawaii Revised Statutes, for state officers and employees who
10 are excluded from collective bargaining and belong to the same
11 compensation plans as those officers and employees within
12 bargaining unit (8):

18 SECTION 4. Funds appropriated or authorized by this part
19 shall be allotted by the director of finance to the appropriate
20 state departments for expenditure in the respective fiscal year
21 for the purposes of this part.

2 SECTION 5. Salary increases and cost adjustments provided
3 in this Act for any officer or employee whose compensation is
4 paid, in whole or in part, from federal, special, or other funds
5 shall be paid wholly or proportionately, as the case may be,
6 from the respective funds.

7 SECTION 6. Funds appropriated or authorized by this Act
8 that are not expended or encumbered by June 30, 2026, and
9 June 30, 2027, of the respective fiscal years, shall lapse as of
10 those dates.

11 SECTION 7. In accordance with section 9 of article VII of
12 the Constitution of the State of Hawaii and sections 37-91 and
13 37-93, Hawaii Revised Statutes, the legislature has determined
14 that the state general fund expenditure ceiling for fiscal year
15 2025-2026 has already been exceeded by \$, or per
16 cent. In addition, the appropriations contained in this Act
17 will cause the state general fund expenditure ceiling for fiscal
18 year 2025-2026 to be further exceeded by \$, or one per
19 cent. The reasons for exceeding the general fund expenditure
20 ceiling are that the appropriations made in this Act are



1 necessary to serve the public interest and to meet the needs
2 addressed by this Act.

3 SECTION 8. This Act shall take effect on July 1, 2050.
