BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. Section 3 of Act 164, Session Laws of Hawaii
- 5 2023, as amended by Act 230, Session Laws of Hawaii 2024,
- 6 appropriated general funds to the department of accounting and
- 7 general services in fiscal year 2024-2025 for interdepartmental
- 8 transfer to the department of law enforcement for payroll costs
- 9 of sheriffs. Similarly, section 3 of Act 70, Session Laws of
- 10 Hawaii 2023, as amended by Act 233, Session Laws of Hawaii 2024,
- 11 appropriated general funds in fiscal year 2024-2025 to the
- 12 judiciary for interdepartmental transfer to the department of
- 13 law enforcement for payroll costs of sheriffs.
- 14 While appropriations for payroll costs out of the general
- 15 fund of the State of Hawaii exclude fringe benefit costs, fringe
- 16 benefits must be included if an appropriation for
- 17 interdepartmental transfer is used to fund positions. Because

1 these aforementioned appropriation amounts did not include 2 fringe benefits, a critical funding shortage exists, and 3 additional funds must be appropriated to cover fringe benefit costs for affected law enforcement personnel of the department 4 5 of law enforcement. 6 The purpose of this Act is to make emergency appropriations 7 to the department of accounting and general services and the 8 judiciary to provide funds to cover payroll and fringe benefits 9 of affected law enforcement personnel. **10** SECTION 3. There is appropriated out of the general 11 revenues of the State of Hawaii the sum of \$ or so **12** much thereof as may be necessary in fiscal year 2024-2025 for an 13 interdepartmental transfer from the department of accounting and 14 general services to the department of law enforcement for 15 personnel costs, including payroll and fringe benefits. 16 The sum appropriated shall be expended by the department of **17** accounting and general services. 18 SECTION 4. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ or so 19 20 much thereof as may be necessary in fiscal year 2024-2025 for an interdepartmental transfer from the judiciary to the department 21

3	The sum appropriated shall be expended by the judiciary.
4	SECTION 5. In accordance with section 9 of article VII of
5	the Constitution of the State of Hawaii and sections 37-91 and
6	37-93, Hawaii Revised Statutes, the legislature has determined
7	that the appropriations contained in this Act will cause the
8	state general fund expenditure ceiling for fiscal year 2024-2025
9	to be exceeded by \$, or per cent. The reasons for
10	exceeding the general fund expenditure ceiling are that the
11	appropriations made in this Act are necessary to serve the
12	public interest and to meet the needs addressed by this Act.
13	SECTION 6. This Act shall take effect upon its approval.

To make two emergency appropriations totaling \$_____ in general funds for fiscal year 2024-2025 to cover payroll and fringe benefits costs for law enforcement

personnel of the Department of Law Enforcement: (1) \$_____ for the Department of Accounting and General Services and (2) \$____ for the

Judiciary.

MEANS:

Emergency appropriations of general funds for fiscal year 2024-2025.

JUSTIFICATION:

Section 3 of Act 164, Session Laws of Hawaii 2023, as amended by Act 230, Session Laws of Hawaii 2024, appropriated general funds to the Department of Accounting and General Services in fiscal year 2024-2025 for interdepartmental transfer to the Department of Law Enforcement for payroll costs of sheriffs. Similarly, section 3 of Act 70, Session Laws of Hawaii 2023, as amended by Act 233, Session Laws of Hawaii 2024, appropriated general funds in fiscal year 2024-2025 to the Judiciary for interdepartmental transfer to the Department of Law Enforcement for payroll costs of sheriffs.

While appropriations out of the general fund of the State of Hawaii exclude fringe benefit costs, fringe benefits must be included if an appropriation from a nongeneral fund is used to fund positions. Because these aforementioned appropriations did not include fringe benefits, a critical funding shortage exists, and additional funds must be appropriated to cover fringe benefit costs.
