A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION TO THE PUBLIC UTILITIES COMMISSION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. This Act is recommended by the governor for
- 2 immediate passage in accordance with section 9 of article VII of
- 3 the Constitution of the State of Hawaii.
- 4 SECTION 2. The legislature finds that the devastating Maui
- 5 wildfires on August 8, 2023, was one of the worst natural
- 6 disasters in the State's history.
- 7 The legislature further finds that in response to the
- 8 growing threat of wildfires and other natural hazards, the
- 9 public utilities commission plays a critical role in the State's
- 10 efforts to strengthen critical infrastructure, mitigate risks,
- 11 protect utility customers, and ensure robust recovery following
- 12 extreme weather events.
- 13 To effectively address these challenges, it is urgently
- 14 imperative for the public utilities commission to strengthen the
- 15 resilience and reliability of electric utility services in the
- 16 State. These initiatives will require consultants with
- 17 specialized expertise to provide technical assessments,

1	evaluations, and recommendations for mitigating storm-related
2	power outages, restoring the grid, rebuilding Maui
3	infrastructure, and preparing for direct impacts of other
4	natural disasters to the State.
5	Accordingly, the purpose of this Act is to make an
6	emergency appropriation of \$700,000 out of the public utilities
7	commission special fund for the public utilities commission to
8	procure the services of specialized consultants.
9	SECTION 3. There is appropriated out of the public
10	utilities commission special fund established by section 269-33,
11	Hawaii Revised Statutes, the sum of \$700,000 or so much thereof
12	as may be necessary for fiscal year 2024-2025 to contract
13	consultant services for utility dockets.
14	The sum appropriated shall be expended by the public
15	utilities commission for the purposes of this Act.
16	SECTION 4. This Act shall take effect upon its approval.

TITLE:

A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION TO THE PUBLIC UTILITIES

COMMISSION.

PURPOSE:

To make an emergency appropriation for the Public Utilities Commission (Commission) to procure services by consultants with technical expertise in the efforts to strengthen the resilience and reliability of electric utility services in the State.

MEANS:

An emergency appropriation out of the Public Utilities Special Fund.

JUSTIFICATION:

Since the August 2023 Maui Wildfires, the Commission has taken many initiatives in response to the growing threat of wildfires and other natural hazards to the State. The Commission is currently engaged in efforts to strengthen critical infrastructure, mitigate risks, protect utility customers, and ensure resilient recovery after extreme weather events.

The Commission will require technical advice on many aspects, including but not limited to, natural hazard (including wildfire) mitigation plans, resilience and reliability of electric utility services, and utility organization.

Impact on the public: The technical advice from expert consultants will support the Commission's ongoing efforts to increase safety, improve reliability and resiliency, and strengthen the electric grid.

Impact on the department and other agencies:
The Commission will be able to use
consultants with technical expertise to
provide recommendations on current standards
and best practices.
